Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Townsend Corporation Salaried Employees Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of The Townsend Corporation Salaried Employees Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

General

The Plan is a qualified salary reduction 401(k) plan sponsored by The Townsend Corporation (the "Company" or the "Employer") for the benefit of its employees. The Plan was established effective January 1, 1995. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Employees who have reached age 18 are eligible to enroll in the Plan.

Contributions

The Plan permits eligible employees to contribute, through a salary reduction election, an amount representing a specific percentage of their salaries up to 80 percent. This salary reduction election is eligible for a discretionary matching Company contribution which is 25 percent of the first 6 percent of the participant's compensation. Rollover contributions from other qualified plans are permitted.

Participant Accounts

Contributions are invested in one or more of a variety of investment funds maintained by First Merchants Private Wealth Advisors, the trustee. Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution, (b) allocation of plan earnings, and (c) allocation of administrative expenses. Participants are allowed to change investment options on a daily basis.

Vesting

Participants are 100 percent vested in salary deferral contributions, as well as income allocations relating to such deferrals. The Employer matching contributions have the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates of 5 to 8.50 percent, which are commensurate with local prevailing rates as determined by the plan administrator. A participant may have one loan outstanding at a time.

Payment of Benefits

Upon termination of participation, the participant is entitled to the value of his or her vested account as soon as administratively feasible following the date on which the distribution is requested. Benefit payments are made in the form of a cash lump-sum distribution. Withdrawals may also be made under the Plan's provisions which designate extraordinary situations (i.e., hardship withdrawals).

Administrative Expenses

The Company pays significant trustee and administrative expenses of the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$382 and \$726, respectively. These accounts are used to reduce future Company contributions or pay administrative expenses. During 2024, \$10,065 was used to reduce Employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. That basis differs from accounting principles generally accepted in the United States of America in that contributions and investment income are recorded when received by the Plan and expenses are recorded when paid. The modified cash basis differs from the cash basis in that investments are recorded at fair value and notes receivable from participants are recorded as receivables (reductions) when the amounts have been advanced to (repaid from) the participant.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

The Plan's investments in mutual funds and money market funds are valued at quoted market prices in an active market. Purchases and sales are recorded on a trade-date basis.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future financial statements.

Tax Status

The Plan is based on a preapproved plan document sponsored by FIS Business Systems, LLC, which has received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the Plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

The Plan is subject to routine audits by taxing jurisdictions. However, as of the date the financial statements were available to be issued, there were no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is September 12, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by First Merchants Private Wealth Advisors, the trustee of the Plan, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$11,969,821 and \$13,549,117 as of December 31, 2024 and 2023, respectively.
- b. Net investment gain as shown in the accompanying statement of changes in net assets available for benefits of \$1,675,198 for the year ended December 31, 2024.
- c. Notes receivable from participants as shown in the accompanying statements of net assets available for benefits of \$194,549 and \$205,041 as of December 31, 2024 and 2023, respectively.
- d. Interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits of \$12,439 for the year ended December 31, 2024.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold as well as held during the year) appreciated in value by \$1,675,198.

4. FUND TRANSFERS

As participants transfer between The Townsend Corporation Salaried Employees Retirement Savings Plan and The Townsend Corporation Hourly Employees Retirement Savings Plan, their related plan account transfers to the appropriate plan, if applicable. Such transfers are reflected in the accompanying financial statements as "Fund transfers from Affiliate Plan".

5. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees and the majority of other administrative expenses of the Plan were paid by the Company.

First Merchants Private Wealth Advisors is the third party administrator and the investment advisor for the Plan and receives payment from the Plan and the plan sponsor. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the plan sponsor for these services. Mutual fund investment management fees are included as a reduction of investment earnings.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Company's contributions.

7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The Plan's assets as of December 31, 2024 and 2023 are all Level 1 assets.


