Note 1: The Plan and its significant accounting policies:

The following description of the MORI Associates, Inc. (the Company) 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established by the Company on January 1, 2000 to provide benefits to eligible employees. The Plan was amended and restated on November 1, 2015 and again on September 21, 2021. The Plan covers all employees of the Company, other than residents of Puerto Rico, leased employees, W-2 consultants, and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of ERISA.

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, Fidelity Management Trust Company (Fidelity) acts as trustee, recordkeeper, and custodian. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Prior to April 2023, investment-related expenses were included in net appreciation of fair value of investments, as they were paid through revenue sharing, rather than a direct payment. Starting in April 2023, investment-related expenses are charged directly to the participants' accounts and are included in administrative expenses.

Investment valuation and income recognition - Investments of the Plan are held by Fidelity and invested based solely upon instructions received from participants. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. The Plan administrator believes all notes receivable from participants are collectible.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The Plan is using a prototype plan document prepared by Fidelity, the trustee and custodian of the Plan. The Internal Revenue Service has determined and informed Fidelity by letters dated March 31, 2014 and June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has not applied for or received an individual determination letter and has been amended since June 30, 2020, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently operated, in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since December 31, 2024 due to normal market fluctuations.

Adoption of new accounting policy - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, total net assets available for benefits and change in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze their financial assets for expected credit loss under this new standard.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the lesser of 75% of eligible compensation or the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. These eligible employees may also elect to make Roth elective deferrals. Roth elective deferrals are made after taxes have been withheld. Participants may contribute a combination of pre-tax elective deferrals and Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - The Company is allowed to make discretionary matching contributions and discretionary profit sharing contributions as defined in the Plan and as approved by the Board of Directors. Discretionary matching contributions were \$1,012,496 and \$1,231,616 for the years ended December 31, 2024 and 2023, respectively. In 2024 and 2023, the Company matched 100% of each participant's contribution up to a maximum of 4% of the participant's compensation. The Company did not make a profit sharing contribution in 2024 or 2023.

Note 2: Participation and benefits: (continued)

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, administrative expenses, Company matching contributions, and an allocation of the Company's profit sharing contribution, if any. Allocation of the Company's matching contributions is based on participant contributions. Allocation of the Company's profit sharing contribution is based on participant's compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral and rollover contributions and related earnings. Prior to January 1, 2017, participants vested ratably and were fully vested in the employer's matching and profit sharing contributions allocated to their account after six years of credited service. Effective January 1, 2017, participants vest ratably and are fully vested in the employer's matching and profit sharing contributions allocated to their account after four years of credited service.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$148 and \$3,638, respectively. These accounts will be used to pay administrative fees and reduce future employer contributions. Forfeitures of \$155,147 and \$153,266 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively.

Payment of benefits - Upon termination, the participant or beneficiary will receive the benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments, paid at least annually over a period not exceeding the joint and survivor life expectancy of the participant and beneficiary. The Plan allows for automatic lump-sum distributions of participant vested account balances which do not exceed \$7,000. Account balances which exceed \$1,000 but are less than \$7,000 for which the participant has not made a distribution election are rolled over to an individual retirement account designated by the Plan administrator.

Notes receivable from participants - The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance and bear interest at the available market financing rates. The loans must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a primary residence. The specific terms and conditions of such loans are established by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Note 3: Certified information:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by Fidelity as of December 31, 2024.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market account - Valued at cost, which equates to the closing price reported in the active market in which the fund is traded.

Note 5: Related party transactions and party in interest transactions:

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the custodian and therefore, these transactions qualify as party-in-interest transactions. Prior to April 2023, fees incurred by the Plan for investment management services were included in net appreciation in the fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. Starting in April 2023, the investment management fees are charged directly to the participants' accounts and are included in administrative expenses. Additionally, the Plan issues loans to participants, which are secured by the participants' accounts. These transactions are considered party in interest transactions.

Note 6: Reconciliation of financial statements to Schedule H of Form 5500:

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise from classification differences in investment income.

Note 7: Plan termination and/or modification:

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Note 8: Subsequent events:

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.
