Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Forest Lawn 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Forest Lawn 401(k) Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Forest Lawn 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Forest Lawn 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Form 5500, Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Forest Lawn 401(k) Plan Notes to Financial Statements

Note 1 – Plan Description

The following description of the Forest Lawn 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan Document. This document is available upon request from the Plan's Administrative Committee.

The Plan is a defined contribution plan for the benefit of eligible employees of Forest Lawn Memorial-Park Association and its wholly owned subsidiary, Forest Lawn Mortuary (collectively the Company). The Plan allows immediate participation for defined classes of employees.

Plan administration – The Plan is administered by the Administrative Committee of the Forest Lawn Memorial-Park Association (the Plan Administrator), which is appointed by the Company.

Trustee, custodian, and registered investment advisor – T. Rowe Price Trust Company (the Trustee) serves as the Plan's trustee and custodian. T. Rowe Price Retirement Plan Services, Inc., serves as the primary recordkeeper for the Plan and is required to provide on a regular basis an accounting of all receipts, disbursements, and transactions of the Plan.

Sageview Advisory Group serves as the Plan's registered investment advisor.

Contributions – The Plan provides for contributions from eligible employees and the Company. Employees may elect to contribute up to 50% of their pre-tax annual compensation. Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows for Roth deferrals and in-plan Roth rollovers. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled at 5% of eligible compensation unless they affirmatively elect not to participate in the Plan. The funds are deposited into the Plan's default investment. On an annual basis, all employees currently contributing to the Plan have their contribution rate automatically increased by 1%, until they reach 15% of their compensation.

The Company may elect to make discretionary matching contributions to the Plan. Contributions by the Company, which are made at the discretion of the Company's Board of Directors, are generally 50% of employee contributions up to 7% of each employee's compensation. For the year ended December 31, 2024, employer matching contributions totaled \$3,305,599. After applying \$5,468 in forfeitures and other available balance, the net contribution of \$3,300,131 was remitted to the Plan in February 2025.

Contributions are subject to Internal Revenue Code (IRC) regulation limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, Company contributions, and investment earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions and the Company's contributions to various investment options offered by the Plan. Participants may choose from a variety of mutual fund and common collective trust options, including life cycle common collective trusts. Refer to the Summary Plan Description for more details of the various fund options.

Forest Lawn 401(k) Plan Notes to Financial Statements

Vesting – Company contributions vest immediately, and therefore, are nonforfeitable when made.

Forfeited accounts – Forfeitures are the non-vested portion of a participant's accounts that is lost upon termination of employment. Forfeitures are retained in the Plan and used to reduce current and future Company profit sharing contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,691 and \$3,507, respectively. During the plan year ended December 31, 2024, no forfeitures were used.

Notes receivable from participants – Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the participant's account balance in the Plan. As of December 31, 2024, the loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 8.5%. Loan maturity is not to exceed five years, except in the case where the loan is used to acquire or construct the participant's principal residence, in which case the loan may be at extended terms up to 15 years. As of December 31, 2024, outstanding loans had various maturity dates through December 2039. Participant loans are valued at their outstanding loan balances at year end.

Benefit payments and withdrawal – Benefits may be distributed to participants at normal retirement age, which is generally age 65, death, or termination of service. Distributions are made either in a lump-sum amount equal to the value of the participant's account or in equal installments over a term not to exceed 10 years. Participants may receive in-service distributions of their entire account balance upon attaining age 59 1/2. The Plan also allows in-service hardship withdrawals for medical, educational, or other severe financial needs for which participants have no other funds available. All withdrawals are subject to the limits specified in the Plan Document and by the IRC.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual basis of accounting.

Investment valuation and income recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e. the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date. Interest is recorded when earned. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying financial statements as net appreciation in fair value of investments.

Use of estimates – Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from these estimates.

Payment of benefits – Benefits are recorded when paid.

Forest Lawn 401(k) Plan Notes to Financial Statements

Risks and uncertainties – The Plan provides for a number of investment options in mutual funds and common collective trusts. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

The Plan invests, through the mutual funds and the common collective trusts, in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds are classified within Level 1 of the valuation hierarchy.

Forest Lawn 401(k) Plan Notes to Financial Statements

Units held in common collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. There are no unfunded commitments or redemption restrictions.

Shares of common stocks held within the individual directed accounts are valued at the closing price reported on the active market on which the individual securities are traded. Common stocks are classified within Level 1 of the valuation hierarchy.

Note 4 – Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid from Plan assets. The Company paid for other expenses of the Plan.

Note 5 – Tax Status

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Forest Lawn 401(k) Plan Notes to Financial Statements

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend the Plan or to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Note 7 – Party-in-Interest Transactions

Plan investments include shares of mutual funds and collective trusts managed by an affiliate of T. Rowe Price Trust Company, the trustee of the Plan, and therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8 – Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan's management has evaluated subsequent events through August 19, 2025, the date the financial statements were available for issuance.
