Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal controls. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of: (1) Schedule H, Part IV, Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and (2) Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and to certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and to other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Plan Description

The following description of the Family Services, Inc. 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the summary Plan description or the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Family Services, Inc. 403(b) Plan (the "Organization" or "Employer"). For elective deferral purposes, all employees, excluding nonresident aliens, are immediately eligible to participate in the Plan. For matching and non-elective contribution purposes, all employees, excluding nonresident aliens and per diem employees, are eligible to participate upon completion of one year of service. 1,000 hours of service are necessary to be credited with a year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to have a percentage or specified dollar amount deducted from their eligible compensation on a pre-tax or Roth basis, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Organization. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Plan contains an automatic enrollment provision whereby employees are automatically enrolled in the Plan after 60 days of employment at a rate of 2% of their eligible compensation.

The Organization may make an Employer matching contribution and non-elective contribution at its discretion. For the 2024 plan year, Employer matching contributions were equal to an eligible participant's elective deferrals up to 3% of their eligible compensation. For the 2024 plan year, Employer non-elective contributions were equal to 2% of an eligible participant's compensation. For 2024, the Organization made an Employer matching contribution of \$214,848 and non-elective contributions of \$186,562, which are net of forfeitures.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contributions and (b) Plan earnings (losses) thereon. Allocations are based on a participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (*continued*)

Vesting (continued)

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the Employer contribution portion of their account is based on years of continuous service as follows:

Years of Vesting Service	Vesting Percentage
Less than 2 years of service	0%
2 years of service	40%
3 years of service	60%
4 years of service	80%
5 years of service	100%

A participant will become fully vested in their Employer contributions upon death, disability or early retirement while an employee of the Organization.

Forfeitures

If a participant terminates their employment with the Employer, the non-vested contributions plus allocated earnings thereon may be used to reduce future Employer contributions and administrative expenses or can be allocated to all Plan participants. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$26,440 and \$11,081. During 2024, \$26,432 of forfeitures were used to reduce Employer contributions. None were used to reduce administrative expenses or were allocated to participants.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 25 years.

Withdrawals and Benefit Payments

On termination of service due to death, disability or retirement, a participant with a vested account balance exceeding \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time, not to exceed life expectancy. On termination of service due to other reasons, and for terminated participants with a vested account balance less than \$5,000, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Under the terms of the Plan, a participant may make a withdrawal for reasons of economic hardship.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contract, which is reported at contract value. The mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are deemed to be actively traded. The guaranteed investment contract is valued at contract value, which represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain administrative expenses of the Plan are paid by the Plan. The Organization pays all costs associated with general consulting and financial statement preparation. Investment related expenses are included in net appreciation in value of investments.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 1, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company, a qualified institution.

4. Guaranteed Investment Contract

The Prudential Guaranteed Income Fund is a group annuity product issued by Prudential Retirement Insurance and Annuity Company (“Prudential”). Principal and interest are fully guaranteed by Prudential. Guarantees are based on the claims-paying ability of Prudential. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

An Employer initiated termination of the contract is an event that could limit the ability of the Plan to transact at contract value paid within 90 days. In this instance, contract value could be paid over time, or at the Employer’s discretion. There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

The Prudential Guaranteed Income Fund represents approximately 10% and 12% of the Plan’s net assets available for benefits at December 31, 2024 and 2023.

The credit risk of Prudential was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+ as of April 2025), Moody’s Investors Service (Aa3 as of April 2025), Standard and Poor’s (AA- as of April 2025) and Fitch Ratings (AA- as of April 2025).

5. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their Employer contributions.

7. Tax Status

On March 31, 2017, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan that indicated the Plan, as then designed, was in compliance with applicable requirements of the IRC. The plan administrator believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Prohibited Transactions

During 2023, the Employer failed to remit to the Plan certain participants’ contributions totaling \$88 within the period prescribed by Department of Labor regulations. Pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to the affected participant in October 2024.

During 2024, the Employer failed to remit to the Plan certain participants’ contributions totaling \$75,945 within the period prescribed by Department of Labor regulations. Pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to the affected participant in 2025.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
