NOTE A - DESCRIPTION OF PLAN

The following description of the Kingery Printing Company 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan established by Kingery Printing Company (the Company) under the provision of Section 401(a) of the Internal Revenue Code, which includes a qualified cash or deferred arrangement as described in Section 401(k) of the Internal Revenue Code, for the benefit of eligible employees of the Company. All full-time employees of the Company who have one year of service and are age twenty-one or older are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each year participants may contribute up to the maximum percentage allowed by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a discretionary percentage, to be determined by the Company, of the participants' salary reductions. For the year ended December 31, 2023, the Company contributed 25% of the first 6% of base compensation that each participant contributed to the Plan. Additional amounts may be contributed at the option of the Company's Board of Directors. All contributions are invested as directed by each individual participant. Contributions are subject to certain limitations under the Internal Revenue Code. The Company made a discretionary contribution of \$ 145,000 for the year ended December 31, 2023. Effective January 1, 2024, the Plan was amended to include Safe Harbor matching contributions.

3. Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Company's contribution, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN - Continued

4. Vesting

Participants are immediately vested with respect to their voluntary contributions and actual earnings on these contributions. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested portion is forfeited upon termination of service. Forfeitures may be used to pay Plan expenses or to reduce employer contributions.

5. Investment Options

Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan's Trustees. Participants may change their investment options at any time pursuant to procedures established in the Plan document.

6. Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period not more than the participant's assumed life expectancy. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

7. Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$ 3,235 and \$ 10,473, respectively. These accounts will be used to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$ 10,559 and \$ 5,271 from forfeited nonvested accounts, respectively.

8. Plan Termination

Although it has not expressed any intent to do so, the Company may discontinue its contributions, anytime thereafter, and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Excess Contributions

Amounts paid prior to the year-end that correspond with payroll dated after the year-end are recorded as excess contributions to place them in the correct accounting year. The amount paid is due to the timing of bank holidays and cleared with the processing of the first payroll of the following plan year.

4. Payment of Benefits

Benefit payments to participants are recorded upon distribution.

5. Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

6. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions. Those estimates and assumptions affect the reported amount of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

7. Subsequent Event

The Plan assessed events that have occurred subsequent to December 31, 2024 through October 3, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. No events occurred that would require adjustment to or disclosure in the financial statements.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024 and 2023, were obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

NOTE D - FAIR VALUE INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets.
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust

Valued at the NAV of units of the collective trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to indicate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair values as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in funds of the Custodian. The Plan paid \$ 4,947 and \$ 13,125 of administrative fees to Voya Retirement Insurance & Annuity Company during the years ended December 31, 2024 and 2023, respectively.

Additionally, the Company provides certain administrative services at no cost to the Plan.

NOTE F - PLAN TAX STATUS

The Internal Revenue Service has determined and informed the volume submitter sponsor by a letter dated March 31, 2014 that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Company is relying on the volume submitter sponsor's letter of determination. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE F - PLAN TAX STATUS - Continued

The Plan follows accounting principles generally accepted in the United States of America related to the accounting for uncertainty in income taxes which sets a minimum threshold for financial statement recognition of the benefit of a tax position taken or expected to be taken in a tax return. Tax positions for the open tax years as of December 31, 2024, were reviewed, and it was determined that no provision or disclosure for uncertain tax positions is required.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
