### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Unilock Retirement Plan and Trust (New York) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and



- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## Notes to Financial Statements

### 1. Description of the Plan

The following description of the Unilock Retirement Plan and Trust (New York) (the "Plan") is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan to enable eligible employees, as defined in the Plan document of Unilock New York, Inc. (the "Company") to defer receipt of a portion of their earnings for the principal purpose of providing benefits at the time of retirement, disability, or death. Employees who are employed by the Company for one year with at least 1,000 hours of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designed investment fund until changed by the participant. The rate increases by 1% annually each July 1, not to exceed 10% of eligible compensation. Automatically enrolled participants may elect to increase or decrease percentages, and may elect to stop the auto-increase, as defined by the Plan document.

The Plan is administered by a 401(k) Plan Committee (the "Committee") that serves at the discretion of the Company's Board of Directors and includes the trustees of the Plan. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, directing the Plan's service providers, and maintaining participant accounts

#### Contributions

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code ("IRC") of their pre-tax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified retirement plans.

The Plan provides for the Company to make safe harbor matching contributions to participants of the Plan equal to 100% of compensation contributed to the Plan, generally not to exceed 5% of a participant's eligible compensation or 6% for participants who are considered non-highly compensated employees with 10 years of credited service. Matching contributions are capped at \$6,000 for highly compensated employees. The Company made safe harbor matching contributions of \$436,492 and \$409,341 to the Plan for 2024 and 2023, respectively.

## Notes to Financial Statements

### 1. Description of the Plan (Continued)

#### Contributions (Continued)

The Company may also elect to contribute discretionary non-safe harbor matching contributions to the Plan at the option of the Company. The Company did not make any such discretionary non-safe harbor matching contributions for either of the years ended December 31, 2024 and 2023.

In addition, the Company may also make, at its sole and unrestricted discretion, a discretionary profit-sharing contribution to the Plan. Participants must be employed on the last day of the plan year and have worked 1,000 hours of service in order to receive an allocation of any discretionary profit-sharing plan contributions. Allocations to participant accounts of any discretionary profit-sharing contributions are based upon points earned by the participants. Each participant is awarded one point for each year of service (not to exceed 40 points) and one point for each \$10,000 of compensation (not to exceed 10 points). The amount of the discretionary profit-sharing contribution was \$332,244 and \$489,182 for the years ended December 31, 2024 and 2023, respectively.

Participants may direct all their contributions among one or more funds offered in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions as permitted, pursuant to the Plan's provisions.

Effective January 1, 2020, the Plan was amended to allow participants to elect Roth contributions at their discretion.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and the Company safe harbor matching contributions plus actual earnings thereon. Vesting in any Company discretionary non-safe harbor matching contributions and Company discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of service. Participants vest 30% in the first year, 60% in the second year, and are fully vested after three years of service.

## Notes to Financial Statements

### 1. Description of the Plan (Continued)

#### Payment of Benefits

Upon termination of service due to retirement, termination of employment, death, permanent disability or attainment of age 59-1/2, a participant may elect to receive the value of their vested interest in their accounts as lump-sum distribution or as a rollover to another entity. If the participants vested interest in the Plan is less than \$5,000, a mandatory lumpsum distribution will be made to the participant. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period, or (b) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates, as determined by the Plan Administrator. Interest rates on outstanding loans currently range from 5.25% to 10.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, unless the loan is used for the purchase of a primary residence, in which case a longer term may be granted.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts were not material to the financial statements. Forfeited accounts are used to pay Plan expenses or to reduce future Company contributions. For the years ended December 31, 2024 and 2023, Company contributions were reduced by approximately \$900 and \$3,600, respectively, from forfeited nonvested accounts.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value in accordance with FASB ASC 820, Fair Value Measurements and Disclosures. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 7 for discussion of fair value measurements.

### 2. Summary of Accounting Policies (Continued)

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. In accordance with the policy of stating investments at fair value, net appreciation for the year (including both realized and unrealized gains and losses) is reflected in the statements of changes in net assets available for benefits.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits when the deduction is made. Employer contributions are recorded as additions to net assets available for benefits when such liability arises. Participant contributions not yet deposited and amounts not funded by the Employers are recorded as contributions receivable.

#### Payment of Benefits

Benefits payments are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and requested distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date on which the financial statements were available to be issued.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 3. Information Certified by the Plan's Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the custodian, has certified that the following data included in the accompanying financial statements and supplement schedule is complete and accurate.

### 4. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are units of pooled separate accounts and common/collective trust funds managed by Principal Trust Company and affiliates. Principal Trust Company is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian amounted to \$17,296 and \$14,505 for the years ended December 31, 2024 and 2023, respectively.

Fees paid by the Plan to Lawley Retirement Advisors amounted to \$11,136 and \$11,173 during the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

### 6. Tax Status

The Plan adopted a Non-Standardized Pre-Approved plan document from Actuarial Benefits Corporation, which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 stating that the prototype plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies - valued at daily closing prices, as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

### 7. Fair Value Measurements (Continued)

Common/Collective Trust Funds - the fair market value of the common/collective trust funds has been established using the NAV provided by the administrator of the funds under the practical expedient approach and therefore is not assigned to a level in the hierarchy table. The NAV is based on the value of the underlying assets owned by the funds, minus liabilities, net of account level fees, and then divided by the number of shares outstanding. The Principal Stable Value Z Fund (the "Fund") and Principal LifeTime Hybrid Collective Investment Funds (the "Funds") are collective investment trusts held by Principal Global Investors Trust Company, as Trustee. Principal Global Investors Trust Company is a whollyowned subsidiary of the Principal Financial Group. Principal Global Investors Trust Company holds omnibus accounts in the name of Principal Life Insurance Company for the collective investment of retirement benefit plan assets from participating trusts. The common/collective trust funds generally provide for daily redemptions by the Plan at reported net asset value, with up to a 30-day redemption notice period.

The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity. The Fund seeks to achieve this objective by investing primarily in a variety of high-quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents. It is intended that the Fund's stable value investment contracts will maintain a minimum weighted average credit quality rating of A or better. The underlying fixed income securities must be rated investment grade and meet issuer diversification guidelines. The Fund is designed for long term retirement investing.

The objective of the Funds are to either seek current income and capital appreciation, or to seek total return consisting of long-term growth of capital and current income, consistent with investment strategy of investors who wish to retire in various future years.

Pooled Separate Accounts - valued using the NAV under the practical expedient approach and therefore is not assigned to a level in the hierarchy table. The NAV is based on a per unit value for the number of units held by the Plan at year end, based on the underlying investments in the pooled separate account. Pooled separate account investments can include, but are not limited to, stocks (both domestic and foreign), bonds, mortgages, real estate, registered investment companies, other separate accounts, and cash or cash equivalents as specified in the separate account's investment policy. The pooled separate accounts generally provide form daily redemptions by the Plan at reported net asset value, with no advance redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
