### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ORW USA 401(k) Plan (f/k/a ORW USA 401K) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1 – Description of the Plan**

The following description of the ORW USA 401(k) Plan (f/k/a ORW USA 401K) (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of ORW USA, Inc. (Company). There are no age or service requirements to enter the Plan. The Plan was originally effective June 15, 1993. Residents of Puerto Rico and employees whose employment is governed by a collective bargaining agreement under which retirement benefits were subject to good faith bargaining are not eligible to participate in the Plan. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan engages John Hancock Trust Company LLC (John Hancock), the custodian of the Plan, to hold and invest Plan assets and execute Plan transactions.

During 2024, the Plan changed providers from Reliance Trust Company and ADP Retirement to John Hancock. The transfer of assets from Reliance Trust Company was initiated on March 28, 2024 and received by John Hancock on April 1, 2024.

Effective April 1, 2024, the Plan was also amended and restated as part of the required 3rd Cycle Restatement of the John Hancock volume submitter Plan document which was adopted by the Plan. As part of the restatement,

- The name of the Plan was changed from ORW USA 401K to ORW USA 401(k) Plan.
- Roth contributions are permitted effective April 12, 2024.
- Nonresident aliens and Code §410(b)(6)(C) employees were removed from the list of excluded employees.
- Age and service requirements were removed.
- The Company is now permitted to make a discretionary match.
- The automatic enrollment rate for new hires and rehires increased from 1% to 3%.

Contributions

Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan, into a pre-tax or post-tax ROTH account subject to limits of the tax law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Newly hired or rehired employees are automatically enrolled in the Plan at a 3% deferral rate unless they make an affirmative election not to participate in the Plan.

The Company may also elect to make discretionary matching and nonelective contributions. There are no additional requirements for participants to receive a discretionary contribution. No discretionary contributions were made during the periods presented. Contributions are subject to certain regulatory limits.

Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. If no election is made, participants' contributions are placed into a target retirement fund, the Plan designated default investment, based on their projected retirement age. Participants can change their investment elections daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses and any related transaction fees for loans and distributions. Allocations are made in a manner which recognizes each participant's account balance, investment selection and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Note 1 – Description of the Plan, continued**

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution is based on years of continuous service. A participant becomes partially vested after 2 year of service and is 100% vested after 6 years of credited service. A participant becomes fully vested in the entire balance of his or her account upon retirement, disability, death or termination of the Plan.

##### Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to 50% of their vested account balance, or a maximum of \$50,000. These loans are secured by the balance in the participant's account and bear interest at the prime rate. The repayment term may not exceed five years, except for loans used to purchase the participant's primary residence. Participants can have one loan outstanding at any time. Principal and interest are paid through payroll deductions.

##### Payment of Benefits

On termination of service due to any reason, participants with vested account balances of \$1,000 or less receive an automatic lump-sum distribution, unless the participant requests that it be rolled-over to an Individual Retirement Account (IRA) provider or another qualified retirement plan. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive a lump sum distribution or an automatic distribution to an IRA. Participants with vested account balances of \$5,000 or more may elect to receive their benefits in any way permitted by the Plan, leave their balance in the Plan, or choose to rollover their balance into another qualified retirement plan or IRA. Participants may also take in-service and hardship distributions subject to the terms of the Plan and Internal Revenue Service (IRS) regulations.

##### Forfeited Accounts

Generally, a participant's unvested portion of the Company's discretionary contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to pay Plan expenses or reduce Company contributions.

At December 31, 2024 and 2023 forfeited nonvested accounts total \$5,553 and \$5,272, respectively. During the year ended December 31, 2024, no forfeitures were used.

#### **Note 2 – Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

Certain investment management fees and other charges paid are offset against fund performance in the net appreciation in fair value of investments on the statement of changes in net assets available for benefits and are not, therefore, separately reflected as administrative expenses. Certain Plan expenses are paid directly by the Company and therefore are excluded from these financial statements.

Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 approximately 17% and 16%, respectively, of the Plan's investments were invested in the BlackRock LP Index 2045 and BlackRock LP Index 2055 Funds.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

Contributions

Contributions from Plan participants and the Company, when applicable, are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

**Note 3 – Certified Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the period of April 1, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock (the current custodian of the Plan), a qualified institution.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the period of January 1, 2024 to April 1, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the former custodian of the Plan), a qualified institution.

**Note 4 – Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust (CCT):* Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

Loans to participants also qualify as party-in-interest transactions.
