Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lane's Retirement Savings and Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Lane's Retirement Savings and Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General and Eligibility: The Plan is a defined contribution profit-sharing plan that allows participants to make pre-tax 401(k) deferrals and roth 401(k) deferrals. Non-union employees of Lane Enterprises, LLC and Pacific Corrugated Pipe Company, LLC are eligible to participate on monthly entry dates upon completion of two months of service. Leased employees, high school and college work study program student employees, and employees that are considered non-resident aliens are also excluded from participation. The Plan also allows Long-Term, Part-Time (LTPT) employees to participate in the plan. Any employee who is credited with a minimum of 500 hours of service during each of the three consecutive twelve-month periods, shall participate in the plan for the purposes of making elective deferral contributions on the earlier of January 1 or July 1 entry date or immediately following the second consecutive 12 month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may direct their pre-tax and roth contributions to separate investment funds as provided by the Custodian. Participant contributions for a plan year are limited to fifty percent (50%) of annual compensation (as defined by the Plan). The Plan provides for an automatic enrollment provision whereby participants will automatically defer 4% of their compensation into the Plan, unless they elect otherwise. The Company has elected to contribute, on a matching basis, to participants who elect pre-tax and roth contributions. Participants who elect pre-tax or roth contributions will receive a safe-harbor matching contribution from the employer of 100% on the first 4% of compensation. The Company may make an annual discretionary basic contribution to participants who complete at least one hour of service in the plan year. Basic contributions are allocated to participants based on years of credited service as of the end of each plan year.

Participant Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their allocations on a daily basis.

Participants' Accounts: Each participant's account is credited with the participant's contributions, employer matching contributions and allocations of (a) the Company's basic contribution, if any (b) Plan earnings, and charged with an allocation of administrative expenses. Plan earnings are allocated daily in proportion to each participant's share in the underlying investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans: Participant loans are not permitted by the Plan.

Administrative Expenses: All investment and management fees, as well as certain administrative fees, are paid by the Plan. All other costs associated with the administration of the Plan are paid by the Plan Sponsor.

Note 1. Description of the Plan (Continued)

Vesting: Participants are fully vested in their pre-tax and roth deferrals, their share of employer matching contributions and the investment earnings on such contributions. Vesting in other discretionary employer contributions begins at 20% upon completion of two years of service and increases to 100% vesting upon completion of six years of service. A participant is fully vested at normal retirement age of 62, regardless of service.

Payment of Benefits: Payment of benefits that exceed \$7,000 on account of retirement, death, disability, or termination of employment will be made in a lump-sum or in the form of an annuity chosen by the participant based on available options. Vested balances of less than \$7,000 but more than \$1,000 may be automatically rolled over into an individual retirement account without participants consent. Vested balances of less than \$1,000 may be distributed to a participant via a direct cash distribution. Active employees may take in-service distributions from the Plan after attainment of age 59½, subject to certain limitations imposed by the Plan. Hardship withdrawals of elective deferrals are permitted based on demonstrated financial need. After-tax contributions and earnings thereon may be withdrawn at any time.

Forfeited Accounts: If a participant terminates employment before being fully vested, the non-vested portion of the terminated participant's account balance will remain in the Plan. Forfeited non-vested accounts are used to reduce administrative expenses of the Plan. During 2024, no forfeitures were used to reduce administrative expenses. There are no unused forfeitures remaining at December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 3, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Charles Schwab Trust Bank, (the custodian of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurements*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

Note 4. Investments and Fair Value Measurements (Continued)

The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and registered investment companies: Shares of money market funds and registered investment companies (mutual funds) are valued at the daily closing prices as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-in-Interest Transactions

Participants in Lane's Employee Stock Option Plan (ESOP) may elect to diversify the stock in their ESOP accounts by taking a distribution and rolling it into Lane's Retirement Savings and Pension Plan. These plan transfers, amounting to \$1,811,127 during 2024, are reported as a separate addition on the statement of changes in net assets available for plan benefits.

Certain plan investments at December 31, 2024 and 2023, consist of shares of a money market fund managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA sponsored by Conrad M. Siegel, Inc. The Plan Sponsor has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, that the Plan, as then designed, was in accordance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended subsequently, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
