## Independent Auditors' Report

To the Plan Administrator  
of SMW Health Network 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the SMW Health Network 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **SMW Health Network 401(k) Plan**

Notes to Financial Statements

December 31, 2024 and 2023

### **Note 1 – Description of the Plan**

The following description of the SMW Health Network 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all eligible employees of multiple employers. The employers that have elected to participate are SMW Health Network, LLC (the “Plan Sponsor”), Caprock Home Health Services, Inc., and Halcyon Home, LLC.

Prior to January 1, 2022, Halcyon Home, LLC sponsored a single employer defined contribution plan. Effective January 1, 2022, SMW Health Network, LLC assumed the role of Plan Sponsor (also referred to as the Lead Employer) of the previously established Halcyon Home Plan, which was renamed the SMW Health Network 401(k) Plan and redefined as a multiple-employer plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### **Eligibility**

Substantially all employees of the Plan Sponsor are eligible to participate in the Plan upon the completion of two months of service and attaining age 21. Eligible employees become participants in the Plan on the first day of the month coincident with or immediately following the attainment of the above requirements.

#### **Administration**

The Plan is administered by the Plan Sponsor (the “Plan Administrator”).

As of December 31, 2023 and through December 15, 2024, the Plan’s assets were held in trust by The Standard Insurance Company (“The Standard”). Effective December 15, 2024, the trustee of the Plan became Fidelity Management Trust Company (“FMTC”), and the financial records of the Plan have since been maintained by Fidelity Workplace Services, LLC (“Fidelity”). The Standard and FMTC (collectively, the “Trustees”) are referred to as the Trustees of the Plan, and Fidelity serves as the Plan’s Recordkeeper.

#### **Participant Contributions**

Contributions are made to the Plan by the Plan Sponsor on behalf of each eligible participant based upon the participant’s elected compensation deferral through payroll deductions. The Plan Sponsor funds the contributions at the end of each payroll period. Eligible participants may make pre-tax and Roth 401(k) contributes to the Plan up to the statutory limit, as permitted by the Internal Revenue Code of 1986, as amended (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants age 50 and older as of December 31 of the Plan year are permitted to make elective catch-up deferrals in accordance with Section 414(v) of the Internal Revenue Code (“IRC”).

#### **Employer Contributions**

The Plan provides for Plan Sponsor discretionary matching contributions. The Plan Sponsor is permitted to change the amount or percentage of matching contributions when needed. For the year ended December 31, 2024, the Plan Sponsor did not make a discretionary matching contribution to the Plan.

### Note 1 – Description of the Plan (continued)

The Plan Sponsor may also elect to make a discretionary profit-sharing contribution in an amount to be determined by the Plan Sponsor for each plan year. For the year ended December 31, 2024, the Plan Sponsor did not make a discretionary profit-sharing contribution to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Rollovers and Transfers

Participants who have a balance in another qualified employee benefit plan, as described in Section 401(a) of the IRC, may transfer or rollover the lump sum values of their account directly into the Plan, provided it meets the requirements of the IRC.

#### Forfeited Accounts

Forfeited accounts may be used to reduce future Plan administrative expenses and employer contributions. The non-vested portion of terminated participants' account balances become forfeitures on the earlier of a requested distribution or five consecutive years without credit service at the Plan Sponsor, not on the date of termination. There were no unallocated forfeitures for the years ended December 31, 2024 and 2023.

#### Vesting

Participants are immediately and fully vested in their contributions plus actual earnings thereon. The participants are vested in the Plan Sponsor discretionary matching and profit share contributions and earnings in accordance with the following schedule:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Participants are only permitted to have one note outstanding at a time. Notes receivable are secured by the balance in the participant's account and bear interest at a rate which is commensurate with prevailing rates as determined by the Plan administrator. All notes must be repaid in equal installments of principal and interest over a period to be determined by the Plan Administrator, but such period shall not exceed five years unless the purpose of the loan is for the purchase of the principal residence of the Participant in which case the repayment period shall be determined by the Plan Administrator. In all cases, repayment of the note will be made through after-tax payroll deductions.

#### Payment of Benefits

Benefits become available to participants on the earliest of four events: (1) termination of employment, (2) death of the participant (benefits are payable to the participants' spouse or beneficiary), (3) disability of the participant, or (4) the participant's retirement.

### **Note 1 – Description of the Plan (continued)**

If the vested account balance is \$5,000 or less, the Plan Administrator may direct the Trustee to distribute the amount to another qualified plan benefiting the participant or are paid out through lump-sum distribution. Participants are permitted to remain in the Plan if their account balance exceeds \$5,000.

Active participants can withdraw benefits once they reach 59 ½ years of age. In-service distributions are permitted due to hardship, as defined in the Plan and subject to the satisfaction of the Plan Administrator. Participants are required to begin receiving distributions in accordance with the minimum distribution requirements of Internal Revenue Code section 401(a)(9).

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and distributions would be made as soon as administratively practical after the Plan terminates.

### **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment adviser and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### Note 2 – Summary of Significant Accounting Policies (continued)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

#### Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Recent Accounting Standards

The SECURE 2.0 Act of 2022, enacted on December 29, 2022, includes a wide range of provisions affecting retirement plans, with effective dates spanning from 2023 through 2026. Plan management has implemented operational changes necessary to comply with applicable provisions effective for the years ended December 31, 2024 and 2023. The Plan has until December 31, 2025 to adopt formal amendments. Plan management continues to evaluate the impact of SECURE 2.0 on future periods. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

### Note 3 – Information certified by the Trustees

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As described in Note 1 above, the Plan changed recordkeepers effective December 15, 2024. Accordingly, the respective Trustees have certified to the completeness and accuracy of the data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, for the periods during which each served as described above in Note 1.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### Note 4 – Tax Status

As of December 31, 2023 and through December 15, 2024, the Plan Sponsor adopted a prototype non-standardized, profit-sharing plan from Minnesota Life Insurance Company which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the prototype plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

As of December 31, 2024 and for the period December 15, 2024 through December 31 2024, the Plan Sponsor adopted a prototype non-standardized, profit-sharing plan from FMR LLC which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the prototype plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is subject to income tax examinations for three years.

### Note 5 – Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

- Level one — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level two — Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level three — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market:* Fair value is estimated to be carrying value.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the net asset value (“NAV”) of units for each fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

*Pooled Separate Accounts:* Valued at the NAV of units for each fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

### Note 6 – Related-Party and Parties in Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee or its affiliates. Fees incurred by the Plan for related investment management services are included in administrative expenses and net appreciation in fair value of investments. Certain fees incurred by the Plan for recordkeeping and audit fees are included in administrative expenses. Transactions such as these qualify as party-in-interest transactions. The Plan Sponsor pays directly certain other fees related to the Plan's operations.

### Note 7 – Prohibited Transactions

During 2022 and 2021, the Plan Sponsor failed to remit participant contributions in a timely manner. The Plan Sponsor identified several instances during the years ended December 31, 2022 and 2021, where \$185,144 and \$46,379, respectively, in participant contributions were remitted to the Plan in violation of DOL regulations. The Plan Sponsor submitted the missed earnings and interest to the Plan in accordance with the DOL's Voluntary Fiduciary Correction Program ("VFCP") in August 2024.

A summary of nonexempt prohibited transactions related to delinquent remittances is shown in the attached supplemental schedule of delinquent participant contributions for the year ended December 31, 2024.

### Note 8 – Excess Contributions Payable

During the year ended December 31, 2024, the Plan received contributions of \$40,488 in excess of certain IRC code sections. The excess contributions were related to participants exceeding IRS annual limits elective deferrals and/or annual additions to the participants' accounts. The Plan administrator is in the process of forfeiting the contributions from the accounts and making the corrective distributions to meet the IRS requirements for the Plan year ended December 31, 2024.
