Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Navicent Health 403(b) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Navicent Health 403(b) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion



NOTES TO FINANCIAL STATEMENTS
AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Navicent Health 403(b) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for eligible employees of Navicent Health, Inc. (the Company) and certain subsidiaries. Employees are eligible to participate in the Plan as of their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Advocate Health, Inc. Benefits Administration Committee.

Contributions

Each year, participants may contribute an amount of their eligible compensation (as defined in the Plan document) as pre-tax or Roth after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 3% contribution rate unless they elect a different deferral rate or elect not to participate in the Plan.

The Company provides a discretionary matching contribution. Currently, the Company contributes 100% of the first 3% of a participant's contributions plus 25% of the next 4% to 7% of a participant's contribution up to 7% of a participant's eligible compensation.

In addition, the Company's board of directors may approve a discretionary employer base contribution on behalf of eligible employees based on such employees' years of service and compensation. Currently, the Company is not making any discretionary contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with participant contributions and Company matching contributions, as well as allocations of the Company's base contribution, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocation of contributions is based on participant compensation. Allocation of investment results is based on the participant's account balance in the investment options selected by the participant. The benefit to which a participant is entitled is equal to the balance in the participant's account.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants also become 100% vested in Company contributions upon retirement, death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at +1% of the prime rate. Principal and interest are paid ratably by participants.

Plan Loans

Participants may borrow amounts directly from The Variable Annuity Life Insurance Company (VALIC), the insurance company, in an amount up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate established each calendar quarter based on Moody's Corporate Bond Yield Average – Monthly Average Corporate for the month ending two months prior to the calendar quarter. Loan terms are up to five years, except for loans to fund the purchase of a principal residence, for which the loan may be repaid over a reasonable period that may not exceed 10 years. Upon establishment of the loan, the amount of the loan, the first quarter's interest payment and any applicable VALIC withdrawal charges are transferred from the participant's account and placed in a separate account held by the Plan. As the loan is repaid quarterly, the amount of the separate account is reduced by the payment amount. Because VALIC is the lender, a portion of the interest payment is retained by VALIC. At December 31, 2024 and 2023, collateralized amounts were \$357,846 and \$429,949, respectively.

Payment of Benefits

On termination of service, a participant may elect to receive their vested account balance through a single lump-sum payment, installment payments or an individual or joint survivor annuity.

Forfeited Accounts

Forfeitures of non-vested Company contributions are used to reduce future Company contributions or pay Plan administrative expenses. During 2024 and 2023, \$30,119 and \$0, respectively, of forfeited participant accounts were used to reduce the Company's contributions or pay Plan expenses. At December 31, 2024 there were \$856,488 of forfeitures that have not yet been applied.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 3 for the description of valuation methodology.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE

The Plan's investments are reported at fair value and the assets are categorized based upon whether the inputs used to determine fair values are observable or unobservable. Observable inputs are inputs that are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumption about pricing the asset or liability, based on the best information available under the circumstances.

The fair value of all assets and liabilities recognized or disclosed at fair value is classified based on the lowest level of significant inputs. Assets and liabilities that are measured at fair value are disclosed and classified in one of three categories. Category inputs are defined as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets on the reporting date.

Level 2 - Inputs other than quoted market prices included in Level 1 that are observable for the asset, either directly or indirectly. If the asset has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs that are unobservable for the asset for which there is little or no market data.

The following section describes the valuation methodologies the Plan uses to measure fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Separate Accounts (PSA): Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. This methodology is deemed to reflect quoted prices of similar assets in active markets.

Self-directed brokerage accounts: These are auxiliary brokerage accounts within the plan that give participants more flexibility and options when choosing investments. Assets within these accounts generally employ the same valuation methods that are used for other plan assets measured at fair value. Equities, bonds and mutual funds are all valued based the closing sales price or published NAV on the last day of the plan year.

The preceding methods described may produce a fair value calculation that does not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive investment contract with VALIC and Lincoln National Life Insurance Company (Lincoln). Both companies maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but it may not be less than 1 percent. Such interest rates are reviewed on an annual basis for resetting.

These contracts meet the criteria for fully benefit-responsive investment contracts and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC and Lincoln, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is depending on the issuers' ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investments options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5)

premature termination of the contracts. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

5. INFORMATION CERTIFIED BY THE TRUSTEES

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustees, The Variable Annuity Life Insurance Company, VALIC Trust Company Inc. and Lincoln National Life Insurance Company, as of December 31, 2024 and 2023 and for the year then ended December 31, 2024. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by VALIC and Lincoln. VALIC and Lincoln are the trustees and record keepers for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

VALIC provides certain administrative services to the Plan pursuant to a services agreement between the Company and VALIC. VALIC receives revenue from mutual fund service providers for services VALIC provides to the funds. This revenue is used to offset certain amounts owed to VALIC for its administrative services to the Plan. If the revenue received by VALIC from such mutual fund service providers exceeds the amount owed under the service agreement, VALIC remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Company may make payments to VALIC for administrative expenses not covered by revenue sharing.

7. TAX STATUS

The IRS has determined and informed the Company by a letter dated April 5, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by taxing authorities. It is the opinion of the Company that the Plan has no uncertain tax positions that would be subject to change upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax filings are generally subject to examination for three years after they are filed.

8. PLAN TERMINATION

Although it has not expressed any such intent, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are 100% vested in their accounts.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investments that are exposed to several risks, such as interest rate, market risks and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. RESTATEMENT FOR CORRECTION OF ERRORS

Management determined the presentation of notes receivable from participants net of deemed distributions in the 2023 financial statements was improper based on the Plan generally accepted accounting principles. The correction resulted in an increase in the value of notes receivable from participants of \$1,266,503 on the accompanying statement of net assets available for benefits as of December 31, 2023.

Management has restated the 2023 financial statements to correct this misstatement.
