## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Center for Community Alternatives 403(b) Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing plan available to employees of Center for Community Alternatives, Inc. (the Center) who meet certain eligibility requirements. Empower Retirement, LLC (Empower), a wholly owned subsidiary of Empower Life & Annuity Insurance Company of New York (Empower Life), is the recordkeeper of the Plan's assets. Empower Life is the insurance company and issuer of the annuity contracts of the Plan. Empower Trust Company, LLC (Empower Trust) is the directed custodian of certain assets of the Plan recordkept by Empower. Pentegra Services, Inc. (Pentegra) is the third-party administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

All employees of the Center are eligible to immediately begin salary deferrals pursuant to a properly completed and valid salary reduction agreement. Participants are eligible for the Center's contribution after completing six months of service. The Center's contributions are allocated to participant accounts based on a uniform percentage of the participant's compensation.

#### **Contributions**

Active participants may make voluntary contributions in the form of salary reductions and applicable rollovers from other qualified plans, subject to certain limitations of the Internal Revenue Code (the Code) under Section 403(b). Each year the Center may elect to make discretionary contributions as determined by its Board of Directors. There was no discretionary contribution for 2024. In 2023, the Center contributed \$353,602.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Center's contribution and Plan earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses are based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

#### **Vesting**

Participants are immediately vested in their account balance, which includes voluntary contributions, the Center's contributions and actual earnings (losses) thereon.

#### **Funding Vehicles**

Plan contributions are invested in one or more of the funding vehicles offered by the Plan. The Plan does not permit plan-to-plan transfers or contract exchanges with any annuity contract or custodial account that is not a funding vehicle specifically approved by the Plan Administrator for use under the Plan.

### Notes Receivable from Participants

Participants may borrow an amount up to the lesser of 50% of the amount of their vested balance or \$50,000. The loan amount cannot exceed the maximum amount imposed by the IRC. A participant may borrow a minimum of \$1,000. Loans are repayable over not more than five years, except in the case of a loan for the purchase of a primary residence. All loans must bear interest at prime plus 1%. Total notes receivable from participants outstanding at December 31, 2024 and 2023 were \$103,002 and \$80,499, respectively. All loans bear interest at 4.25% to 9.5% at December 31, 2024. Notes mature at various times through November 2029.

### Payment of Benefits

The Plan provides benefit payments upon either termination of employment or the attainment of age 65. Benefits may be paid out in a single lump sum, partial payments, installment payments or an annuity contract (if assets are held in a custodial account).

### Hardship Withdrawals

Hardship withdrawals are not allowed.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

### Investments

The Plan's investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases or sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan had fully benefit-responsive investment contracts with Empower Life. These contracts are included in fully benefit-responsive fixed annuity contracts on the statements of net assets available for benefits and are reported at contract value. Empower Life maintains Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments were guaranteed by Empower Life at a rate of 1.75% and 1.40% in 2024 and 2023, respectively.

### Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement (Continued)

The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at the net asset value of shares held at year end based on quoted prices in active markets.

There were no changes in the valuation methodologies used during 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

### Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year end. The Plan considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. The Plan has not experienced any historical credit losses relative to contributions receivable. Current and future economic conditions are not expected to change relative to historical financial information and the full amount outstanding was received subsequent to year end. Therefore, management has determined that no allowance for credit losses is necessary for 2024 and 2023.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

### Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by participants. Management fees and operating expenses charged to the Plan for investments are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right, under the Plan document, to terminate the Plan subject to the provisions of ERISA.

#### 6. TAX STATUS

In a letter dated March 31, 2017, the IRS informed Pentegra that the prototype plan, which was adopted by the Plan, is designed in accordance with applicable sections of the Code. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

#### 7. PARTY-IN-INTEREST TRANSACTIONS

Empower is the recordkeeper of the Plan's assets. Empower Life is the insurance company and issuer of the annuity contracts of the Plan. Empower Trust is the directed custodian of certain assets of the Plan recordkept by Empower. Pentegra is the third-party administrator. As such, transactions between Empower, Empower Life, Empower Trust, Pentegra and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

#### 8. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the year ended December 31, 2024.

#### 9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.
