Notes to Financial Statements

1. Description of Plan

The following description of the Huntington House, Inc. (the “Company”) 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company who have completed 1 year of service and attained the age of 21. Employees may begin participation as of January 1, April 1, July 1, or October 1 of the year in which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled to defer 4% of pre-tax compensation unless they elect an alternative percentage or decline participation. Participants may otherwise elect to contribute a percentage of their annual pre-tax and/or after-tax (“Roth”) compensation, not to exceed the limits established by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also rollover balances from other qualified plans and certain individual retirement accounts (“rollovers”). The Company makes safe harbor matching contributions equal to 100% of the first 4% of compensation contributed to the Plan. The Company may also make a discretionary profit sharing contribution. However, no discretionary profit sharing contribution was made in 2024.

Upon enrollment in the Plan, a participant may direct contributions into any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and Company’s contributions and an allocation of the Plan’s net earnings, and administrative expenses. Allocations are based upon participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their voluntary contributions and the Company safe harbor matching contributions plus any earnings thereon. Discretionary profit sharing contributions, plus earnings thereon, vest 20% after two years of service increasing 20% for each additional year with 100% vesting after six years of eligible service.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant or beneficiary may elect to receive the value of the vested interest in his or her account in a lump-sum payment. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of hardship, as specified by the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset administrative expenses. However, no forfeitures were utilized during 2024. Forfeited accounts totaled approximately \$8,400 and \$4,900 at December 31, 2024 and 2023.

1. Description of Plan (Concluded)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have up to two outstanding notes at any given time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the plan administrator based on prevailing market rates. The maximum term of a note for other than the purchase of a primary residence shall be five years. Principal and interest are repaid ratably through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including trustee, recordkeeping and investment advisory fees are paid by the Plan. Loan and distribution fees are paid out of affected participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Mass Mutual Guaranteed Interest Account (Note 9).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Concluded)

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 6, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, the trustee of the Plan.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Nova 401(k) Associates Inc ("Nova"). The IRS has determined and informed Nova by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Fees paid by the Plan to Empower Annuity Insurance Company ("EAIC"), an affiliate of the Plan's trustee for recordkeeping services were approximately \$35,000 in 2024.

Fees paid by the Plan to Cetera Advisor Networks and Investment Advisers for investment advisory services were approximately \$2,000 (net of approximately \$25,000 in participant revenue credits) in 2024.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Guaranteed Investment Contracts

The Mass Mutual Guaranteed Interest Account is a group annuity contract backed by EAIC. The contract is designed to achieve consistent returns to support a competitive crediting rate, provide safety of principal, and full liquidity at book value for participant-directed payments and transfers to non-competing investments. Under the contract, a crediting rate is established for a six-month period of time with all assets credited with the same rate until the new crediting rate is declared. The minimum crediting rate under the contract was 2.15% and 1.25% at December 31, 2024 and 2023.

10. Delinquent Participant Contributions

During the year ended December 31, 2024, participant elective deferrals of \$1,192 were not remitted within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. As of the report date, the Company is in the process of taking the necessary corrective action, including the calculation and remittance of lost earnings to the affected participant accounts.
