To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Kayaku Advance Materials, Inc. 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

KAYAKU ADVANCE MATERIALS, INC. 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of Kayaku Advanced Materials, Inc. 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined-contribution plan established on January 1, 1998, to provide retirement and other related benefits to all employees of Kayaku Advanced Materials, Inc. and its affiliate, Nippon Kayaku America, Inc. (collectively, the “Company”). Employees, other than excluded employees, are eligible to participate upon reaching the age of 21. An employee is an excluded employee if they are a union employee or if they are a nonresident alien. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Voya Retirement Insurance and Annuity Company (“Voya”) and Guardian Insurance and Annuity Company (“Guardian”) are custodians of the Plan (the “Custodians”). CBIZ Benefits and Insurance Service (“CBIZ”) provides record-keeping and administrative services for the Plan.

Participant Contributions: Each year, participants may contribute an amount up to 80% of their pretax annual compensation, as defined in the Plan, or the limits set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts received from any other retirement plan which satisfy the tax rules for rollovers.

Participants may designate a portion, or all, of their deferred contributions as Roth contributions, which are includable in the participant's gross income.

Employer Contributions: For each plan year, the Company will contribute to the Plan safe harbor matching contributions in an amount equal to 100% of the employee's compensation contributed to the Plan, but subject to a maximum of 6% of the employee's compensation contributed to the Plan. A participant must complete six months of service to be eligible to receive the matching contribution.

The Company may also make a discretionary employer matching contribution to the Plan in an amount equal to 100% of an employee's compensation contributed to the Plan, but subject to a maximum of 4% of a Participant's compensation. There were no discretionary employer matching contributions made for the year ended December 31, 2024.

Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts: Each participant’s account is credited with the participant’s contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting: Participants are immediately 100% vested in all employee contributions and safe harbor contributions, plus the investment earnings thereon. Discretionary employer matching contributions are subject to a vesting schedule based on the number of years of continuous service as follows:

Forfeited Accounts: Forfeited accounts may be used to pay administrative expenses and any remaining amounts can be used to reduce future employer contributions. There was no balance in the forfeiture account as of December 31, 2024 and 2023.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 and a maximum of the lesser of 50% of their vested account balance or \$50,000 minus the highest outstanding loan balance in the last 12 months. Notes receivable terms cannot exceed five years unless for the purchase of a primary residence. Loans are secured by the balances in the participants’ accounts and are supported by a promissory note. Loans will be issued at the prime rate plus 1%. Interest rates for outstanding loans currently range from 4.25% - 9.50%. Participants repay principal and interest through payroll deductions. If participants terminate employment or retire, the loan will be offset from their account. The offset loan amount will be considered a taxable distribution.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits: Benefits may be distributed to participants upon termination of employment by reason of retirement (65 years or older), disability, death, or other separation from service. Participants who terminate employment and have a vested account balance less than \$7,000 (\$5,000 prior to July 1, 2024) will receive a cash distribution. Participants who have an account balance in excess of \$7,000 (\$5,000 prior to July 1, 2024) may leave their funds investment in the Plan or may elect to receive their vested account balance as a lump sum payment.

A participant may also request a withdrawal upon attainment of age 59 ½, or upon demonstration by the participant to the Plan Administrator that the participant is suffering from a hardship, as defined in the Plan document. The hardship withdrawals are subject to a minimum of \$500 and may only be withdrawn from a participant's deferral contributions.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements and supplementary schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate a permitted transaction under the terms of the Plan. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

The variable annuity is an investment option that provides both guaranteed income at retirement with additional market growth opportunity based on the market performance of its underlying portfolio and it has no redemption restrictions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates: The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefit payments to participants are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Uncertain Tax Positions: GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate it at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4: TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended since the latest determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the unit value based on the net asset value ("NAV") of the underlying mutual fund at year end. The NAV, as provided by the fund manager, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined that the fund will sell the investment for an amount different from the reported NAV.

Variable Annuity: Variable Annuity is valued by Guardian using the quoted market price of the underlying investments less application Guardian asset charges. The underlying investments are in the Guardian Investor Variable B Series.

NOTE 6: FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7: INVESTMENT CONTRACT

The Voya Fixed Account is a fully benefit-responsive investment contract. Investment contracts held by a defined contribution plan are required to be reported at contract value, if fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to Voya Institutional Trust Company (“Voya”) under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90-days notice to Voya prior to redemption of the contract.

NOTE 7: INVESTMENT CONTRACT (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 8: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held primarily in pooled separate accounts and a guaranteed investment fund offered by Voya Retirement Insurance and Annuity Company as well as a variable annuity provided by Guardian and the Plan pays certain related fees. As Voya and Guardian are the Plan's custodians, they are considered to be exempt party-in-interest transactions. CBIZ is the third-party administrator. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments as they are paid through revenue sharing, rather than a direct payment.

NOTE 9: LATE REMITTANCES

As reported on Form 5500, Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions, certain employee contributions for the year ended December 31, 2024 were not remitted within the timeframe specified by the DOL's regulation, thus constituting nonexempt transactions as defined by ERISA. The aggregated late remittances amount to \$438 for the year ended December 31, 2024. The late remittances were corrected in February of 2025.

NOTE 10: SUBSEQUENT EVENTS

The date to which events occurring after December 31, 2024, the date of the most recent statement of financial position, have been evaluated for possible adjustment to the financial statements or disclosure is October 8, 2025, which is the date the financial statements were available to be issued.
