Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the year 2024 Financial Statements

We have performed audits of the financial statements of VPH Retirement Saving Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements (2024 Financial Statements).

(1) Description of the Plan

The following description of VPH Retirement Saving Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) *General*

The Plan is a defined contribution, cash or deferred profit sharing plan sponsored of VPH Motor, Corp. (the Company). Substantially all employees who have completed 90 days of services, in the Company are eligible to participate in the Plan as defined in the plan agreement. Participation in the Plan commences on the first day of each of the first, fourth, seventh and tenth months of the Plan year coinciding with or immediately following the completion of the above eligibility requirements. The Plan is designed and intended to be qualified under Section 1081.01(a) and (d) of the Internal Revenue Code of 2011 (the 2011 Code). The Plan was established on April 1, 2018 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective as of July 1, 2022, the plan was amended, among other things, to add VPH Sur, LLC, VPH Oeste LLC, VPH Este, LLC, F&I Agency, LLC as a participating employer, pursuant the Amendment signed on November 14, 2022.

(b) *The Separation*

On November 1, 2017, Penske Automotive Group Board of Directors (Triangle Dealers) made the sale and separation of VPH Motor, Corp. The separation and distribution of 401k was effective on or about April 1, 2018.

On March 27, 2018, the Triangle Dealers Group Retirement Plan Committee approved and sign an agreement in order to spin-off and create a new plan to the VPH Motor, Corp to provide for the transfer of assets and liabilities to the New Plan, for those VPH employees whose employment transferred in connection with the Separation, effective on or about April 1, 2018.

(c) *Participants' Contributions*

Each year participants may contribute an amount not to exceed the maximum deferral amount specified by the Puerto Rico tax law. Annual deferral limit under the 2011 Code is \$15,000 for tax years ended December 31, 2024 and 2023. Participants who have attained or will attain age 50 by the end of the Plan year and whose pre-tax contributions of up to 6,000 for the tax year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans. The employer contribution is determined on an annual basis. The Company contributions were up to 62.5% of the first 4% of base compensation that a participant contributes to the Plan. The matching Company contributions are invested proportionally as elected by participants. Contributions are subject to certain limitations.

(d) *Participants' Accounts*

Each participant's account as established in the plan is credited with the participant contribution and allocations of the Company contribution and plan earnings. The Company absorbs the Plan administrative expenses in excess of forfeited employer contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and an insurance investment contract as investment options for participants.

(e) *Vesting*

Participants are immediately vested in their pretax, after-tax and rollover contributions accounts plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. The Company matching contribution and actual earnings thereon vest in accordance with the following schedule:

(f) *Distributions of Accounts*

Prior to termination of employment with the Company, a participant with a financial hardship may request a distribution from his or her pre-tax contributions up to the lesser amount of his or her pre-tax contributions or the amount needed to alleviate his or her financial hardship. In addition, a participant who has attained age 59½ may request a distribution of the participant's pretax contribution account under the Plan.

(g) *Payment of Benefits*

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments over a period of years not to exceed the lifetime of the participant and his or her beneficiary or the purchase of a fixed annuity contract with payments over a period of time not exceeding the life expectancy of the Participant or his or her beneficiary. In case of termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(h) Forfeitures

Generally, when a participant terminates participation in the plan, the non-vested portion of the participant's account, as defined by the plan, represents forfeiture. Forfeitures are utilized to reduce the company matching contributions or future plan expenses.

(i) Administrative Expenses

All administrative expenses, to the extent not paid by the Company, are paid from the Plan's assets.

(2) Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are:

(a) Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation includes the plan's realized gains and losses on investments bought and sold as well as held during the year and the change in appreciation from one period to the next.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(3) Financial Information Certified by the Asset Custodian

The Plan Administrator has elected the method of annual reporting compliance as permitted by ERISA Section 103(a)(3)(C) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company (the trustee of the Plan).

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following table sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2024 and 2023.

Mutual Funds: Valued at the quoted net asset value (NAV) of shares held by the plan at year end.

Guaranteed investment contract: Valued at fair value based on contractual rates of interest and stated maturity dates. The fund is vested in guaranteed investments contract (GICs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Deposit Administration Contract with Insurance Company

In 2018, the plan entered into a fully benefit-responsive guaranteed investment contract with Universal Life Insurance Company (Universal). Universal maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the plan by Universal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract value of the investment contract as of December 31, 2024 was \$681,296. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the plan to transact at contract value with the Universal. Such events include the following (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the plan's normal operations; (4) the failure of the plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator believes that no events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuer, and that also would limit the ability of the plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the employer may determine.

(8) Tax Status

On May, 2023, the Puerto Rico Treasury Department (PR Treasury) issued a favorable determination letter confirming the qualified status of the Plan under Sections 1081.01 of the Puerto Rico Internal Revenue Code of the 2011 Code (as amended).

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the PR Treasury. As of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

(9) Delinquent Participant Contributions

During the year ended December 31, 2024, certain employee contributions were not remitted to Plan within the timeframe required by Department of Labor for the amount of \$42,983. As of the date of financial statements, the lost earnings of approximately \$11.23, is pending correction and have not been deposited by the plan sponsor. Employer has agreed to absorb any costs imposed on the Plan as a result of the untimely remittances of the participants' contributions.

(10) Risks and Uncertainties

The Plan invests in various securities, principally in mutual funds, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(11) Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date at which the financial statements were available to be issued and determined there are no other items to disclose.
