Independent Auditor's Report

To the Trustees of
Institute for Advanced Study Defined Contribution Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Institute for Advanced Study Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Institute for Advanced Study Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of Institute for Advanced Study Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective July 1, 1989, as restated January 1, 2022. The Plan covers all employees, excluding union, nonresident aliens, leased employees, part-time employees whose regularly scheduled service is less than 1,000 hours of service, and visiting professors of Institute for Advanced Study (the "Plan Sponsor" and "Plan Administrator"). Full-time employees shall become participants in the Plan immediately following attainment of age 21. Part-time employees shall become participants in the Plan upon satisfying the later of reaching age 21 or completion of 1,000 hours of accredited service within 12 consecutive months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Employer Contributions

As set forth in the Plan, the Plan Sponsor contributes a nonelective contribution to eligible participant accounts based on 9.5% of compensation, plus an additional 15% of such compensation in excess of the taxable wage base. All contributions are deposited with the Teachers Insurance and Annuity Association and the College Retirement Equities Fund ("TIAA and CREF," "TIAA" or the "Trustees").

Participant Accounts

Each participant's account is credited with an allocation of contributions made by the Plan Sponsor and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in employer contributions is done with a three-year cliff vesting schedule. Employees that leave the Plan before three years forfeit their contributions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment unless otherwise provided by the terms of the contracts.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,288 and \$17,019, respectively. These accounts will be used to reduce future employer contributions. During 2024, employer contributions were reduced by \$25,000, from forfeited nonvested accounts, in accordance with Plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments and are not readily determinable.

Subsequent Events

The Plan Sponsor evaluated events that occurred after December 31, 2024 through September 24, 2025, the date when the financial statements were available to be issued. Based on this evaluation, the Plan Sponsor has determined that no significant subsequent events require recognition or disclosure in these financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Pooled separate accounts: Units held in pooled separate accounts are valued based on the net asset value of the shares held by the Plan at year end, which is based on the unit prices quoted by the fund, representing the fair value of the underlying assets.

Group fixed annuity contracts: The TIAA Traditional Annuity investments are fixed annuity contracts that are fully and unconditionally guaranteed by the claims-paying ability of TIAA. Contributions to the TIAA Traditional Annuity are used to purchase a contractual or guaranteed amount of future benefits for participants. TIAA maintains the contributions in a general account. At the time the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The Plan has the following type of non-benefit responsive annuity contract: Retirement Annuity (“RA”). The RA TIAA Traditional Annuity holding has liquidity restrictions. The contract value of this holding equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Transactions in similar investment instruments are not observable. TIAA believes contract value provides a good approximation of fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Group fixed annuity contracts are invested in the general account of TIAA and CREF with guaranteed returns and are subject to claims of TIAA and CREF's general creditors. The general account is invested in corporate and government bonds, preferred stock, mortgage and asset backed securities, commercial mortgages, private equity, limited partnership fund investments, real estate investment trust common stock, other common stock, real estate and cash. Insurance regulations limit the proportion of investments that can be allocated to certain asset classes. Specifically, regulations limit holding of below-interest-grade bonds to 10% of the portfolio; emerging market debt to 4%; U.S. common stock and other non-preferred equity securities to 20%; and U.S. real estate to 20%. Regulations also require TIAA to maintain certain minimum amounts of capital. These capital requirements vary by the amount and type of risk. For instance, emerging market bonds, equities, and real estate require significantly higher capital than investment grade bonds.

(b) In accordance with FASB ASC 820, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

(c) This account seeks favorable long-term returns primarily through rental income and appreciation of real estate investments owned by the account. The account intends to invest between 75% and 85% of its assets directly in real estate or real estate-related investments. This account will invest the remaining portion of its assets in government and corporate debt securities, money market instruments and other cash equivalents, and, at times, stock of companies that do not primarily own or manage real estate.

4. Investments at Contract Value

The TIAA Traditional Annuity investments are fixed annuity contracts that are fully and unconditionally guaranteed by the claims-paying ability of TIAA. Contributions to the TIAA Traditional Annuity are used to purchase a contractual or guaranteed amount of future benefits for participants. TIAA maintains the contributions in a general account. At the time the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The Plan has the following types of fully benefit-responsive annuity contracts: Group Supplemental Retirement Annuity ("GSRA") and Stable Value Fund.

Because the GSRA and Stable Value Fund holdings are fully benefit-responsive, they are reported at contract value, which approximates fair value. Contract value, as reported to the Plan by the Trustees, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment account at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The credit rate of return for GSRA holdings was 4.50% and 5.25% for the years ending December 31, 2024 and 2023, respectively, and is based on a formula agreed upon with the issuer and the five-year Constant Maturity Treasury Rate, as reported by the Federal Reserve. TIAA Stable Value Fund is a guaranteed annuity product that credits interest at a net rate announced in advance of each semi-annual rate guarantee period beginning January 1 or July 1. The current rate of return is 2.69% through December 31, 2024.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with TIAA and CREF for investments in the GSRA and Stable Value Fund. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and CREF that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow TIAA and CREF to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustees, and therefore, these transactions qualify as party-in-interest transactions.

Investments in the group fixed annuity contract, pooled separate account, and registered investment companies are managed by the Trustees. These transactions qualify as party-in-interest transactions. Investment fees charged by TIAA and CREF are absorbed in investment income and amounted to \$222,295 for the year ended December 31, 2024. Revenue credits received by the Plan were \$33,184 for the year ended December 31, 2024. Administrative expenses incurred by the Plan were \$7,540 for the year ended December 31, 2024.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment. TIAA-CREF receives revenue from investment fund service providers for services TIAA-CREF provides to the funds. This revenue is used to offset certain amounts owed to TIAA-CREF for its administrative services to the Plan. If the revenue received by TIAA-CREF from such investment fund service providers exceeds the amount owed for its services, TIAA-CREF remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to TIAA-CREF for administrative expenses not covered by revenue sharing.

Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

6. Information Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, TIAA-CREF, the Trustees of the Plan, have certified the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Based on information provided and certified by the custodians, there are no fixed income obligations, leases or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan adopted a pre-approved plan offered by Teachers Insurance and Annuity Association and the College Retirement Equities Fund stating that the written form of the underlying specimen plan is qualified under Section 401 of the Internal Revenue Code ("IRC"). The pre-approved plan received an IRS opinion letter dated October 7, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan Sponsor offers an investment mix managed by TIAA-CREF to its participants in the Plan. In accordance with ASC 275 *Risks and Uncertainties*, the Plan Sponsor discloses certain investments based on participant choices that may accumulate to a significant percentage of total net assets concentrated at the end of the Plan year. As of December 31, 2024, two investments accounted for approximately 35.6%, CREF Stock and TIAA Traditional Non-Benefit Responsive Annuities at 14.0% and 21.6%, respectively. As of December 31, 2023, two investments accounted for approximately 36.8%, CREF Stock and TIAA Traditional Non-Benefit Responsive Annuities at 14.1%, and 22.7%, respectively.
