## Independent Auditors' Report

## 1. Description of Plan

The following description of the United Hebrew Geriatric Center Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a noncontributory defined contribution plan covering employees, as defined by the Plan document, of the United Hebrew Geriatric Center (the "Center" or "Employer"). United Hebrew Geriatric Center is the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan provides retirement benefits to all eligible employees for the following controlled group of employers:

- Azor Home Care, Inc.
- Will Gardens, Inc.
- Willow Towers Inc.
- United Hebrew Geriatric Center

All employees, except employees covered by a collective bargaining agreement, certain nonresident aliens and leased employees, who have completed one year of service with 12 consecutive months during which an employee has at least 1,000 hours of service and have attained the age of 21 are eligible to participate in the plan.

The Plan assets are held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan.

### ***Contributions***

Each year, the Employer may make a discretionary profit sharing contribution. The Employer contributed \$224,278 in 2024. Participants direct their investment of the Plan Employer's contributions. Participants may change their investment selections at any time. The Plan accepts rollovers and transfers from other qualified plans. To be eligible for the Employer's non-elective contributions, participants must complete one year of service and be employed on the last day of the Plan year. Participant deferrals are not permitted under the Plan.

### ***Participant Accounts***

Each participant's account is credited with allocations of (a) the Employer's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses or account balances, as defined in the Plan document.
