### Notes to Financial Statements

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Presentation***

The accompanying financial statements of Grote Enterprises, LLC Retirement Savings Plan have been prepared under the accrual basis of accounting principles generally accepted in the United States of America ("GAAP").

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

##### ***Notes Receivable from Participants***

For reporting purposes, participant loans are classified as notes receivable from participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### ***Related Party Transactions***

Certain Plan investments are shares in mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Grote Enterprises, LLC ("Plan Sponsor") provides administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by Grote Enterprises, LLC for the services to the Plan.

##### ***Estimates***

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements (Continued)

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Benefit Payments*

Benefit payments are recorded when paid.

##### *Subsequent Events*

In preparing its financial statements, Plan management has evaluated events subsequent to the balance sheet date through September 30, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of Grote Enterprises, LLC Retirement Savings Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all employees of Grote Enterprises, LLC, Cinfab, LLC, Design Build, Inc. dba Commercial HVAC, and the Thomas J. Dyer Company (individually "Company" and collectively the "Companies"). The Plan covers all non-union employees who are 18 years of age and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### *Contributions*

Participants may voluntarily make salary deferral contributions up to 60% of their pre-tax or post-tax compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. All employees of the Companies not covered under a collective bargaining agreement are eligible for participation in the Plan if they have completed at least one month of service and have attained the age of eighteen. Participants that do not complete a salary deferral agreement on or after 35 days of eligibility notice are automatically enrolled in the plan and have 3% of their eligible compensation withheld. Rehired employees will be automatically enrolled in the same manner as other employees.

## GROTE ENTERPRISES, LLC RETIREMENT SAVINGS PLAN

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Contributions (Continued)*

The Companies may elect to make a discretionary matching contribution each year of a discretionary percentage of a Participant's compensation or a discretionary dollar amount. The matching contribution is invested as directed by the Participant, in the same manner as elected for the participant's deferrals. In 2024, the Companies elected to make a matching contribution of 50% of employee deferrals up to 3% of compensation for all participants with deferrals during the plan year. The Companies may also elect to make a profit sharing contribution. Profit sharing contributions are allocated pro-rata based on the employee's compensation as a percentage of the total compensation. There was no profit-sharing contribution in 2024.

##### *Rollover Contributions*

Participants may roll over the taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### *Participant Accounts*

Each participant's account is credited with the participant's and Companies' contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the matching contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become vested over a five-year graded vesting schedule. A participant vests ratably beginning after one year of service with 100 percent vesting being attained after five years.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and may not exceed the lesser of \$50,000 or half of the participant's vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. Generally, notes receivable range in term from one to five years, except in the case of a note for the purpose of acquiring a primary residence.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Payment of Benefits***

Upon a participant's retirement, death, total and permanent disability, other termination of employment, or termination of the Plan, the participant's benefits are distributed either in the form of a single lump-sum amount equal to the value of the participant's vested interest in his or her account or rolled over into an IRA or another qualifying plan to avoid current taxation.

In conditions of "financial hardship," a participant may apply to the Plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

##### ***Forfeited Accounts***

The non-vested portion of terminated participant account balances can be used by the Plan sponsor to first reduce employer contributions and/or administrative expenses and then proportionally redistributed among participants. At December 31, 2024 and 2023 unallocated forfeitures contained in the Plan were \$51,594 and \$31,790, respectively. During 2024, forfeitures in the amount of \$13,250 were used to pay administrative expenses.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Applicable generally accepted accounting principles' accounting for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Notes to Financial Statements (Continued)

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Value at the net asset value ("NAV") of shares held by the Plan at year end.

*Money market fund:* Value at the net asset value ("NAV") of shares held by the Plan at year end.

*Self-directed brokerage accounts:* Accounts primarily consist of cash, ETFs, and common stocks that are valued on the basis of market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### NOTE 5 TAX STATUS

The Plan sponsor has adopted a volume submitter specimen plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the provider's prototype, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself had not received a determination letter from the IRS. The Plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income tax has been included in the Plan's financial statements.
