INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
WTS Paradigm Deferred Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of WTS Paradigm Deferred Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - WTS Paradigm Deferred Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024, through September 22, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - WTS Paradigm, LLC is the plan administrator, sponsor and employer. Fidelity Management Trust Company is the trustee of the plan that holds custody of the plan's investment assets. Fidelity Workplace Services LLC is the record keeper that maintains plan and participant records and tax counsel that performs various compliance tests. The two related entities are collectively referred to as "Fidelity". NFP Retirement Inc. is the plan's investment advisor.

Investments - The plan sponsor/employer determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily quoted market price as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trusts - Valued at their NAV based on units of the common/collective trusts. The common/collective trust investments are direct filing entities. The NAV, as certified by Fidelity, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trust will sell the investment for an amount different from the reported NAV.

Participant-directed brokerage accounts - The plan invests in participant-directed investments which consist of cash, common stocks and mutual funds that are valued at the closing price reported in the active market in which the individual securities are traded. Participant-directed investments held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as summarized below.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was established on March 1, 2006, as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan, with the exception of Limited Term Employees, immediately upon hire and can begin contributing upon completing the required enrollment documents.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferrals. Up until November 30, 2023, the plan included an auto-enrollment provision whereby new employees were automatically enrolled in the plan and had 3% of their compensation withheld as elective deferral contributions. In addition, participant deferral percentages automatically increased 1% each year until they reached a maximum of 6%. Such participants had the option to increase, decrease or stop the deferral by completing the necessary documentation. As of December 1, 2023, the plan was amended to update the auto-enrollment provision whereby new employees are automatically enrolled in the plan and have 8% of their compensation withheld as elective deferral contributions. Participants have 35 days to opt-out of the automatic enrollment provisions. The auto-increase provision was also amended to increase 1% each year until they reached a maximum of 8%.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The employer made discretionary matching contributions equal to 50% of the first 8% of eligible plan compensation in 2024 and 2023, funded coinciding with each payroll.
- d. Qualified nonelective contributions may be made at the employer's discretion. An employee must have worked at least 1,000 hours during the plan year and be employed as of the last day of the year to be eligible to receive qualified nonelective contributions. No such contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, and an allocation of the employer's contributions, if any. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants are fully vested at all times in their elective deferral and rollover contributions. For employer matching contributions, participants vest according to the following vesting schedule:

Payment of benefits - Benefit payments are recorded when paid and may commence upon termination of employment, death, disability or retirement. Distributions are made in the form of a single lump sum payment. In addition, hardship withdrawals are permitted under certain circumstances. In-service withdrawals can commence upon attaining the age of 59½.

Administrative expenses - Certain administrative fees of the plan are paid by the plan sponsor. Certain other administrative fees are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and loan fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeitures may be used to pay administrative fees of the plan or to reduce employer contributions. Forfeitures of \$0 and \$13,000 were used to reduce employer contributions in 2024 and 2023. Unapplied forfeitures were \$274,000 and \$159,000 as of December 31, 2024 and 2023.

Notes receivable from participants - Participants may obtain a loan from their accounts with approval of the plan administrator. Each participant may generally only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the total outstanding loan cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term generally cannot exceed five years unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through November 2033 with interest rates ranging from 5.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain of the plan's investments are managed by Fidelity. Fidelity is the trustee of the plan that holds custody of the plan's investment assets and therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to the trustee were \$69,000 and \$68,000 in 2024 and 2023. In addition, Fidelity receives indirect compensation from mutual fund service providers for services Fidelity provides to the funds. The compensation received by Fidelity is used to offset amounts that would otherwise be owed by the plan to Fidelity for administrative services provided.

Activity relates to notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a Fidelity pre-approved profit sharing plan with CODA that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

- b. Dividends and interest income from investments, net appreciation (depreciation) of investments and interest income on notes receivable from participants during 2024 and 2023;
- c. Purchases and sales of investments during 2024 and 2023; and
- d. Contributions to, investment income credited to, benefits paid from and transfers between investment accounts during 2024 and 2023.
