Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of Virtual Business Office Associates, Inc. 401(k) Plan (the "Plan") provides only general information. Participants may refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Virtual Business Office Associates, Inc. (the "Company"). The Plan provides retirement benefits to eligible employees of the Company. Eligibility to participate in the Plan is based on the employees attaining the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administrative Expenses

Certain administrative expenses paid by the Plan, including administrative fees relating to notes receivable, are charged to individual participants' accounts. All Plan expenses not paid by the Plan are paid by the Company.

Contributions

Participants may contribute up to all of their annual compensation as pre-tax or Roth contributions, as defined by the Plan document, subject to contribution limitations specified by applicable laws and regulations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions, up to the maximum annual amount permitted by statute. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

During the years ended December 31, 2024 and 2023, the Company made matching contributions equal to twenty-five percent of up to six percent of participants' eligible compensation (as defined by the Plan documents). Participants are eligible to receive matching contributions immediately upon entering the Plan. The Company also has the option to make discretionary profit sharing contributions, which are allocated to eligible individual participants' accounts based on the ratio that their compensation bears to the total compensation of all participants eligible for a share of the contribution. The Company made no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, matching contributions, discretionary profit sharing contributions, allocations of earnings and losses, and allocations of any administrative expenses paid by the Plan. Participants may elect to allocate contributions among a variety of fund options offered by the Plan.

Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferral contributions, plus actual earnings thereon. Vesting in employer matching and discretionary profit sharing contributions is based on years of continuous service. Participants become vested in employer contributions on a six-year graded vesting schedule, beginning with 20% after two years with an additional 20% in each subsequent year.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can only have one outstanding note receivable. The notes receivable are collateralized by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024. Rates are established on the date of the loan based on rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death, termination of employment, or attainment of age 59½, participants or their beneficiaries may elect to receive their vested portion of Plan assets in a single distribution or other distribution methods as allowed under the Plan. Upon termination of employment for reasons other than retirement, disability, or death, the participant's vested interest in the Plan will be paid to the participant as soon as administratively feasible upon participant request of a distribution.

Payment of Benefits (continued)

Any terminated participant account with a balance of less than \$1,000 is paid out in a single lump sum as soon as administratively feasible. If the participant's balance exceeds \$1,000 but is less than \$5,000, the participant's benefit must be distributed in a single lump sum or rolled over into another individual retirement account.

Forfeitures

In accordance with the Plan document, available forfeitures may be used to offset employer contributions or plan administrative expenses. Any remaining forfeited amounts are then reallocated back to active participants. Forfeitures of approximately \$44,000 and \$51,000 were used to reduce Plan expenses for the years ended December 31, 2024 and 2023, respectively. Unallocated forfeited accounts total approximately \$25,000 and \$34,000 as of December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. Basis of Presentation and Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Principal Guaranteed Option, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Principal Guaranteed Option is a fully benefit-responsive guaranteed interest contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed interest contract. The guaranteed interest contract is reported at contract value on the statements of net assets available for plan benefits. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

Risks and Uncertainties

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance, plus any accrued, but unpaid interest. If a participant does not make repayments and the Plan administrator considers the participant note receivable to be in default, the note receivable balance will become immediately due and payable, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents.

Payment of Benefits

Benefit payments are recorded when paid.

3. Certified Investments

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, the guaranteed interest contract, net appreciation in fair value of investments, and interest and dividends was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal and Principal Trust Company (the custodians of the Plan).

4. Fair Value Measurements

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

4. Fair Value Measurements (continued)

The Plan's mutual funds are valued using Level 1 inputs, which are based on quoted market prices of the shares held by the Plan.

The Plan's investments include collective trusts and a pooled separate account, which are valued at net asset value ("NAV") of units of the accounts. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts or pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the accounts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods used to measure fair values may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although Plan management believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

No determination letter has been received for the Plan as it is operated under a prototype plan document. The IRS issued an opinion letter for the prototype plan on June 20, 2020, stating that the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the prototype plan has been amended since the date of the letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest Transactions

The Plan holds investments in mutual funds and other investments that are managed by Principal. These transactions and notes receivable from participants qualify as party-in-interest transactions. Fees paid by the Plan to Principal for custodial, recordkeeping, and investment advisory services, net of forfeitures used, amounted to approximately \$83,000 and \$84,000 for the years ended December 31, 2024 and 2023, respectively.

Participant notes receivable amount to approximately \$162,000 and \$103,000 as of December 31, 2024 and 2023 and qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules as defined by ERISA.

7. Subsequent Events

Management evaluated events and transactions after December 31, 2024 through October 6, 2025, the date on which the financial statements were available to be issued, for subsequent events and determined there were no subsequent events to report.
