Opinion

We have audited the accompanying financial statements of Ignite - Fueling Innovation Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

Nature of the Plan

The following description of the Ignite - Fueling Innovation Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions. The Plan Sponsor is Ignite Fueling Innovation, Inc. (the “Company”), and the Plan Committee (the “Committee”) is the named fiduciary of the Plan as defined by the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Company established the Plan effective as of January 1, 2012. The Plan is designed to comply with Section 4975(e)(7) of the Internal Revenue Code (hereinafter referred to as the “Code”). In addition, in accordance with Section 54.4975-1 l(a)(5) of the Treasury Regulations, this Plan also forms a portion of the Plan that is a Stock Bonus Plan, which is intended to qualify under Section 401(a) of the Code. This Plan reflects the applicable provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”) and the guidance issued thereunder.

Eligibility

Employees of the Company are eligible to participate in the Plan immediately following the completion of one hour of service and the attainment of age twenty-one. All employees of the Company employed as of the effective date of the Plan were automatically eligible to participate in the Plan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each Plan year with an allocation of shares of the Company’s common stock released by the Trustee from the unallocated account and forfeitures of terminated participants’ non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s eligible compensation to all participants’ eligible compensation for that year.

Employer Contributions

The Company is obligated to make contributions into the Plan in such amounts as determined by the Board of Directors of the Company. Contributions may be made in cash, Company stock or a combination of both. Shares of the Company’s stock will be valued at their then fair value. The contribution for each year is allocated to each participant’s account based upon the ratio of the participant’s compensation to total compensation for the Plan year.

Vesting

The vesting of a participant's Plan benefit is based on years of service. A participant will complete a year of service for vesting purposes if he or she is credited with 1,000 hours of service during the Plan year. There is a graded scale for vesting based on years of service; a participant is 20 percent vested after two years and 100 percent vested after six years of service. Participants are automatically vested 100 percent if employment ends due to death, disability, or retirement.

Payment of Benefits

Distributions due to death, disability, or retirement are made as soon as administratively feasible following the participant's separation from service, beginning no later than one year after the close of the Plan year in which such an event occurs. Distributions are made in cash or, if a participant elects, in the form of Company common shares. Distributions are based on the value of the Company's stock as of December 31 of the Plan year coinciding with or immediately preceding the date of actual distribution of Plan benefits. Distributions may be paid in equal annual installments over a period of no more than five years or paid in a lump-sum amount at the determination of the Plan Committee.

Under the provisions of the Plan, the Company or the Trust are obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or subject to trading limitations. During 2024, the Trust repurchased 78,982 shares from participants at prices determined from the independent appraisal.

Put Option

Under federal income tax regulations, if the Company's stock that is held by the Plan and its participants is not readily tradable on an established market, or is subject to trading limitations, must include a put option. The put option is a right to demand that the Company or the Trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Notwithstanding the foregoing, participants and/or beneficiaries shall be entitled to direct the voting of any voting shares allocated to his or her Company stock accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation. In accordance with instructions from the Committee, the Trustee shall vote any unallocated shares held by the Trust as well as any allocated shares for which a participant has failed to give timely voting direction.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age fifty-five (55) with at least ten 10 years of participation in the Plan may elect to diversify a portion of their account.

Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

S Corporation Dividends

S Corporation dividends paid on allocated shares shall be allocated in the proportion that the cumulative number of shares in a participant's account as of the preceding anniversary date bears to the total cumulative shares of Company stock allocated to all participants as of that date.

Participant Accounts and Forfeitures

Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeiture of a non-vested interest shall occur in the fifth consecutive calendar year following a break in service. The forfeited accounts will be allocated amongst the accounts of active participants. Forfeitures of terminated, non-vested account balances totaling \$43,949 were allocated to remaining participants as of December 31, 2024.

Administrative Expenses

As provided in the Plan agreement, the Company shall pay all expenses in connection with the design, establishment, or termination of the Plan. The Trust shall pay all costs of administering the Plan and Trust, unless such expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.

Cash and Cash Equivalents

The Plan considers all highly liquid debt instruments purchased with a maturity date of three months or less to be cash equivalents.

Income Recognition

The common shares of the Company are valued at fair value. Dividend income is accrued on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on assets bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of Market Risk

The Plan's investments consist primarily of the Company's common stock. The common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Distribution of Benefits

Benefit payments to participants are recorded when paid.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Ignite Fueling Innovation, Inc. common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees, audit fees, and for annual valuation of the Company's common shares are paid by the Plan, unless such expenses are paid by the Company.

NOTE 4 - INVESTMENTS

The Plan's investments are held by the Trustee of the Plan. All investments are directed by the Plan administrator. The estimated fair value of the Plan's investments in Ignite Fueling Innovation, Inc. common shares as of December 31, 2024 and 2023 consisted of the following:

NOTE 5 - PLAN TERMINATION

The Company reserves the right to terminate the Plan in whole or in part in accordance with the Plan's provisions. Upon such termination of the Plan, the interest of each participant in the Trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Committee shall direct the Trustee to pay all liabilities and expenses of the Trust.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan's investments consist of the Company's common stock, which is exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. NOTE 7 - FAIR VALUE MEASUREMENTS

The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flows and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The valuation process involves the Trustee's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a report which plan management and the Trustee review in detail, discuss, and approve.

Money market accounts are valued at amortized cost which approximates fair value.

Mutual funds and exchange traded funds are valued at the closing price reported on the active market on which the individual securities are traded.

The Internal Revenue Service has determined and informed the Plan Sponsor, by a letter dated January 29, 2015, that the Plan is qualified and the Trust established under the Plan is tax-exempt under the appropriate sections of the Code. The Plan has been amended since receiving the determination letter, and the Sponsor believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities. The Sponsor has concluded that as of December 31, 2024 and 2023, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.
