Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ingo Money, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Transamerica Trust Company and Transamerica Life Insurance Company as of December 31, 2024 and for the period July 1, 2024 through December 31, 2024, and Reliance Trust Company as of December 31, 2023, and for the period January 1, 2024 through June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Note 1. Description of Plan

The following description of Ingo Money, Inc. 401(k) Plan (the plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a safe harbor defined contribution plan covering all full-time employees of Ingo Money, Inc. (the "Company") who are at least 18 years old and have completed three months of service. Eligible employees may enter the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may elect to defer a portion of their compensation and make a contribution to the Plan. Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participant catch-up contributions are permitted by the Plan and are matched by the Company. The Company makes matching contributions equal to 100% of the first 3% of the participant's compensation deferred plus 50% of the next 2% of compensation deferred. The Company may also make an optional profit sharing contribution, and none was made for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of Plan earnings (losses), and Company profit sharing contributions, and charged with an allocation of administrative expenses. Allocations are based on compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately 100% vested in their salary deferral contributions and, effective July 1, 2017, immediately 100% vested in any employer matching contributions plus actual earnings thereon. Vesting in any employer profit sharing contributions is based on years of service with the Company and a participant is fully vested in these contributions after three years of service.

Hardship distributions:

In the event of immediate and heavy financial need, participants may receive a distribution of up to 100% of their salary deferral, vested matching contributions and earnings, vested profit sharing contributions and earnings, as well as rollover account balances. In order to receive a hardship distribution, certain requirements and conditions must be satisfied.

INGO MONEY, INC. 401(k) PLAN**NOTES TO FINANCIAL STATEMENTS**

Note 1. Description of Plan (continued)

Forfeited accounts:

Forfeitures of nonvested balances resulting from termination of service are used to reduce employer contributions to the Plan. At December 31, 2024 and 2023, unallocated forfeitures/suspense totaled \$279 and \$195, respectively. No forfeitures were used during 2024.

Notes receivable from participants:

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested portion of their account balance. Generally, loans can be made for a period not exceeding five years; however, in certain circumstances, terms can be extended beyond five years, as defined by the Plan. Loans bear interest at a rate of 4.25 - 9.50%, and the interest rate is fixed for the life of the loan. Loans are secured by the balance in the participant's account. Loan payments are made via the participant's payroll withholdings and are deposited back to the current investment contribution source from which it was withdrawn.

Payment of benefits:

The vested value of a participant's account is payable in either a lump sum or annual installments upon termination of employment, retirement, death or disability. In-service withdrawals are also permitted, as defined by the Plan.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition:

The Plan's investments are stated at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Note 2. Significant Accounting Policies (continued)

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Related Party Transactions

Certain plan investments are mutual funds and the stable value fund managed by Transamerica Trust Company ("TTC"), Transamerica Life Insurance Company ("TLIC"), who acts on behalf of TTC, and Reliance Trust Company ("RTC"). TLIC, TTC, and RTC are the trustees/custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also paid fees to the recordkeeper, FuturePlan, LLC, which qualify as party-in-interest transactions. Total fees paid to these companies and their affiliates in 2024 was \$99,361. These party-in-interest transactions are exempt from the prohibited rules of ERISA.

Note 4. Information Prepared and Certified by the Trustees/Custodians

The following information was compiled from data certified by the trustees/custodians, TLIC, TTC, and RTC, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits - December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits - Year Ended December 31, 2024.
- C. Investment information included in Schedule of Assets Held at End of Year.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

Note 6. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Income Tax Status

The Plan has adopted the Ascensus, LLC prototype non-standardized profit sharing with cash or deferred arrangement plan document. The underlying profit sharing plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under the applicable sections of the IRC. Any employer adopting the form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.

Note 8. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Note 8. Fair Value Measurements (continued)

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 9. Stable Value Fund

The Plan has entered into a benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). Assets held in the Stable Value Fund are commingled with assets in the general account. The account is recorded at its contract value, which approximates fair value. The credited interest rate is backed by the income received from assets held in the general account and is 2.10% at December 31, 2024 (1.75% as of December 31, 2023). The Stable Value Fund has no stated maturity. Interest rates reset monthly as of the beginning of each month, during which a new interest rate is applied daily to the total outstanding balance of the investment.

The Stable Value Fund investment choice is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Transamerica. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, the Stable Value Fund may no longer be considered fully benefit-responsive.

The terms of the contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying Plan such as withdrawals for benefits, loans or transfers to other investment choices within the Plan. Since the Stable Value Fund investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable. The Stable Value Fund investment choice allows a participant reasonable access to their assets. There are no unfunded commitments, the redemption frequency is daily, and the redemption notice period is daily.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
