Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Plan Description

The following description of the Claims Conference 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of the Conference on Jewish Material Claims Against Germany, Inc. (the Company) who are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Empower Trust Company, LLC is the Plan's trustee. Empower Life & Annuity Insurance Company of New York is the Plan's recordkeeper.

Eligibility and Contributions

Employees who complete one month of service and have attained age 21 are eligible to participate in the Plan. The Plan permits participants to defer up to 100% of their annual compensation, subject to the maximum allowable under the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC limit.

A participant may, with the consent of the Plan administrator, make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from a qualified retirement plan in which employees participated prior to their employment by the Company.

The Company, at its discretion, may contribute a matching percentage of each eligible participant's deferral. Additionally, the Company may make a nonelective contribution that is allocated to participants equal to the percentage of a participant's compensation in relation to the compensation of all participants entitled to nonelective contributions. To be eligible for nonelective contributions, participants must either be employed on the last day of the Plan year or have been credited with at least 500 hours of service during the Plan year. The exact percentage, if any, is determined each year by the Company for both employer matching and nonelective contributions. During the years ended December 31, 2024 and 2023, the Company provided \$532,939 and \$448,173, respectively, in employer matching contributions. During the years ended December 31, 2024 and 2023, no nonelective contributions were declared or made by the Company.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, employer matching contributions, and allocations of the Company's nonelective contributions, if any. Each participant's account is also credited with an allocation of Plan earnings and charged with an allocation of Plan losses, withdrawals, and loan fees, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting

Participants are immediately vested in their elective contributions and rollovers, plus actual earnings thereon. Participants vest in their employer matching contributions and nonelective contributions, if any, after the completion of two years of service.

Forfeitures

Forfeitures occurring during a Plan year attributable to terminated participants may be used to reduce employer contributions or to pay administrative fees. There were \$45,497 and \$36,002 in forfeited non-vested accounts at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, no amounts in forfeited accounts were used.

Payment of Benefits

Upon separation of service, death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, the participant may withdraw his or her elective deferrals on account of financial hardship or if the participant attains age 59½ and continues to work.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loans are secured by the balance in the participant accounts, require approval of the Plan administrator, and bear interest equal to the prime rate at the time of loan origination. The interest rate on loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Loan repayments are made through payroll deductions in equal installments over a period that may not exceed 30 years for the purchase of a primary residence and five years for other loans, from the date the loan was made.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes to Financial Statements

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains or losses on those investments purchased and sold, as well as held, during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Nonelective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Benefit payments to participants and beneficiaries are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants represent participant notes that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments, the loan is deemed a distribution, based on the terms of the Plan document. The participant's loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

The administrative expenses of the Plan are paid by either the Plan or Company, as provided by the Plan document. For the years ended December 31, 2024 and 2023, participant loan origination fees, distribution processing fees, and recordkeeping fees were paid from the respective participant accounts. All other expenses of administering the Plan were paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Revenue Credits

The Plan's trust agreement provides for a participant revenue credit arrangement, whereby the trustee allocates deposits into the accounts of eligible participants who are invested in certain funds. There were no unallocated revenue credits at December 31, 2024 and 2023. During 2024 and 2023, the Plan received credits of approximately \$45,000 and \$34,000, respectively, which were used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statements of changes in net assets available for benefits.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the overall fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuities - Fixed annuities are valued based on the sum of all contributions and deposits plus interest credited less any distributions, transfers, and fees. Fair value is determined using a discounted cash flow model. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York, qualified institutions.

5. Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that were managed by the Plan trustee or its affiliates. Participant loan and distribution processing fees are paid to the recordkeeper by participants. The Plan also receives revenue credits from the recordkeeper as described in Note 2. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by The Retirement Plan Company LLC. The Retirement Plan Company LLC received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risk and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Subsequent Events

Subsequent events have been evaluated through October 6, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to or additional disclosure to the financial statements.


