### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the accompanying financial statements of Presbyterian Homes & Services Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion on the Financial Statements***

We do not express an opinion on the financial statements referred to above of Presbyterian Homes & Services Tax Deferred Annuity Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

As described in Note 6 to the financial statements, the Presbyterian Homes & Services Tax Deferred Annuity Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial statements referred to above.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Presbyterian Homes & Services Tax Deferred Annuity Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of Presbyterian Homes & Services Tax Deferred Annuity Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Presbyterian Homes & Services Tax Deferred Annuity Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Presbyterian Homes & Services, Inc. (the Employer) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 1987. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last restated June 26, 2019, with a retroactive effective date of January 1, 2010, as part of the remedial amendment period to adopt a volume submitter plan document. The Plan was last amended effective October 1, 2023 to add a Roth deferral option. The Plan covers all employees of the Employer. Employees are eligible to participate in the Plan immediately upon their date of hire.

**Contributions**

Participants may elect to make salary reduction contributions up to 100% of their compensation according to the Plan provisions. The Plan allows participants age 50 and older to make catch-up contributions. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Employee contributions, plus actual earnings thereon, are immediately 100% vested.

**Notes Receivable from Participants**

Notes receivable from participants are not permitted under the Plan.

**Benefit Payments**

Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in accordance with the following direction. A married participant who is vested shall receive benefits in the form of a joint and survivor annuity. An election other than joint and survivor annuity may be made only with the written consent of the participant's spouse. An unmarried participant who is vested shall receive benefits in the form of a life annuity. An election other than the life annuity needs to be made within 90 days prior to the date the annuity is to begin payments.

**Benefit Payments (Continued)**

In the event of a participant's death, the benefit will be paid to the participant's beneficiary not earlier than the first day of the month coinciding with or immediately following the participant's death. This benefit may be paid pursuant to one of the alternate forms of payment. If a participant terminates employment and the participant's account balance is not greater than \$7,000 (\$5,000 prior to January 1, 2024), the Plan administrator will authorize the benefit payment without the participant's consent. The Plan requires all mandatory distributions greater than \$1,000 to be rolled over into an individual retirement account. The Plan allows for in-service distributions if a participant reaches age 59½. The Plan allows hardship distributions subject to Plan provisions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Senior Leadership Team determines the Plan's valuation policies utilizing information provided by the investment advisor and the insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Employer pays certain administrative expenses on behalf of the Plan. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

American United Life Insurance Company (AUL) and Lincoln National Life Insurance Company (Lincoln), the qualified institutions of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of investments as of December 31, 2024 and 2023, and investment income for the years then ended, and the ERISA required supplemental schedule as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*Self-Directed Brokerage Accounts:* Primarily consists of mutual funds which are valued at the closing price reported in the active market in which the individual security is traded.

*Insurance Company General Accounts:* Investments in the insurance company general accounts are comprised of fixed interest accounts and are valued at fair value by the insurance companies by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plans have deposit contracts with AUL. AUL maintains the contributions in a fixed interest account, a stable value account and pooled separate accounts. The fixed interest account and the stable value account are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Due to the transfer restrictions within the contract, they are not deemed to be fully benefit-responsive and is valued at fair value which is deemed to approximate contract value by AUL. Certain participants hold individual annuity contracts with Lincoln National Life Insurance Company.

**NOTE 6 EXCLUDABLE CONTRACTS**

The Plan has certain annuity and custodial accounts with Waddell and Reed, Ameriprise, Capital Guardian Trust, Hartford 1, Hartford 2, and Nationwide issued to current and former employees prior to January 1, 2009. As permitted by the Department of Labor's Field Assistance Bulletin 2009-02, *Annual Reporting Requirements for 403(b) Plans*, these contracts are excluded from the investments in the statements of net assets available for benefits and the related investment income and distributions have been excluded from the statements of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions has not been determined.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 9 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated November 22, 2017, received from the Internal Revenue Service (IRS) on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal or state authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 PARTY-IN-INTEREST TRANSACTIONS**

The investments are managed by American United Life Insurance Company and Lincoln National Life Insurance Company, the insurance companies, and American Funds, a custodian. Therefore, these investment transactions qualify as party-in-interest.

**NOTE 11 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The Plan holds investments in a pooled separate account, as classified in the financial statements included herein. The pooled separate account did not file a Form 5500 for the direct filing entity, therefore, the underlying assets, which are deemed to be sub-accounts of the pooled separate account, have been reported on the Form 5500, Schedule H, as mutual funds.
