Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Creed 2.0 dba Creed Monarch 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that

agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN:

The following description of Creed 2.0 dba Creed Monarch 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto, for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution 401(k) profit sharing plan covering all persons who are eligible employees of Creed 2.0, LLC (collectively, the “Company”) and who have completed three consecutive months of service (or one year of service, if earlier) and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan management is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Contributions:

Each year, participants may contribute up to 100% of pre-tax annual eligible compensation and voluntary after-tax Roth 401(k) contributions to the Plan, limited to certain Internal Revenue Service (“IRS”) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution that can be made is \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan contains an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to not participate. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant.

The Plan provides a non-discretionary matching contribution not to exceed 100% of the first 3% of each employee’s wages contributed to the plan. In addition, each year the employer may make a discretionary profit sharing contribution. For the year ended December 31, 2024, the Company did not elect to make a discretionary profit sharing contribution. Contributions are subject to certain statutory limitations.

Employer and participants’ contributions can be invested at the participants’ direction into various mutual funds or collective investment fund.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):

Participant Accounts:

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations for the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions and any discretionary employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of participants' accounts is based on credited years of service, as defined by the Plan, according to the following schedule:

Participants are credited with prior completed years of service at Creed Monarch, Inc.

In the event of termination due to death, total and permanent disability or normal retirement, participants shall become 100% vested in the Company's discretionary profit-sharing portion of their account.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent determined at the first day of each quarter. The prime rate was 7.5% and 8.5% at December 31, 2024 and 2023, respectively. The term of a loan generally cannot exceed a period of five years, with the exception that the plan administrator may permit a longer repayment term for a loan used to purchase a principal residence. Principal and interest are paid ratably through monthly payroll deductions.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED):

Payment of Benefits:

Upon termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the plan administrator. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawal from a participant's pre-tax elective deferral account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Also, participants who are at least 59½ years of age may withdraw all or a portion of the balance of their account prior to termination for any reason.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-. Any forfeited non-vested profit sharing amounts can be applied to pay administrative expenses of the Plan or will be allocated as of the last day of the Plan year as an additional employer profit sharing contribution to participants as directed by the plan administrator. During 2024, no forfeiture account money was used to offset administrative expenses or as an additional employer profit sharing contribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The financial statements of the Plan have been prepared based on the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-Responsive Investment Contracts:

Fully benefit-responsive investment contracts held directly by the Plan or included in the underlying investment of collective investment fund in which the Plan holds an interest are presented at fair value. The collective investment fund holds guaranteed investment contracts ("GIC"), synthetic GICs, and cash and cash equivalents. All defined contribution retirement plan trusts invested in the collective investment fund have a proportionate undivided interest in all assets of the fund. The investment objective of the fund is stability of principal and high current income.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits:

Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of mutual funds.

Subsequent Events:

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED):

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in valuation methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Investments in mutual funds have been designated level 1 instruments.

Collective investment fund: The fair value of the Plan’s interest in the Federated Investors Capital Preservation Fund is based upon the net asset value (“NAV”) of such fund reflecting all investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund. The NAV is used as a practical expedient to estimate fair value. The fund seeks to maintain a stable value of \$10.00 per unit of participation; however, it cannot guarantee that the value per unit will always remain at \$10.00. Units of the fund may be redeemed for funding a bona fide benefit payment, honoring an employee directed transfer to another investment election that is a noncompeting investment, or paying administrative fees. Withdrawals for other purposes can be made from the fund generally only upon 12 months’ advance written notice. The fund’s investment objective is stability of principal and high current income by investing primarily in GICs, money market mutual funds, and other stable value products.

As of December 31, 2024 and 2023, there were no level 2 or 3 investments.

NOTE 4 - CERTIFICATION BY THE CUSTODIAN:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are shares in mutual funds managed by the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. The Plan allows participants to take loans against their vested account balances, which are also considered exempt party-in-interest transactions. The Plan sponsor pays directly any other fees related to the Plan's operation.

NOTE 6 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portions of their account.

NOTE 7 - TAX STATUS:

The volume submitter plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (the "IRS") has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
