Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Metalplate Galvanizing, L.P. Employee Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. Plan Description

The following description of the Metalplate Galvanizing, L.P. Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all eligible employees of Metalplate Galvanizing, L.P. (the Employer).

Employees are eligible to participate in the Plan after completing six months of service and 500 hours and attaining age 20.5. Credit is also given for service prior to the date the business was acquired by the Plan sponsor. Plan enrollment is on January 1, and July 1 of each plan year.

The Employer serves as the Plan administrator and Empower Annuity Insurance Company of America ("EAICA") and Empower Trust Company, LLC (the Custodian) serves as the Plan's custodian and recordkeeper. Thus, all investment transactions qualify as party-in-interest transactions.

The Consolidated Appropriations Act of 2023 was signed into law on December 29, 2022, which includes the Setting Every Community Up for Retirement Enhancement Act ("SECURE Act") 2.0. SECURE Act 2.0 contains over 90 new provisions related to retirement, with varying effective dates through 2027. As these provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there was no material impact on the Plan for these financial statements.

Contributions

Contributions to the Plan may consist of employee elective deferral contributions, employer matching contributions, and rollover contributions. The Plan provides for the Employer to match the employee's contributions up to a maximum of 3% of an employee's regular earnings and allows the employee to contribute up to 100% of regular earnings. Employee elective contributions for a participant may not exceed certain limitations set annually by the Internal Revenue Service (\$23,000 in the plan year ended December 31, 2024 and \$30,500 for participants age 50 and above).

Vesting

Participant contributions and rollover contributions become fully vested upon receipt. Each participant's employer contributions become fully vested upon normal retirement, disability, death and according to the following schedule for years of service:

Participant Accounts and Benefits

An account is maintained for each participant in the Plan. The accounts are credited with the participants' contributions and their allocated portion of the employer matching contributions and investment earnings. Distributions, withdrawals, and allocated expenses are subtracted from the account balances. Participants' vested account balances represent the benefits available to the participants upon retirement, disability, death, or termination from the Plan.

Termination

The Employer retains the right to amend or terminate the Plan at any time. No amendment may permit any plan assets to revert to the Employer or be used for any purpose other than to provide benefits to participants and their beneficiaries, reduce a participant's accrued benefit or eliminate an optional form of benefit payment. Upon termination of the Plan, all participant accounts would become fully vested and each participant would receive a distribution based on the current value of assets available for plan benefits at such time.

Forfeitures

Forfeitures may be applied to pay administrative expenses or to reduce employer contributions. The balance in the forfeiture account at December 31, 2024 and 2023 totaled \$11,309 and \$23,873, respectively. During 2024 and 2023, forfeitures totaling \$4,698 and \$10,985, respectively were used to reduce employer contributions. Additionally, \$11,250 in investment and advisory fees were paid using the forfeiture balance during the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan provides for separate investment programs which allow participants to direct their investment among different investment options. The Plan currently offers a fixed annuity and a selection of mutual funds. The Plan's fixed annuity is a fully benefit-responsive contract that is stated at contract value. The Plan investments in mutual funds are stated at fair value based on quoted market prices at the close of each business day.

Purchases and sales of investments are reflected as of the trade date. Gains or losses on the sale of investment securities are based on an average cost method. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date.

In all cases, valuations are based on the judgment of management after consideration of the above and other factors, including, but not limited to, original cost, operating results and financial condition of the portfolio investments. The valuations do not necessarily represent amounts which might ultimately be realized from the disposition of the investments.

Contributions

Contributions from employees are recorded in the period in which the Employer makes the deduction from the employees' payroll. Employer matching contributions are accrued in the plan year for which the corresponding employee deferrals were deducted.

2. Summary of Significant Accounting Policies

Basis of Financial Statements

The financial statements of the Plan are maintained on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Employer provides certain administrative and accounting services to the Plan at no cost and pays certain other administrative expenses on behalf of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

3. Investment Information

Fair Value Measurement

The Financial Accounting Standards Board's Accounting Standards Codification, ("ASC") Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 - Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 - Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Investments, at contract value
- Net appreciation/depreciation in fair value of investments
- All components of income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Fixed Annuity Contract

For the years ended December 31, 2024 and 2023, the Plan held an investment in the Key Guaranteed Portfolio Fund, a fixed annuity contract. The Fixed Account is an annuity contract for which contract value is guaranteed for participant transactions by Empower Annuity Insurance Company of America (“EAICA”). EAICA believes that contract value is an appropriate measurement for the Fixed Account. This fund meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Generally, the term “fully benefit-responsive” describes the contract’s guarantee that (1) the crediting rate provided under the contract will not fall below zero and (2) participant-initiated withdrawals from the fund will be covered at contract value.

The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. For the years ended December 31, 2024, and 2023, the average fund yields were 1.41% and 1.23%, respectively. The *actual* average yield earned by the Plan for the benefit responsive fund can be derived by averaging the Plan’s quarterly interest rates. For the years ended December 31, 2024, and 2023, the *actual* average plan yields were 1.41% and 1.23%, respectively.

Because the Fixed Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fixed Account. The Fixed Account is reported in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily.

Certain events may limit the Plan’s ability to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement of plan incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value.

The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

6. Income Tax Status

The Plan adopted a prototype plan document that is pre-approved by the Internal Revenue Service (IRS) as being designed in accordance with applicable sections of the Internal Revenue Code (IRC), by a letter dated June 30, 2020. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. The Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files income tax returns in the U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal, state and local or non-U.S. income tax examinations for years before 2021.

7. Exempt Party-in-Interest Transactions

Certain plan assets are mutual funds and fixed annuity contracts managed by Empower Annuity Insurance Company of America and Empower Trust Company. EAICA and Empower Trust Company are custodians of the Plan and therefore, these transactions qualify as party-in-interest transactions.

8. Reconciliation of Form 5500 to the Financial Statements
