Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Windels Marx Lane & Mittendorf, LLP Retirement Plan & Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Windels Marx Lane & Mittendorf, LLP Retirement Plan & Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule of Assets (Held at End of Year) for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used

to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

1. Description of the Plan

General

The following description of the Windels Marx Lane & Mittendorf, LLP (the “Company”) Retirement Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan was effective January 1, 1979, restated most recently effective January 1, 2023, and is a defined contribution plan covering partners and substantially all non-legal staff full time employees of the Company, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Internal Revenue Code of 1986, as amended.

Eligibility

The provisions of the Plan provide that, in general, any person employed by the Company on a full time basis as an employee, other than an associate attorney or special counsel on the legal staff, will be eligible to participate in the Plan. However, leased employees are not eligible to participate in the Plan. Eligible employees may begin participation in the Plan after completion of six months of eligibility service and their attainment of age 21. Eligibility service is defined as the employee having completed at least 500 hours of service within the six month period following the employee’s commencement of employment. Once participation commences, a participant must be credited with at least 501 hours of service and be employed on the last day of the Plan year.

Contributions

For each Plan year, the Company shall contribute to the Plan in respect of each eligible participant an amount equal to the sum of (i) and (ii):

- (i) 5.5% of their compensation for such Plan year up to the social security taxable wage base for such year;
- (ii) 11.0% of their compensation for such Plan year in excess of the social security taxable wage base for such year.

The Company takes into consideration the contributions it makes to the Social Security system on participants’ behalf when determining the amount of the contribution it makes to the Plan.

Compensation, for Plan purposes, includes earned income as a partner of the Company or salary, including overtime and bonus, as an employee. Compensation also reflects the cash value of certain fringe benefits provided by the Company.

Participant Accounts

Each participant's account is credited with the Company's contribution, Plan earnings (loss), and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting

Participants are vested in the Company's contributions both funded and accrued plus actual earnings thereon based on years of continuous service. A participant is 100% vested after three years of credited service or after attainment of one of the accelerated vesting events, which consists of age 65, death or disability.

Forfeitures

Forfeitures of nonvested Company contributions are used to fund future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,847 and \$47,297, respectively. The plan administrator applied \$4,945 of forfeitures in 2025 to reduce the Company's 2024 contribution.

Investment Options

Upon enrollment in the Plan, participants are offered a variety of investment options in a selection of mutual funds and common/collective trust funds.

The selection of mutual funds and common/collective trust funds offered range from fixed-income, equity, money market, and a blend of fixed-income and equity portfolios. The selection of investment options are made at the direction of the participant.

In-Service Withdrawals

In general, participants can receive in-service withdrawals from all contribution accounts, once they have reached age 62. The minimum withdrawal is \$1,000 and may not exceed their vested account balance.

Benefit Payments

Participants are required to annual payment of benefits beginning no later than April 1st of the calendar year following the year in which the participant reaches age 73 (or age 70 ½ if you were born before July 1, 1951) or retire, whichever is later, based on the value of the participant's vested interest in their account. Employees may elect to receive the value of their accumulated Plan benefits as a lump-sum distribution or a 50% qualified joint and survivor annuity upon retirement or termination. If employees terminate before rendering three years of service, they forfeit the right to receive their accumulated Plan benefits. Employees will receive the value of their accumulated Plan benefits as a lump-sum distribution upon retirement or termination if the value of their account is less than \$1,000.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements, and reported amounts of changes in net assets during the period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value as of the end of the year. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for information related to the Plan’s valuation methodologies. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. For detailed information on each fund’s investments and concentrations of credit risk, the prospectus and the Annual Report are available from T. Rowe Price Trust Company.

Payment of Benefits

Benefits are recorded when paid.

Professional Fees

The legal, accounting and audit fees have been absorbed by the Company.

3. Fair Value Measurements

The Plan's investments are stated at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities exchanged in active markets.
- Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets.
- Level 3 inputs are significant and unobservable.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Information Certified by the Plan's Trustee

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by the Trustee, which included total investments as of December 31, 2024 and 2023, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, line 4i-schedule of assets (held at end of year).

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$4,522,180.

During 2024, the Plan earned \$1,547,341 in dividends.

5. Related Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan investments in the self-directed brokerage fund are managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Transactions with parties-in-interest also include fees paid during the year for trustee, accounting, and other services, as well as contributions paid to the Plan by the Company and loans made to participants. All of these transactions are exempted from prohibited transaction rules under ERISA.

T. Rowe Price Trust Company is the trustee as defined by the Plan and is responsible for the safekeeping of the Plan's trust fund. The Company has an Employee Benefits Committee of the Plan which acts for the Plan administrator. T. Rowe Price Retirement Plan Services Inc. is the recordkeeper.

Fees treated as paid by the Plan for the trustee services, asset fees and administrative fees amounted to \$56,832 for the year ended December 31, 2024.

6. Plan Termination

Although the Plan sponsor has not expressed any interest to terminate the Plan, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Upon termination or partial termination of the Plan, the amount credited to the account of each affected Participant shall become fully vested, and shall not thereafter be subject to forfeit.
- b. Upon any such termination all assets remaining in the Trust Fund, after payment of any expenses shall be distributed to the Participants in accordance with the value of such Participants' accounts as of the date of such termination.

7. Tax Status

The Plan was amended and restated based on a prototype plan of T. Rowe Price Retirement Plan Services, Inc., which has received a determination letter from the Internal Revenue Service dated August 19, 2020 stating that the Plan is qualified under section 401(a) of the Code and, therefore, the related trust is exempt from taxation. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Other Income

The Plan received Revenue Sharing Income, net of miscellaneous expenses, in the amount of \$17,048 which is a refund of certain fees from various mutual funds for the year ended December 31, 2024.

9. Reclassifications

Certain balances in the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year financial statements. These reclassifications have not had any impact on net income.

10. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. Reconciliation of Financial Statements to Form 5500
