Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

**Note 1 – Description of Plan**

The following description of One Off Hospitality Group, Ltd. 401(k) Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution and 401(k) plan covering eligible employees of One Off Hospitality Group, Ltd., Prestige Restaurant, Inc. (d/b/a Blackbird), Terroir Restaurant, Inc. (d/b/a Avec), 845 W. Fulton, LLC (d/b/a Publican), 825 W. Fulton, LLC (d/b/a Publican Quality Meats), Pontiac Produce Company, Inc. (d/b/a Big Star), 1520 N. Damen, Inc. (d/b/a Violet Hour), 21 E. Bellevue Management, LLC (d/b/a Nico), 1543 N. Damen LLC (d/b/a Dove's Luncheonette), 1576 North Milwaukee, LLC (d/b/a Publican Anker), Air Publican Corp, Big Star Wrigley Field, Inc. (d/b/a Big Star II), 151 W. Erie, LLC (d/b/a Pacific Standard Time), and Laurel Room, LLC (collectively, "the Company") under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement described in section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company are subject to the following eligibility requirements:

- Age: 21
- Service: One year of Service and 1000 hours
- Status Exclusions:
  - a. Employees who are members of a specific union
  - b. Non-resident aliens with no U.S. earned income

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the Plan year and 7<sup>th</sup> month of the Plan year. Effective September 26, 2024, employees may participate in the Plan immediately upon eligibility.

**Contributions**

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

**Contributions** (Continued)

The following contribution types are allowed by the Plan:

- Elective deferrals
- Safe harbor matching contributions
- Discretionary employer matching
- Non-elective contributions
- Rollover contributions

The Company has elected to operate the Plan as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. The Company makes a safe harbor matching contribution of 100% of the participant's deferral up to 3% plus 50% of deferrals from the next 2% of compensation. The Company made and accrued safe harbor matching contributions of \$179,145 to the Plan for the year ending December 31, 2024.

The Company discretionary matching is allocated based on a percentage of the participant's contribution up to 4% eligible compensation for the plan year, as defined by the Plan. The Company's non-elective contributions is allocated as of last day of the plan year and is based on ratio of each eligible participant's compensation to total compensation for all eligible participants.

The Company made no discretionary matching or non-elective contributions to the Plan for the year ending December 31, 2024. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, safe harbor contributions, and actual earnings thereon. The portion of the participants' account attributable to the Company's discretionary matching and nonelective contributions becomes 20% vested after two years of service and continues to vest at the rate of 20% for each successive year until 100% vested after six years of service. In the event of death or disability, participants become fully vested.

Participants are always 100% vested in their safe harbor matching contributions. The following schedule is only applicable if the Company makes discretionary matching contributions and nonelective contributions.

**Forfeited Accounts**

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used as follows:

- Pay administrative expenses
- Reallocated as Company contributions

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,975 and \$20,244, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$24,191 were used to reduce Company contributions.

**Investment Options**

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

**Benefits Paid to Participants**

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- Termination partial withdrawal
- Involuntary cash-outs
- Emergency personal expense
- Rollover source withdrawal at any time
- In-service

**Plan Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

**Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Plan recognizes employee contributions and the related employer matching contributions in the period in which the related employee contribution is withheld.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Collective Trust Funds

Common collective trust funds are valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by the custodian of the underlying investments, comprises the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 – Fully Benefit-Responsive Investment Contract**

The Plan holds a fully benefit-responsive investment contract with EAIC through the Empower Investments Fixed Account ("EIFA") which is reported at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

EAIC maintains the contributions in its general account. EAIC guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rating is updated quarterly based upon contract provisions. EAIC's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan)
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**Note 6 – Related Party and Party-in-Interest Transactions**

Plan investments are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

**Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 – Tax Status**

The Plan Sponsor adopted a plan, which received a favorable opinion letter issued to the document provider from the Internal Revenue Service dated June 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**Note 9 - Prohibited Transactions**

The Plan Sponsor failed to deposit participant contributions within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplemental information. The Plan Sponsor corrected the deficiencies related to the years 2019 through 2022 and 2024, during 2025. Of the late remittances identified for 2023, \$31,341 of the \$38,395 late remittances were corrected in 2025, and the Plan Sponsor intends to correct the remaining balance during 2025.

**Note 10 - Plan Amendment**

Effective September 26, 2024, the Plan was amended to update the entry dates of Plan participation to “immediate” for all types of contributions. Significant provisions of the amended plan document are consistent with those of the current plan document Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

**Note 11 – Subsequent Events**

Plan management has evaluated subsequent events through October 3, 2025, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, other than as disclosed below, have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.

Effective January 1, 2025, the Plan was amended to change the service requirement for eligibility to participate in the Plan. Under the previous provision, employees were required to complete 1,000 hours of service within a 12-month period to become eligible. Beginning January 1, 2025, employees are eligible to participate in the Plan upon completion of 500 hours of service within a 6-month period (not to exceed 1,000 hours or 12 months).

Effective May 7, 2025, the Plan was amended to (1) allow Roth deferrals, (2) include participant catch-up contributions in the definition of employee contributions eligible for employer discretionary matching contributions, (3) allow hardship withdrawals and in-service withdrawals upon attainment of age 59½, (4) and clarify that in-plan Roth rollovers and transfers are not permitted.
