We have performed audits of the financial statements of National Cattlemen's Beef Association Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

#### **NOTE 1 - DESCRIPTION OF THE PLAN AND SIGNIFICANT ACCOUNTING POLICIES**

The following description of National Cattlemen's Beef Association Savings Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan established May 1, 1985. The Plan is available to all employees of the National Cattlemen's Beef Association (the "Association") who have attained the age of 21 years or older on the first day following the month they were hired, except part time and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by an individual appointed by the Association with oversight by a Board of Trustees. The Plan Administrator is responsible for filing all required reports of the Plan. The Association serves as trustee and manages the Plan's assets.

##### ***Contributions***

Participants may elect salary deferral contributions of up to 75% of their eligible compensation, in accordance with Internal Revenue Service ("IRS") regulations. Catch up contributions are allowed. The maximum percentage may be reduced by the Plan's administration in certain circumstances. Participant contributions to the Plan are made through regular payroll deductions. Participants may also contribute rollover contributions from other qualified plans, and participants may make after tax Roth contributions.

Effective January 1, 2016, the matching contribution on employee deferrals is 100% of employee deferrals, not to exceed 8% of compensation, or, effectively, an 8% employer match.

Effective January 1, 2020, the Plan updated the Automatic Contribution Agreement ("ACA") with Automatic Escalation Feature to reflect that eligible employee hired or participating before January 1, 2020 who are contributing below the 8% initial default deferral percentage will be automatically increased to 8% unless changed by the participant.

##### ***Participants' Accounts***

Each participant's account is credited or charged with the participant's contributions, rollover contributions and withdrawals, as applicable, the participant's share of the Association's discretionary matching contributions, plan earnings or losses thereon, and plan expenses. Plan earnings or losses are allocated pro rata within each investment on a daily basis based on the participant's account balance. The benefits to which participants are entitled are the vested portion of their account.

##### ***Vesting***

Participants are 100% vested in their voluntary contributions and allocated earnings or losses thereon.

Any employer matching contributions (including forfeitures) and the earnings or losses thereon are not fully vested when contributed and will vest as follows:

A participant's account becomes 100% vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or if the Plan is terminated.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the amount of the largest loan outstanding at any time during the prior 12 months) or 50% of the participant's vested account balance. The loans are secured by the vested balance in the participant's account, and at December 31, 2024 bear interest at rates between 4.25% and 9.50%, which is commensurate with local prevailing rates at loan origination, as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions and becomes due and payable at various times between January 2025 and April 2053. Loans used to acquire real estate that serves as the participant's primary residence may be repaid over a period of up to 30 years. Participants may only have one plan loan outstanding. Delinquent receivables are recorded as a distribution based upon the terms of the Plan document.

#### ***Payments of Benefits***

Upon termination of service, death, disability, or retirement, a participant will receive a lump-sum payment or equal installments in the amount equal to the participant's vested account balance within a reasonable period of time after termination of employment. Participants may not make withdrawals from their accounts prior to retirement at age 65, except in the event of disability, death, termination of employment, or notice of hardship, without being subject to certain restrictions and penalties. If the balance in the participant's account does not exceed \$1,000, the participant's vested account balance may be automatically distributed. Benefits are recorded as distributions to participants when paid. The Plan allows in-service distributions for participants who have reached the age of 59½ years old.

#### ***Forfeitures***

If, at the time of termination of employment, the participant is not 100% vested, the non-vested portion ("forfeitures") of the participant's account shall be placed in a separate account. A forfeiture will occur as of the earlier of the last day of the Plan year in which the former participant incurs five consecutive one year breaks in service or the distribution of the entire vested portion of the participant's account. Participant forfeitures may be used to reduce the Association's matching contributions or pay plan expenses. Forfeitures used to reduce the Association's matching contribution were \$75,246 for the year ended December 31, 2024. There were \$46 and \$22,753 of unallocated forfeitures available to offset future matching contributions at December 31, 2024 and 2023, respectively.

***Valuation of Investments and Income Recognition***

Plan investments are comprised of mutual funds and a common/collective trust. Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 2).

The Plan held investments in fully benefit responsive investment contracts through its investment in guaranteed interest accounts held within the common/collective trust. Investment contracts held by a defined contribution plan are required to be reported at fair value. As required by accounting standards, the statements of net assets available for benefits present the fair value of the investment.

The net investments' gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Net appreciation and depreciation in fair value of investments includes realized and unrealized gains and losses. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recognized based on the type of investment. Interest income is recorded on the accrual basis.

***Risks and Uncertainties***

The Plan provides for various investments in mutual funds and a common/collective trust. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Additionally, some investments held by mutual funds are invested in the securities of foreign companies, which involves special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

***Use of Estimates and Basis of Presentation***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

The accompanying financial statements are prepared on the accrual method of accounting.

***Subsequent Events***

The Association has evaluated all subsequent events through October 6, 2025, which is the date the financial statements were available to be issued. No subsequent events noted.

**NOTE 2 - FAIR VALUE ACCOUNTING**

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Assets in this class are generally valued using market value.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The valuation technique used to measure fair value of the mutual funds was the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation technique used to measure fair value of the common/collective trust was based on the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There were no changes to the valuation techniques used during the year ended December 31, 2024.

***Reported Net Asset Values***

The common/collect trust fair value as of December 31, 2024 and 2023 is \$1,491,516 and \$2,128,929, respectively, with no unfunded commitment. Trust units may be redeemed on a daily basis. Under the terms of the Declaration of Trust, retirement plans invested in the trust are required to provide either 12 or 30 months advance written notice to the trustee prior to redemption of trust units.

The investments seek to maximize current income consistent with the maintenance of principal and to provide for withdrawals for certain participant-initiated transactions under a retirement plan without penalty or adjustment. The funds invest in guaranteed investment contracts issued by insurance companies; investment contracts issued by banks; structured or synthetic investment contracts (“SIC”) issued by banks, insurance companies, and other issuers, as well as the securities supporting SICs; separate account contracts; and other similar instruments.

**NOTE 3 - INCOME TAXES**

On January 31, 2006, the IRS issued a determination letter and indicated that the prototype plan fulfilled the requirements of a qualified plan and that the trust, which forms a part of the Plan, is not subject to tax. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**NOTE 4 - ASSETS CERTIFIED BY CUSTODIAN**

T. Rowe Price Trust Company held the Plan's investment assets and executed investment transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024. T. Rowe Price Trust Company has certified in writing to the Plan Administrator that the stated amounts for investments at fair value and participant loans at amortized costs and the income earned for the periods described above as reflected in the accompanying financial statements and the supplemental schedule are complete and accurate.

The Plan Administrator has elected as of December 31, 2024 and 2023 the method of compliance as permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the information certified by the trustee, except for comparing the information contained therein to information included in the financial statements.

**NOTE 5 - ADMINISTRATION OF THE PLAN**

Certain fees are charged to participants relating to loan set up, distribution, and maintenance costs. All other expenses incurred in the administration of the Plan are paid by the Association.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Association has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants become 100% vested, and the Plan Administrator is to distribute each participant's interest to the participant or their beneficiary.

**NOTE 7 - RELATED-PARTY TRANSACTIONS**

Certain plan investments are managed by T. Rowe Price. Therefore, these transactions qualify as party-in-interest, which are exempt from the prohibited transaction rules.
