NOTE 1 - DESCRIPTION OF PLAN

The following description of the Hickman’s Egg Ranch, Inc. 401(K) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan for all eligible employees of Hickman’s Egg Ranch, Inc. (the “Company”). Employees of the Company are eligible to participate in the salary deferral, employer safe harbor matching and employer matching components of the Plan upon completing three months of service with the Company and attaining the age of 21. Employees of the Company are eligible to participate in employer nonelective contributions if they meet the preceding requirements, have achieved 500 hours of service during the Plan year and are employed on the last day of the Plan year.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(K) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(K) or Roth contributions to the Plan. Effective May 5, 2022, the Plan was amended to remove the Roth component. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes a safe harbor matching contribution of 100% of the participant's contribution up to 4% of the participant's eligible plan compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, any Company contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, safe harbor contributions, and employer contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only residential loans may be made with specified financial necessity. Loan terms can be no longer than 15 years. Notes are secured by the balance in the participant's account and bear interest at the prime rate (7.5% at December 31, 2024) as of the date the note is executed, plus 1%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or partial payments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the plan administrator may authorize the benefit payment without the participant's consent. If the balance in the participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures

Forfeited non-vested accounts may be used to reduce administrative expenses and to reduce future Company contributions. Forfeited non-vested accounts as of December 31, 2024 and 2023 totaled \$40,320 and \$38,374, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The process of preparing financial statements in conformity with generally accepted accounting principles in the United States of America ("U.S. GAAP") requires the use of estimates regarding certain types of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Investments Valuation and Income Recognition

The Plan’s investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair values of mutual funds and money market funds are based on quoted net asset values of the shares held by the Plan at year-end. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses

Administrative expenses of the Plan may be paid directly by the Company or from the assets of the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. The expenses that are paid from Plan assets will either be shared by all participants or charged directly to the account of the participant on whose sole behalf the expense is incurred.

Subsequent Events

Subsequent events have been evaluated through September 23, 2025, the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS

Voya Institutional Trust Company and Voya Retirement Insurance and Annuity Company (VRIAC) (collectively "Voya"), the trustee of the Plan, has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya, the trustee as defined by the Plan, and, therefore, the investment transactions qualify as party-in-interest transactions. As described in Note 2, the Plan has arrangements with service providers for investment advisory, custodial, and recordkeeping services. Some of the fees charged by these service providers are paid by the Plan and allocated to participant accounts, while others are paid through revenue sharing and allocated to participants as part of appreciation/depreciation on investments. These transactions are party-in-interest transactions under ERISA.

NOTE 5 – TERMINATION OF PLAN AND RELATED TRUST

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan and related trust, subject to the provisions of ERISA. In the event of Plan termination, the amount of each participant's or beneficiary's account as of the date of such termination would become 100% vested and non-forfeitable in the employer matching contributions, plus actual earnings thereon.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – INCOME TAX STATUS

The Plan Sponsor has adopted a pre-approved plan provided by VRIAC. VRIAC obtained an opinion letter dated June 30, 2020 from the IRS pursuant to a requirement to restate pre-approved plan documents every six years in order to maintain the Plan's tax-qualified status. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE 8 – INVESTMENT FAIR VALUE MEASUREMENT

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 9 – GROUP ANNUITY CONTRACT

The Plan participates in the Voya Fixed Account. The contract is an insurance company issued general account backed group annuity contract. There are no specific securities in the general account that back the investment in this account.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants generally may withdraw assets from the Voya Fixed Account subject to certain equity wash and percentage limitation provisions. Currently, the Plan does not offer any competing investments options (as defined by VRIAC), so the equity wash provisions do not apply. VRIAC currently permits participants to transfer up to 100% of their account balance invested in the Voya Fixed Account to another investment option. VRIAC may also impose a market value adjustment at the contract level in the event of a full contract discontinuance or a partial contract discontinuance.

NOTE 9 – GROUP ANNUITY CONTRACT (continued)

The contract is a group annuity insurance product issued by VRIAC and is backed by the full faith and creditworthiness of the issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Deposits made to the contract are deposited in VRIAC's general account. Payment obligations under the contract represent an insurance claim supported by all general account assets. The contract does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Expenses related to the contract are calculated by VRIAC and incorporated into the contract's crediting rate. Past interest rates are not indicative of future interest rates.

The Voya Fixed Account has a portfolio investment rate design in which all deposits are credited with the same interest rate on a daily basis, and with no set maturity. The investment has a contractual minimum guaranteed interest rate for the life of the contract of 1.0%, and a declared interest rate that may be changed at any time, but will never be lower than the minimum guaranteed interest rate. The crediting interest rate for the investment contract as of December 31, 2024 was 1.5%.
