**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of Yale University Tax-Deferred 403(b) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to July 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter - supplemental schedules required by ERISA**

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2024, and the schedule of assets (held at end of year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

**NOTES TO FINANCIAL STATEMENTS**

---

**1. Description of Plan**

The following description of the Yale University Tax-Deferred 403(b) Savings Plan (the “Plan”) provides only general information. Plan participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering eligible employees of Yale University (the “university” or “Plan Administrator”) who have completed at least one hour of employment. Eligible employees (“participants”) include those employees receiving eligible compensation and not participating in another defined contribution plan sponsored by the university. Eligible compensation generally includes basic earnings and excludes other forms of additional or supplemental earnings, as described in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan utilizes Teachers Insurance and Annuity Association of America (“TIAA”) as its record-keeper. Both TIAA and College Retirement Equities Fund (“CREF”) serve as custodians of the Plan’s investment assets.

Contributions

Participants may elect to contribute up to 75 percent of eligible compensation as a percentage, flat dollar, or IRS maximum election, as defined by the Plan. Contributions are subject to limitations as defined by the Internal Revenue Code (“IRC”). There are no university contributions.

Participants direct the investment of their contributions into the various investment options offered by the Plan. The Plan offers registered investment companies, insurance company general account contracts, a pooled separate real estate account, and a self-directed brokerage account. Effective July 1, 2015, participants can elect to have their contributions made to the Plan on a Roth 403(b) after-tax basis as an alternative to pre-tax contributions. It is the participant’s responsibility to designate the investment fund(s) where their contributions should be directed. In the event a participant fails to direct the investment of his or her Plan contributions, participant’s contributions are automatically invested in a model portfolio selected for each participant by the Yale Target-Date Plus Service, a “qualified default investment alternative” as described by ERISA, will remain in effect until superseded by a subsequent election by the participant. Participants may change elections with regard to future Plan contributions and may reallocate the balance of his or her account among investment funds and contracts at any time.

Participants may also contribute amounts representing eligible rollover distributions as defined by the IRC. Deposits of such rollover distribution amounts are subject to the provisions of the Plan document.

Participant Accounts

Separate accounts are established for each participant. The current value of a participant's account includes all Plan contributions and Plan earnings or losses, withdrawals (if applicable), and an allocation of Plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is immediately vested in 100 percent of their contribution and the earnings of their account.

Plan Loans and Participant Loans

Loans were available to participants through TIAA, subject to certain limitations, through November 15, 2018. Plan loans were issued directly from the funds owned by TIAA and loan amounts were not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity Contract account balance was reserved, or held in collateral, to cover 110 percent of the outstanding loan amount for the period of time the loan is outstanding. Investments underlying defaulted loan balances are included in the Statements of Net Assets Available for Benefits until a distribution event occurs.

Plan loans of approximately \$492 thousand and \$541 thousand are outstanding at December 31, 2024 and 2023, respectively. These loans were collateralized by TIAA Traditional Annuity Contract account balances of approximately \$542 thousand and \$595 thousand at December 31, 2024 and 2023, respectively.

Beginning November 15, 2018, the Plan was amended and now allows only participant loans. The Plan allowed only Plan Loans previously. Participants may borrow from their accounts a minimum of \$1 thousand up to a maximum, which is equal to the lesser of \$50 thousand or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the prime rate. Interest rates on existing participant loans range from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through monthly Automated Clearing House payments. Participant loans are reported as notes receivable from participants.

Payment of Benefits

Upon termination of service, retirement, death or eligibility for in-service distributions such as a loan, hardship or age 59 ½ withdrawal, payment of benefits will be made to participants or beneficiaries based on the provisions of the Plan. The form of the payment is based on participant elections, as

outlined in the provisions of the Plan and may include annuities, installment payments, minimum distribution payments, and lump sum payments.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ materially from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the benefit responsive TIAA Traditional Annuity Contracts, which are reported at contract value. Fair value is a market-based measurement based on assumptions that market participants would use in pricing an asset or liability. See Note 3 for further information on fair value measurements. For fully-benefit responsive TIAA Traditional Annuity Contracts, contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Each contract is fully and unconditionally guaranteed by TIAA and the fully benefit responsive contracts provide for full participant directed liquidity. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, nor limit the ability of the Plan to transact at contract value with its participants.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation/(depreciation)

in fair value of investments, which consists of both realized gains/(losses) on investments bought and sold, as well as unrealized gains/(losses) on investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of the Plan are paid by the Plan unless paid by the university. Such expenses include any expenses incident to administration of the Plan, including, but not limited to, accounting fees, legal fees, investment advisory fees, regulatory compliance fees, and other qualified costs of administering the Plan.

Expenses deemed reasonable and necessary for the administration and maintenance of the Plan are being paid using funds from the Plan's Revenue Credit Account ("RCA"). As a result of the university's agreement with TIAA-CREF regarding its fees, approximately \$1 thousand and \$6 thousand was returned to the Plan as deposits into the RCA for the years ended December 31, 2024 and 2023, respectively. These deposits, as well as any earnings, are reflected as other income in the accompanying Statements of Changes in Net Assets Available for Benefits. Within the 12-month period following each deposit into the RCA, the funds are expected to be used to pay expenses of the Plan or credited to Plan participant accounts in the form of revenue credits. The revenue credits may be credited on a per capita or pro rata basis at the election of the Plan Sponsor.

Effective April 1, 2020, Yale introduced explicit recordkeeping fees, a model portfolio fee and direct revenue share credits to participant accounts on a quarterly basis. Some participants do not have sufficient annuity investment credits to cover the plan services fee or are under the \$1 thousand balance threshold established by the Fiduciary Committee on Investments ("the Committee"). The Committee determined that plan services fees not payable by participants should be paid by the university rather than being subsidized by the RCA.

During the plan years ended December 31, 2024 and 2023, administrative expenses of approximately \$52 thousand and \$33 thousand, respectively, were paid by the Plan using RCA funds. These expenses were partially offset by fees charged to participants of approximately \$44 thousand and \$41 thousand, respectively. These expenses are included in net appreciation in fair value of investments.

Funds remaining in the RCA are considered assets of the Plan and are included in investments in the accompanying Statements of Net Assets Available for Benefits. Approximately \$834 thousand and \$812 thousand of RCA funds were credited to participant accounts for the Plan years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the balance in the RCA was approximately \$3 hundred and \$15 thousand, respectively.

**3. Fair Value Measurements**

Fair value is a market-based measurement based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering assumptions, a three-tier hierarchy has been established which categorizes the inputs used in measuring fair value. The hierarchy of inputs used to measure fair value includes:

- *Level 1* – Quoted prices for identical assets in active markets. Market price data is generally obtained from relevant exchange or dealer markets.
- *Level 2* – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable.
- *Level 3* – Unobservable inputs in which there is little or no market data, requiring the Plan Administrator to develop its own assumptions.

Registered investment company investments are stated at fair value based on quoted market prices available on the last day of the Plan year. Self-directed brokerage account balances are invested in registered investment companies.

Real estate investments in the TIAA Real Estate Account (a pooled separate account) are valued using independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet participant redemption, transfer, or cash withdrawal requests. Redemptions are allowed daily not to exceed one per calendar quarter.

The non-benefit responsive TIAA Traditional Annuity Contracts provide a guarantee of principal, a guaranteed minimum interest rate of three percent, and the potential for additional interest, if declared by the TIAA Board of Trustees. The average yield for the non-benefit responsive TIAA Traditional Annuity Contracts for the years ended December 31, 2024 and 2023 were 4.30 percent and 4.57 percent, respectively. These contracts are subject to certain withdrawal restrictions, including limitations on lump sum withdrawals, and are subject to certain surrender charges.

**4. Party-In-Interest Transactions**

Plan investments include investment contracts, shares of registered investment companies and a pooled separate account managed by TIAA or CREF. Transactions pertaining to these investments qualify as exempt party-in-interest transactions. In addition, the Plan pays certain fees to TIAA and CREF related to investment transactions, including those paid from the RCA. These fees are reported as part of net appreciation in the fair value of investments.

**5. Plan Termination**

Although it has not expressed any intent to do so, the university has the right to terminate the Plan and discontinue contributions completely at any time subject to the provisions of ERISA. Upon termination of the Plan, the university has the right to distribute the balance of participants' accounts in a lump sum, if permitted under the terms of the contracts, or by delivery of a fully paid annuity contract as permitted under U.S. Treasury regulations.

**6. Tax Status**

The Plan is intended to satisfy the requirements of Section 403(b) of the IRC so that any earnings on employer and participant contributions to the Plan are exempt from taxes but are taxable to Plan participants upon distribution.

In accordance with Section 403(b) of the IRC, all assets of the Plan are held in annuity contracts described in Section 403(b)(1) of the IRC or custodial accounts described in Section 403(b)(7) of the IRC. To the best of the Plan Administrator's knowledge, the Plan is and has been administered in accordance with the requirements of Section 403(b) of the IRC and any earnings on amounts invested in the Plan's investment vehicles are not subject to tax at the Plan level. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The university has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. Prior to the amended regulations, the Plan was not viewed as a separate reporting entity. The regulations were effective for plan years beginning on or after July 1, 2009. Accordingly, certain records are not available from the inception of the Plan, and the effect, if any, on the completeness or accuracy of the Plan's financial statements and supplemental schedule cannot be determined.
