The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of MoneyLion, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2018 covering all eligible employees who are members of the controlled group which includes MoneyLion, Inc. (Plan Sponsor effective January 1, 2018), Wealth Technologies, Inc, Malka Media Group LLC, Malka Sports LLC and Even Financial, Inc. (collectively, the “Employers”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees of the Employers over the age of 21 who have completed 30 days of service are eligible to participate in the Plan for purposes of elective deferrals and the Employers’ safe harbor matching contribution. Employees who attain one year of service are eligible for employer profit sharing contributions, if any. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

On June 16, 2025, the Plan Sponsor approved the termination of the Plan effective April 16, 2025 (see note 6).

Participant accounts

Each participant’s account is credited with the (a) participant’s contributions, (b) allocations of the Employers’ contributions and (c) Plan earnings net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions

Upon eligibility, participants may make pre-tax and Roth contributions to the Plan, subject to certain limitations set by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employers makes a safe harbor matching contribution of 100% up to 3% of compensation plus 50% of employee contributions in excess of 3% of compensation and up to 5% of compensation. The Employers may make profit sharing contributions equal to a discretionary amount for eligible employees. During 2024, the Employers did not make any profit-sharing contributions.

Investment options

The assets of the Plan are allocated to the applicable funds at the direction of the participant.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and employer safe harbor contributions. Vesting in the Employers' discretionary matching contributions portion of their accounts plus actual earnings thereon is based on the number of years of continuous service by the participant. A participant is 100 percent vested after six years of credited service, based on the vesting schedule outlined in the Plan document.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to pay administrative expenses or reduce future employer contributions. The Plan had no forfeiture balances as of December 31, 2024 and December 31, 2023.

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lower of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates equal to the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or payment by check over no longer than a five-year period. The five-year period may be extended to a term no longer than 30 years if the participant is borrowing to finance the purchase or renovation of a principal residence. Participants are limited to one outstanding loan at a time. Effective April 16, 2025, the loan program was amended to allow participants with loan balances to transfer their loans to another plan.

Payment of benefits

On termination of service due to death, disability, retirement, or separation from service, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as further outlined in the Plan document. Participants may also elect in-service withdrawals of their elective deferral account balances in their accounts in the case of a hardship. Required minimum distributions for participants also apply per Internal Revenue Service regulations.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan's financial statements are prepared using the accrual basis of accounting, except for benefits paid which are recorded when paid.

Investment valuations and income recognition

The Plan's investments are reported at fair value except for the fixed income guaranteed option which is valued at contract value.

Realized, unrealized gains (losses) and interest and dividend income from the assets in each account are credited to or charged against each participant's account. Purchases and sales of securities are recorded on a trade date basis.

The aggregate of (a) the net unrealized appreciation (depreciation) in the fair value of investments for the year, and (b) the net gains or losses on disposition of investments during the year is reflected as net appreciation of investments for the year.

Management fees and operating expenses charged to the Plan for investments in the investments consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with investments. Any defaults on notes receivable from participants would be treated as a taxable distribution to the participant.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, which is the date of the financial statements were available to be issued.

On June 16, 2025, the Plan Sponsor approved the termination of the Plan effective April 16, 2025 as further described in the "Plan termination" footnote (note 6).

Note 3 – Investments, at fair value

Fair value measurements

The Plan reports its investments under the Financial Accounting Standards fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under this standard are as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical assets.
- Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.
- Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Mutual funds

The Plan’s investments in mutual funds are stated at fair value based on the quoted market prices of the underlying securities within each fund. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price.

Pooled separate accounts

Unit value is calculated based on the net assets of the underlying pool of securities which value their investment securities at fair value. The separate accounts are valued daily based on the NAV of shares of the underlying funds. These investments can be redeemed on a daily basis.

Common/collective trusts

The NAV of the common/collective trusts are determined at the close of each business day based on the fair value of the respective investments. The NAV per unit is calculated as of the close of each business day. The NAV per unit is computed by dividing the total contract value of the assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation (“unit value”). Investment income earned is reinvested in the Fund and included in the determination of unit values. The value of each participant’s account on any date is determined by multiplying the number of units held by the “unit value” at the close of the business day. The common/collective trusts have zero unfunded commitments, a daily redemption frequency and a 1 day redemption notice period.

Note 4 – Investments, at contract value

The Plan held a portfolio of investment contracts that comprised of fixed income guaranteed option contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value types of investment contracts held by the Plan as of December 31, 2024 and December 31, 2023:

Note 6 – Plan termination

On June 16, 2025, the Plan Sponsor adopted a resolution to terminate the Plan effective April 16, 2025. Although the Plan was in existence as of December 31, 2024, the decision to terminate was made subsequent to year-end and prior to the issuance of these financial statements. The termination is subject to the distribution of assets in accordance with the provisions of the Plan and the requirements of ERISA.

As of December 31, 2024, the financial statements do not reflect any adjustments related to the termination of the Plan. The Plan's assets will be distributed to participants or their beneficiaries in accordance with their account balances, subject to applicable provisions of the Plan and the Code.

Note 7 – Party-in-interest transactions

Plan investments include shares of funds managed by Principal Life Insurance Company, Principal Trust Company and Principal Global Investors Trust Company who are the Custodians as defined by the Plan, and, therefore, those transactions, as well as other transactions with the Custodians, qualify as party-in-interest.

Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Employer. These transactions also qualify as a party-in-interest transactions.

Note 8 – Tax status

The Internal Revenue Service has determined and informed the Plan by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan's management and Trustees believe the Plan is designed and currently being operated in compliance with applicable requirements of the IRC.
