**INDEPENDENT AUDITORS' REPORT**

To the Board of Luzerne County  
Head Start, Inc., Retirement Plan  
Wilkes-Barre, Pennsylvania 18702

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Luzerne County Head Start, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Luzerne County Head Start, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year then ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Luzerne County Head Start, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Luzerne County Head Start, Inc. Retirement Plan's ability to continue as a going concern one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Luzerne County Head Start, Inc. Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Luzerne County Head Start, Inc. Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of Luzerne County Head Start, Inc. Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was restated coincident with the transfer from Transamerica Life Insurance Company, Plan custodian, to John Hancock Trust Company, LLC, Plan trustee, effective July 12, 2022.

A. General:

The Plan is a defined contribution profit sharing plan covering all eligible employees (excluding interns, substitute and replacement employees) of Luzerne County Head Start, Inc., who have completed one year of service for nonelective contributions and ninety days of service for elective deferrals and are eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions:

Each year, participants may elect to defer a specific percentage or dollar amount of pre-tax or after-tax (ROTH) annual compensation, defined in the Plan as wages, tips and other compensation on form W-2, up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to automatically escalate their elective deferrals by one, two or three percent of compensation up to a maximum of twenty-five percent of compensation. The escalation will apply as of the anniversary of enrollment in the voluntary escalation program. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employee contributions are remitted to the Plan on a bi-weekly basis coincident with the company's payroll schedule.

Employer profit sharing contributions are discretionary to be determined each year by Luzerne County Head Start, Inc. Although the exact amount may vary from year to year, the contributions to this Plan will always be given high priority by the Board of Luzerne County Head Start, Inc. The amount of such contributions shall not be greater than 15% of the compensation paid to all participants for each limitation year. During 2024 and 2023 contributions were 7% and 7%, respectively. Contributions to the Plan are made on a monthly basis. Participants direct all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

C. Participant Accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) Luzerne County Head Start, Inc.'s discretionary profit-sharing contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Employer contributions plus actual earnings thereon vests ratably at 20% per year of service and are 100% vested after five years of service.

E. Notes Receivable from Participants:

The Plan does not allow participant loans.

F. Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, substantially equal installment payments or partial withdrawals. A participant may withdraw all or part of his/her fully vested pretax elective deferral account or ROTH elective deferral account in the event of undue financial hardship. The Plan allows automatic rollover distributions if the value of the participant's vested account balance is between \$1,000 and \$7,000. The participant must consent to distributions in excess of \$7,000. Vested account balances less than \$1,000 are automatically paid in a single lump-sum distribution. In-service distributions are allowed if a participant has attained the age of 59½.

G. Forfeited Accounts:

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$28,237 and \$54,362, respectively. These accounts will be used to reduce employer contributions. In 2024, there were \$78,062 in additional forfeitures and earnings and employer contributions were reduced by \$104,187 from forfeited nonvested accounts.

H. Plan Amendments:

Effective January 2020, the Plan has adopted certain requirements of the Setting Every Community Up for Retirement Enhancement (SECURE) Act which changed required minimum distribution age from 70.5 to 72, requires non-spouse beneficiaries to withdraw funds within ten years, allows penalty free withdraws for new parents and other provisions. The Plan has until 2026 to formally amend the Plan.

Effective April 2020, the Plan adopted the suspension of required minimum distribution provision of the Coronavirus Aid, Relief, and Economic Security (CARES) Act that was signed into law on March 27, 2020. As a result of the act, required minimum distributions were completely waived for 2020. The Plan has until 2026 to formally amend the Plan. The Plan chose not to adopt any additional provisions of the CARES Act.

Effective January 2024, the Plan adopted certain requirements of Setting Every Community Up for Retirement Enhancement 2.0 (SECURE 2.0) Act which changed required minimum distribution age from 72 to 73. The Plan has until 2026 to formally amend the Plan.

Effective January 2024, the Plan adopted certain requirements of Setting Every Community Up for Retirement Enhancement 2.0 (SECURE 2.0) Act which increased the cash-out limit from \$5,000 to \$7,000. The Plan has until 2026 to formally amend the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting:

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

B. Use of Estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Contributions are recorded in the period earned. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and may include interest and dividends earned in pooled separate accounts as allowed by the Department of Labor.

D. Payments of Benefits:

Benefits are recorded when paid.

E. Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Agency and are excluded from these financial statements. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

F. Date of Management Review:

The plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE AND CUSTODIAN

The plan administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA as complete and accurate by the trustee, John Hancock Trust Company, LLC and was not subjected to any auditing procedures performed by the independent auditors:

- a. Investments at fair value as shown in the accompanying statements of net assets available for benefits of \$12,466,073 as of December 31, 2024, and \$10,678,334 as of December 31, 2023.
- b. Net investment income of \$1,317,354 as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Input to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets:

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/Collective Trusts:*

Valued at the net asset value (NAV) of units of a bank collective trust at John Hancock Trust Company, LLC, the Plan trustee. The NAV, as provided by the Plan trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Registered Investment Companies:*

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The Plan investments included shares of common/collective trusts and registered investment companies managed by John Hancock Trust Company, LLC (John Hancock) the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest

Cambridge Investment Research, Inc. was paid \$16,891 for investment advisory services to the Plan during 2024.

During 2024, the trustee and custodian, John Hancock, charged \$2,566 in distribution fees directly to applicable participants and allocated \$20,715 in administrative and advisory fees to participants.

The Plan sponsor pays the audit fee for the Plan.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, Luzerne County Head Start, Inc., has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in the employer contributions.

7. TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the June 30, 2020 letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. OTHER ADDITIONS

The other additions amount is from a prior year correction done by John Hancock and has been credited to the forfeiture account.
