Notes to Financial Statements For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of The All Roads Company Retirement Savings Plan and Trust (the Plan) provides only general information. The Plan agreement should be referenced for a complete description of the Plan's provisions.

General

George R. Norris, Inc. established a profit sharing and savings plan and trust for the benefit of its employees effective December 31, 1972. The Plan also covers employees of Packer Norris Parts, LLC and the former employees of Chesapeake Ford Truck Sales, Inc., Elliot Wilson Capital Trucks, Hydra Lift Industrial Truck, Inc. (collectively, Norris Ford) and Vermeer Mid Atlantic and Vermeer Sales and Services, Inc. (collectively, Vermeer Mid Atlantic) (collectively, the Company). Effective February 23, 2019, the Plan was amended to grant participation to employees of Pensare, LLC Db/a/Tischer Acura, collectively included under Norris Ford. Effective October 6, 2019, the Plan was amended to change the name of the Plan from "The Norris Ford Retirement Savings Plan and Trust" to "The All Roads Company Retirement Savings Plan and Trust" and grant participation to employees of NYNE Equipment, LLC, collectively, included under Vermeer Mid Atlantic. Effective December 1, 2019, the Plan was amended to grant participation to employees of Bare Truck Center, Inc. and Stoms Companies, LLC, collectively included under Norris Ford. Effective January 1, 2021, the Plan was amended to grant participation to employees of Hickory International, Inc., collectively included under Norris Ford. Effective May 24, 2021, the Plan was amended to grant participation to employees of Beaver's Auto Body Repair CTR, Inc., collectively included under Norris Ford. Effective September 1, 2021, the Plan was amended to grant participation to employees of Clifton Leasing, Inc., collectively included under Norris Ford. Effective October 1, 2021, the Plan was amended to grant participation to employees of Rish Equipment Company, collectively included under Norris Ford. Effective November 1, 2021, the Plan was amended to grant participation to employees of Central Truck Center, Inc. (collectively All Roads Kenworth DC, LLC.), collectively included under Norris Ford. Effective January 1, 2023, the Plan was amended to change the manner the non-discretionary matching contribution is calculated and to change the service requirement for overall plan participation from eleven months to two months. Effective April 1, 2023, the Plan was amended to grant participation to employees of J. G. Parks & Son, Inc. collectively included under Norris Ford. Effective May 1, 2023, the Plan was amended to grant participation to employees of TP Investment Group, LLC collectively included under Norris Ford. Effective August 13, 2023, the Plan was amended to grant participation to employees of West End Service, Inc. collectively included under Norris Ford. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Plan was most recently restated effective September 10, 2021.

Effective November 2024, the Plan elected to operate in accordance with SECURE Act and SECURE 2.0 provisions permitting qualified birth or adoption distributions of up to \$5,000 and one annual emergency personal expense withdrawal of up to \$1,000. Although formal amendments have not yet been executed, the Plan is operating in compliance with these provisions and will adopt amendments by the statutory deadline.

All employees, with the exception of nonresident aliens, leased employees and employees covered by a collective bargaining agreement are eligible to participate in the Plan after completion two months of service, and the attainment of age 21.

1. DESCRIPTION OF THE PLAN - cont'd.

General – cont'd.

Eligibility to receive Company contributions (matching, profit sharing or qualified non-elective contributions) requires the completion of two months of service. Entry dates into the Plan are on the first day of each month. Employees may enter the Plan at the next entrance date once the employee satisfies the eligibility requirements.

Participant Contributions

The Plan allows automatic enrollment of employees once the eligibility requirements have been met. Employees are automatically enrolled with pre-tax deferral contributions deducted from their pay at a rate of 4% of their compensation, unless the employee opts out of Plan participation or elects a different percentage. The automatic deferral is increased annually, on a participant's anniversary date of when they were automatically enrolled, by 2%, to a maximum of 10%, unless an alternative automatic increase percentage is elected by the participant.

A participant in the Plan may elect to enter into a salary reduction agreement with the Company, which would be applicable to the Plan year during which the election is made, and to subsequent Plan years unless cancelled or modified. Such agreement provides that the participant agrees to accept a reduction in compensation on a pre-tax or post-tax (Roth) basis equal to any whole percent of compensation that does not exceed 90% of compensation, subject to any dollar limitation imposed by the Internal Revenue Code (Code), which totaled \$23,000 for the year ended December 31, 2024 and \$22,500 for the year ended December 31, 2023. The salary reduction amount would then be contributed to the Plan by the Company on behalf of the employee.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans except for after-tax Roth contributions.

Company Contributions

All employees of the Company receive a non-discretionary matching contribution equal to 10% of the first 10% of the eligible employee's compensation contributed to the Plan.

In addition, the Company may make discretionary qualified contributions for employees. Any such contributions would be allocated to the participants based on a ratio of each participant's year to date deferrals to total deferrals contributed to the Plan.

Participants must be employed on the last day of the Plan year to be eligible for the non-discretionary and discretionary Company contributions unless he or she retired, died or became disabled during the Plan year.

Non-discretionary matching contributions totaled \$392,408 and \$360,931 for the years ended December 31, 2024 and 2023, respectively. There were no discretionary contributions for the years ended December 31, 2024 or December 31, 2023.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their salary deferral contributions plus earnings thereon. Vesting in Company contributions is based upon years of service, as defined by the Plan agreement according to the following schedule:

Upon attaining the normal retirement age of 65, or early retirement age of 60 and the completion of five years of service, participants shall be entitled to receive the full value of their accounts. The full value of participants' accounts will also be paid in the event of death or total permanent disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, except for loans used to purchase a principal residence, which can be repaid over a period not to exceed ten years. Loans are secured by bank rates for a comparable personal loan at the time of loan issuance. The rate is fixed throughout the duration of the loan. Interest rates on outstanding loans range from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefit payments are available to participants (or their beneficiary, in the event of death) upon retirement (age 65), early retirement (age 60 and completion of five years of service), termination of employment, death, attainment of age 59 ½ or disability. Prior to retirement, benefit payments may be distributed in the form of a lump-sum payment or rollover into another qualified plan. If the account balances are not fully withdrawn, remaining balances over \$5,000 will remain part of the Plan and share in investment gains and losses. Remaining balances under \$5,000 will be automatically distributed. The Plan also allows for hardship and in-service withdrawals, under certain circumstances, as defined in the Plan agreement. Hardship withdrawals may only be taken from participant deferral accounts. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company at its discretion. During the years ended December 31, 2024 and 2023, the Company paid a portion of Plan direct expenses. Expenses paid by the Company are excluded from the Plan's financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts

Forfeitures are used to reduce Company contributions or pay administrative expenses. There were no forfeitures applied to reduce Company contributions for the years ended December 31, 2024 and 2023. Forfeitures used to pay administrative expenses during the years ended December 31, 2024 and 2023 totaled \$19,950 and \$18,614, respectively. As of December 31, 2024 and 2023, forfeitures available to the Plan totaled \$33,316 and \$7,107, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends and dividend income are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, the Plan administrator deems the participant loan to be in default.

Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair Value Measurement - cont'd.

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest in common/collective trust: Valued based on the net asset value using practical expedient as determined by the issuer.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 6, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that required disclosure.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, and interest and dividend income and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Fidelity Management Trust Company (FMTC or the Trustee).

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of investment funds managed by parties related to Fidelity Investments Institutional Operations Corporation, Inc. (FIIOC), a related entity to FMTC. The Plan allows participants to take out notes against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. TAX STATUS

The Plan adopted a nonstandardized pre-approved plan sponsored by Fidelity Management & Research Company. The pre-approved plan received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the plan's qualified status. The opinion letter has been relied upon by the Plan. The Plan has been amended since the date of this opinion letter. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. TAX STATUS - cont'd.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. As the Plan is tax exempt and has no unrelated business income, these provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits, for any periods, in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the rights of all affected employees to benefits accrued in their accounts on the date of such termination will be nonforfeitable.

7. EXCESS CONTRIBUTIONS PAYABLE

During the years ended December 31, 2024, and 2023, the Plan failed to comply with certain non-discrimination rules. As a result of failing these tests, the Plan was required to refund the excess contributions to certain affected participants. As of December 31, 2024, and 2023, corrections were required totaling \$143,856 and \$74,260, respectively, and are recorded as excess contributions payable in the accompanying statements of net assets available for benefits. The refund payments related to the corrections required for the year ended December 31, 2024 were made in February 2025. The refund payments related to the corrections required for the year ended December 31, 2023 were made in February 2024.
