#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Dayton Progress/PCS Employee Retirement Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established by Dayton Progress Corporation (the "Company" or "Sponsor"). The Plan allows all eligible employees to participate upon the date of hire. Non-resident aliens, leased employees, high school students, full-time college students participating in internships and cooperative study programs, and certain employees of companies affiliated through common ownership are not eligible to participate in the Plan. Union employees of Anchor Lamina, Inc. are eligible to participate in the Plan and make elective deferrals, however, these employees are not eligible to receive employer matching or profit sharing contributions. Employees that meet eligibility requirements are automatically enrolled at a 5% deferral rate, unless an alternative election is made. This rate increases 1% each year on March 1, up to a maximum of 15%, unless the participant elects otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 17, 2025, a related plan, Anchor Lamina America, Inc. 401(k) Retirement Plan, was merged into the Plan. The Plan's name has also been changed to Dayton Lamina/PCS 401(k) Retirement Savings Plan. Total assets transferred to the Plan totaled \$21,717,647.

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Additionally, the Plan allows participants to make both after-tax and Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Employer matching contributions are discretionary, and participants become eligible for these contributions upon eligibility to participate in the Plan. The Company contributed 100% of the first 3% of elective deferrals and 50% of the next 2% of elective deferrals that a participant contributed to the Plan for the years 2024 and 2023.

The Company may also make discretionary profit sharing contributions to the Plan for eligible employees. To be eligible for the profit sharing contributions, a participant must complete one year of service and be employed by the Company as of the last day of the Plan year, unless separated due to death, disability or attainment of retirement age. Allocations of the Company's profit sharing contributions are made on the ratio a participant's compensation bears to the total eligible compensation. For the years 2024 and 2023, the Company did not make a discretionary profit sharing contribution to the Plan. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Vanguard Fiduciary Trust Company (the "Trust") is Trustee and Custodian of Plan investments. Subsequent to year end, the Plan's assets were moved to Empower Retirement, LLC in connection with the Plan merger with the Anchor Lamina America, Inc. 401(k) Retirement Plan. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution, employer match, and discretionary profit sharing contribution are to be invested.

### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately fully vested in their voluntary contributions, rollovers, employer matching contributions, and corresponding earnings. The following schedule will be used to determine vesting in the profit sharing contributions and its earnings:

Effective January 17, 2025 the Plan was amended and restated. As part of this amendment, the vesting schedule for employer matching contributions was updated as follows:

Participants hired on or before the effective date of this amendment, and participants transferring in from Anchor Lamina America, Inc. 401(k) Retirement Plan will be grandfathered into the prior vesting schedule.

**Notes Receivable From Participants** - Participants may borrow from the Plan in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at the prime rate plus 1%. Loan terms are for a period not exceeding five years. A 10-year term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions. No more than one loan may be outstanding at a time, unless one loan is for the purchase of a primary residence.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance in either a lump-sum or partial-sum amount. Upon termination, if the participant's account balance is \$1,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. If the balance does not exceed \$5,000, and the participant does not elect to have the distribution paid directly to an eligible plan, the Plan Administrator may make a lump-sum distribution to a direct rollover individual retirement account. In addition, participants may receive distributions of pre-tax deferrals and Roth elective deferrals for qualified financial hardships.

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. There were no forfeitures used to reduce Company contributions during 2024 and 2023. There were no unallocated forfeitures at December 31, 2024 and 2023.

Effective January 17, 2025, the Plan was amended and restated. As part of this amendment, the Plan now allows for forfeitures to be used to reduce nonelective and employer matching contributions and to pay Plan expenses.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options at any time via telephone or the Internet. Deferral percentages can be changed via telephone or the Internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as part of the loan amount. No allowance for credit losses is deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

**Administrative Expenses** - The Company pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Investment related expenses are included in net appreciation (depreciation) in value of investments.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 25, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation (depreciation) in value of investments, interest and dividends, and interest income on notes receivable from participants for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the Trustee of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Investments in registered investment companies:* Valued at the daily closing price reported by the fund as registered with the Securities and Exchange Commission. The funds held by the Plan are deemed to be actively traded and are required to publish their NAV and to transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Vanguard Retirement Savings Trust is a common collective trust that consists of a pool of investment contracts that are issued by insurance companies and commercial banks and other contracts that are backed by bond trusts selected by Vanguard Fiduciary Trust Company. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries. This common collective trust is included in the statements of net assets available for benefits at its contract value.

Certain events, such as premature termination of the investment in the common collective trust by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Vanguard Fiduciary Trust Company. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

#### NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with Vanguard Fiduciary Trust Company. Thus, Vanguard Fiduciary Trust Company, as Trustee defined by the Plan, qualifies as a party-in-interest. In addition, the Trustee receives certain fees for recordkeeping and management of the Plan. Fees paid by the Plan for these services for the years 2024 and 2023 totaled \$51,007 and \$50,509.

UBS Financial Services, Inc. ("UBS"), as advisors of the Plan, qualifies as a party-in-interest. Total fees paid to UBS for the years 2024 and 2023 totaled \$36,006 and \$0.

Brady, Ware & Schoenfeld, Inc., as auditor, qualifies as a party-in-interest. Audit fees expensed by the Plan during the years 2024 and 2023 totaled \$22,695 and \$11,798.

The Plan Sponsor also provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer profit sharing contributions.

#### NOTE 8 - TAX STATUS

The Plan adopted a Prototype Non-Standardized Profit Sharing and 401(k) Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
