## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the  
Odyssey Rehabilitation 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Odyssey Rehabilitation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

### *Opinion*

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

NOTE A – DESCRIPTION OF PLAN

The following description of the Odyssey Rehabilitation (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan covering all full-time employees of the Company who have twelve months of service with 1,000 hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan Administrator.

Matrix Trust Company is the custodian of the Plan. Gregory A. Hayes is the trustee of the Plan.

2. Contributions

Each year, participants may contribute up to the maximum amount allowable by law. Participants may also contribute amounts representing distributions from other qualified plans and IRAs. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Participants may change the allocation daily. Participants also have the option to invest in insurance up to amounts allowable by law. The Company may make discretionary contributions to the Plan at the option of the Company’s board of directors. These contributions are subject to certain limitations. The limit on employee elective deferrals is \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants over age 50 may contribute an additional \$7,500 in 2024.

3. Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution, (b) Plan earnings and (losses), and (c) charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A – DESCRIPTION OF PLAN, continued

4. Participant Investment Account Options

Investment account options available include various mutual funds. Each participant has the option of directing their contributions into any of the separate mutual funds offered by the Plan and may change the allocation daily.

5. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings is based on years of continuous service. A participant is 100% vested after six years of credited service.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of one percent (1%) above the prime interest rate. Principal and interest are paid ratably through monthly payroll deductions. The term of repayment will not be greater than five (5) years except when related to the purchase of a principal residence, which can extend the term of repayment up to thirty (30) years. There are \$6,128 and \$3,205 of outstanding participant loans receivable as of December 31, 2024 and 2023, respectively.

7. Payment of Benefits

Upon termination of service due to disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the participant's account, or annual installments over a period of not more than their assumed life expectancy. Upon termination of service due to death, a participant's beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the beneficiaries assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship distributions may also be granted in accordance with plan provisions.

8. Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,343 and \$1,274, respectively. These accounts will be used to reduce future employer contributions. During 2024 and 2023, there were not any reductions of employer contributions from forfeited nonvested accounts.

9. Plan Expenses

The employer absorbs significant costs of the plan administration and does not expect repayment of such costs.

## NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices, if applicable, are used to value investments. Mutual funds are valued at net asset value (NAV) of shares held by the plan at year end. See Note D for discussion of fair value measurements.

The income on investments is recognized as an appreciation or depreciation of the net unit value of each fund. As of the date of transfer of funds to Matrix Trust Company, the funds separately distribute interest, dividends, and capital gains to the participants. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

5. Payment of Benefits

Benefit payments to participants are recorded when paid.

6. Expenses

The employer absorbs significant costs of the plan administration and does not expect repayment of such costs. Expenses paid by the employer are excluded from the financial statements. Investment related expenses are included within net appreciation or depreciation in fair value of investments.

## NOTE D – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1**      Unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority.
- Level 2**      Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable market data for substantially the full term of the assets or liabilities.

## NOTE D – FAIR VALUE MEASUREMENTS, continued

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

### *Investments*

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

## NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE F – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are not any uncertain tax positions taken or expected to be taken requiring recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

#### NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### NOTE H – BENEFITS PAID TO PARTICIPANTS

Benefits paid to participants were \$253,949 for the plan year ended December 31, 2024.

Benefits paid to participants were \$705,539 for the plan year ended December 31, 2023.

#### NOTE I – CONCENTRATIONS

For the year ended December 31, 2024, investments in one family of mutual funds were \$3,593,992, which represents 99% of the total assets available for benefits.

For the year ended December 31, 2023, investments in one family of mutual funds were \$3,195,332, which represents 99% of the total assets available for benefits.

## NOTE J – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan issues loans to participants, which are secured by the participant's account balance. The loan transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited rules of ERISA.

## NOTE K – SUBSEQUENT EVENTS

Management has reviewed the financial statements as of October 7, 2025, which is the date the financial statements were available to be issued, and identified no events requiring recording or disclosure in the 2024 financial statements.
