## Independent Auditor's Report

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Rumson Country Day School DC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of Plan**

The following description of The Rumson Country Day School DS Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established effective January 1, 1956, as restated January 1, 2010. The Plan covers all employees, excluding non-resident aliens and employees who have not yet completed a year of service, of The Rumson Country Day School (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

**Eligibility**

Eligible employees may make elective deferral contributions immediately upon their date of hire. Upon attaining one year of eligible service, age 21 and 1,000 hours of service, as a condition of employment, all eligible employees are required to participate in the Plan with a minimum contribution of 5% of their salary and are eligible to participate in the non-elective employer contribution. Employees with less than one year of service are not eligible to receive a non-elective contribution, except for employees with the title "Headmaster" that are non-highly compensated. Employees with the title Headmaster that are non-highly compensated have no service requirement for an employer contribution.

**Employee Contributions**

An employee participating in the Plan must annually contribute, through payroll deductions, a minimum of 5% of their compensation not to exceed the maximum amounts as determined by the Internal Revenue Service ("IRS") and may contribute amounts representing distributions from other qualified plans. In addition to the 5% minimum deferral, participants may contribute additional elective deferrals and Roth deferrals, subject to IRS limitations. Any participant, age 50 or over, may make an additional "catch-up" contribution as determined by the IRS. In addition, "qualified employees" may make an additional contribution subject to the lesser of (1) \$3,000, (2) \$15,000, reduced by the amount of additional elective deferrals made in prior years, or (3) \$5,000 times the number of the employee's years of service for the organization, minus the total elective deferrals made for earlier years. Employees are considered to be a "qualified employee" if they have completed at least 15 years of service with an educational organization, hospital, home health service agency, health and welfare service agency, church, convention or association of churches.

**Employer Contributions**

For employees hired on or after January 1, 2013, employer contributions are non-elective contributions. The amount of the contribution will be determined by the Plan sponsor. For the year ended December 31, 2024, the employer contribution was 5% of compensation.

For employees hired on or before December 31, 2012, the Company makes a matching contribution based upon the following schedule:

<u>Years of Service</u>	<u>Match</u>
Less than or equal to 10 years	5% of compensation
Greater than 10 years to 15 years	6% of compensation
Greater than 15 years to 20 years	7.5% of compensation
Greater than 20 years	10% of compensation

**Participant Accounts**

Individual accounts are established for each participant. The Plan offers a variety of investment options. Each participant's account is credited with the participant's pre-tax contributions, the employer contributions and the proportionate share of dividends, interest and investment gains since the preceding valuation date. The participant's account is reduced by withdrawals, allocation of expenses and losses on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

#### **Distributions and Withdrawals**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump-sum payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

When a participant receives a distribution in the form of an annuity contract, the participant's assets are transferred into an individual contract in the participant's name. This contract provides the participant with either a guaranteed lifetime payment or a fixed term payment for a specific amount, and the funds transferred into the annuity contract are no longer Plan assets. Distributions, in the form of an annuity contract, are shown on the statement of changes in net assets available for benefits as purchases of annuity contracts.

#### **Plan Loans**

The Plan allows for loans to be extended to participants as Plan loans which are issued directly from funds owned by TIAA and are not considered Plan assets. A portion of the participant's account in the TIAA Traditional Annuity is reserved as collateral to cover 110% of the outstanding loan balance and interest is credited directly to TIAA and CREF. The minimum a participant may borrow is \$1,000 and the maximum, including the outstanding balance of existing Plan loans, is 50% of their vested account balance, not to exceed \$50,000. Participant loans bear interest at varying rates fixed at the time of issuance and determined by the terms of the Plan document. Plan loan interest rates may be fixed or variable and the initial rate is determined by the terms of the controlling contract. For each of the years ended December 31, 2024 and 2023, the loans bear interest ranging from 5.23% to 5.73%. Principal and interest on Plan loans are paid ratably through monthly payments paid by the participants directly. At December 31, 2024 and 2023, the amount of Plan loans outstanding was \$3,309 and \$19,785, respectively.

#### **Revenue Credit Account**

In accordance with an agreement between TIAA and the Plan, TIAA will make deposits to this account in an amount consistent with the revenue sharing terms as defined in the agreement. Any amounts attributable to the account shall be reflected in the Plan records, held in the Plan trust and invested as directed by the Plan sponsor. Amounts in this account are used to offset Plan administrative expenses and any amounts unused for expenses may be allocated to participant accounts. For the year ended December 31, 2024, there was \$10,045 of distributions from the revenue credit account and has been reported as other revenue in the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, there was approximately \$235,000 and \$179,000, respectively, in the credit revenue account.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in 2025.

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

#### **Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Valuation of Investments and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in the following plan year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Group Fixed Annuity Contracts:* The RA and RC TIAA Traditional Annuity holdings are not benefit responsive. Liquidity restrictions apply to these types of annuity contracts. See the redemption restrictions section below for further details on the liquidity restrictions. The contract value of these holdings equals the accumulated cash contributions and interest credited to the contract less any withdrawals. Transactions in similar investment instruments are not observable. TIAA has indicated that contract value provides a good approximation of fair value.

The guaranteed annual interest rate for RA and RC TIAA Traditional Annuity is 1% to 3% for all premiums remitted under TIAA Traditional Annuity accumulating contracts. The crediting interest rate is calculated on a daily basis.

*Pooled Separate Accounts:* The TIAA Real Estate Account is a pooled separate account/insurance company separate account. This is a variable annuity product. The value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on the assessment of specialists and reported by TIAA. The TIAA Real Estate Account sometimes holds securities as well, and these are generally priced using values obtained from independent pricing sources. Units held in the pooled separate account are valued on the NAV of the shares held by the Plan, at year end, which is based on the unit prices quoted by the fund, representing the fair value of the underlying investments.

*Registered Investment Companies - CREF Accounts:* CREF Accounts are variable annuity accounts. The accounts invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources, which may employ various pricing methods to value the investments including matrix pricing. For accounts other than the money market account, CREF uses market quotations or values obtained from independent pricing services to value securities and other instruments held by the accounts. If market quotations or values from independent pricing services are not readily available or are not considered reliable, CREF will value the securities using "fair value" as determined in good faith using procedures approved by the Board of Trustees (Level 2).

*Money Market:* The CREF Money Market Account's portfolio securities are valued using their amortized cost. This valuation method does not factor in unrealized gains or losses on the account's portfolio securities. Amortized cost valuation involves first valuing a security at its cost, and thereafter assuming a constant amortization to maturity of any discount or premium, regardless of the impact of fluctuating interest rates on the security's market value (Level 2).

*Mutual Funds/Custodial Account Agreement:* The Plan had a custodial account agreement with JPMorgan Chase Bank, N.A., which was transferred to TIAA-CREF Trust Company, FSB effective January 1, 2015 to enable the Plan to be funded, in part, with a custodial account designed to meet the requirements of Code Sections 401(f)(2) and 403(b)(7). As a result, participants are able to invest in an enhanced menu of mutual funds. The mutual funds invest principally in equity securities and fixed income instruments, in accordance with each fund's objectives. The investments in the mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Group fixed annuity contracts are invested in the general account of TIAA and CREF with guaranteed returns and are subject to claims of TIAA and CREF's general creditors. The general account is invested in corporate and government bonds, preferred stock, mortgage and asset backed securities, commercial mortgages, private equity, limited partnership fund investments, REIT common stock, other common stock, real estate and cash. Insurance regulations limit the proportion of investments that can be allocated to certain asset classes. Specifically, regulations limit holding of below-interest-grade bonds to 10% of the portfolio; emerging market debt to 4%; U.S. common stock and other non-preferred equity securities to 20%; and U.S. real estate to 20%. Regulations also require TIAA to maintain certain minimum amounts of capital. These capital requirements vary by the amount and type of risk. For instance, emerging market bonds, equities and real estate require significantly higher capital than investment grade bonds.

(b) In accordance with Subtopic 820-10, certain investments that were measured at NAV (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan administrator has evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers into or out of Levels 1, 2 or 3.

(c) This account seeks favorable long-term returns primarily through rental income and appreciation of real estate investments owned by the account. The account intends to invest between 70% and 85% of its assets directly in real estate or real estate-related investments. This account will invest the remaining portion of its assets in government and corporate debt securities, money market instruments and other cash equivalents and, at times, stock of companies that do not primarily own or manage real estate.

**Redemption Restrictions**

Certain contracts issued for the TIAA Traditional Annuity contain liquidity restrictions on transfers and withdrawals which could impact the value realized upon exiting the contract. The RA contract requires cash withdrawals and transfers to be spread over a period of ten annual installments. The Retirement Choice Annuity provides for a 2.5% withdrawal fee if a participant separates from service and elects to withdraw accumulations within 120 days of separation.

Accumulation units in the TIAA Real Estate Account are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the TIAA Real Estate Account are limited to one per calendar quarter.

Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Participants will be locked out of a CREF Account, other than the CREF Money Market Account, for 90 days if a purchase, sale or repurchase within that account is made within a 60-day period.

Accumulation units in TIAA and CREF Accounts are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Participants will be locked out of a TIAA and CREF Account, other than the TIAA and CREF Money Market Fund or the TIAA and CREF Short-Term Bond Fund, for 90 days if a purchase, sale and repurchase within that account is made within a 60-day period. Certain funds charge a 2% redemption fee on redemptions of shares occurring within 60 days of the initial purchase date.

Accumulation units in mutual funds are available for transactions at the closing accumulation unit value on any day the NYSE is open for business.

#### **4. Investments at Contract value**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

The contract value of the Plan's fully benefit-responsive investment contracts at December 31, 2024 and 2023 was \$774,781 and \$705,059, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3.0%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate is calculated on a daily basis.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **5. Information Certified by Custodians (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities Fund ("CREF"), the Custodians of the Plan, have certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **6. Plan Termination**

The Company intends to continue the Plan indefinitely for the benefit of its employees but reserves the right to modify, amend or terminate the Plan at any time by resolution of its Board of Directors. In the event of termination of the Plan, all amounts credited to participants' accounts shall be 100% vested and non-forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan.

### **7. Tax Status**

The Plan adopted a volume submitter plan offered by FIS Business systems LLC stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the Internal Revenue Code ("IRC"). The volume submitter plan received an IRS Opinion Letter dated March 31, 2017, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. Furthermore, there are no tax related interest or penalties for the periods presented in these financial statements.

### **8. Party-in-Interest Transactions**

Investments in the TIAA Accounts, CREF Accounts and TIAA and CREF Funds are managed by TIAA and CREF, the Custodians. These transactions qualify as party-in-interest transactions. Investment fees charged by TIAA and CREF are absorbed in investment income and were approximately \$138,000 for the year ended December 31, 2024.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**9. Subsequent Events**

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued. Based on that evaluation, the Plan has determined that no subsequent events have occurred that require disclosure in the financial statements.
