To the Plan Trustees and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the New York Athletic Club Local 6 Union Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1 – Description of Plan

General

The following description of the New York Athletic Club Local 6 Union Employees 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution pension plan established on May 1, 2005. It is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”). All Local 6 Union Employees of the New York Athletic Club (the “Club”) who have completed 60 days of service, as defined in the Plan document, are eligible to participate in the Plan. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective January 1, 2024, the Plan was amended to comply with the long-term part-time employee eligibility provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE Act”). Under these provisions, union employees who complete at least 500 hours of service in each of three consecutive 12-month periods and attain age 21 are eligible to make elective deferrals under the Plan, even if they have not satisfied the Plan’s standard 1,000-hour service requirement. Beginning January 1, 2025, the Plan will be further amended, as required under the SECURE 2.0 Act of 2022, to expand these eligibility provisions to union employees who complete at least 500 hours of service in each of two consecutive 12-month periods.

Contributions

Upon eligibility, participants may contribute a portion of their annual compensation; subject to certain limitations set under the Internal Revenue Code and the Plan document. The Club does not contribute to the Plan. Participants may also contribute rollover amounts representing distributions from another eligible retirement plan.

Participant accounts

Individual accounts are maintained for each participant. Each participant’s account is credited with the (a) participant’s contribution and allocations of and (b) investment earnings net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options

Each participant may direct the investment of his/her account into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of funding vehicles. The Club may choose from various investment options under the terms of the contract as further outlined in Plan document.

Note 1 – Description of Plan (continued)

Participant notes

Under the terms of the Plan, participants are not permitted to borrow from their accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Forfeitures

The Plan had no forfeiture balances as of December 31, 2024 and December 31, 2023.

Payment of benefits

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as further outlined in the Plan document. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2. Participants may also elect in-service withdrawals of their elective deferral account balances in their accounts in the case of a hardship. Rollover account balances may be withdrawn at any time, provided the rollover contributions have been properly segregated. Minimum required distributions for participants also apply per Internal Revenue Service ("IRS") regulations.

Plan termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Note 2 – Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"), except for benefits paid, which are recorded on the cash basis of accounting.

Investment valuation and income/expense recognition

Investments are reported at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when earned. Realized gains and losses on the sale of securities are computed on each individual security.

Investment valuation and income/expense recognition (continued)

The aggregate of (a) the net unrealized appreciation (depreciation) in the fair value of investments for the year, and (b) the net gains or losses on disposition of investments during the year is reflected as net appreciation in the fair value of investments for the year.

Management’s fees and operating expenses charged to the Plan for the Plan’s investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Fair value measurements

For assets measured at fair value on a recurring basis, Accounting Standards Codified Topic Fair Value Measurements requires quantitative disclosures about the fair value measurement separately for each major class of assets. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets.

Level 2 - Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Fair value measurements (continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024:

Registered investment companies (mutual funds)

The value of each registered investment company is determined at the close of each business day based on the net asset value ("NAV"), which is considered by Plan management to be the best approximation of fair value. Data for NAVs are distributed to Plan administrators and client investors and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily values using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

Common collective trust - stable value fund

The fair value of the common collective trust is determined based on the valuation method disclosed in the contract as calculated by the provider. All of these inputs are generally considered observable but without readily available financial information. The common collective trust is classified as Level 2 in the fair value hierarchy due to their ability to meet the NAV segregation and tracking requirements of the fair value hierarchy. The Plan has a common collective trust with the T. Rowe Price Trust Company. T. Rowe Price's stable value fund is credited with a contractual rate of return. T. Rowe Price Trust Company determines and periodically declares the fixed interest rate of return (referred to as the credited interest rate) to be credited to amounts under the contracts held in their general account, including the extent and frequency credited interest rates may be changed.

Contributions

Contributions from employees' are recorded as they are withheld from the participants' wages.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Note 2 – Summary of significant accounting policies (continued)

Administrative expenses

The Plan's expenses are paid by either the Plan or by the Club, as provided in the Plan document. Expenses that are paid directly by the Club are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Club. No such officer or employee receives compensation from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with these investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits at December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with investment securities.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, which is the date of the financial statements were available to be issued.

Note 3 – Information certified by the Plan's Custodians

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company and Reliance Trust Company, the Custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the Supplemental Schedule H – Part IV – Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4 – Party-in-interest transactions

Certain Plan investments are shares of investments managed by T. Rowe Price Trust Company and Reliance Trust Company. T. Rowe Price Trust Company and Reliance Trust Company are the Custodians as defined by the Plan, and therefore qualify as a parties-in-interest.

Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Club. These transactions qualify as party-in-interest transactions.

Note 5 – Tax status

The Plan utilizes a prototype plan document which the Internal Revenue Service (the “IRS”) has opined and informed the prototype plan sponsor that the prototype document is in compliance with Section 401 of the Internal Revenue Code (the “Code”). The prototype plan has obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.
