#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Diversified Technologies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of Diversified Technologies 401(k) Plan (the Plan) provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan covering eligible employees of Diversified Technologies, Inc. (the Company) who have attained 21 years of age and have completed six months of service, excluding leased employees, student and summer interns, co-op students, and residents of Puerto Rico. Eligible participants may enroll in the Plan immediately.

The Plan was originally established on August 1, 1996 and most recently amended effective January 1, 2022 to permit qualified birth and adoption distributions.

The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan is subject to the provisions of the Internal Revenue Code of 1986 (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA).

### *Setting Every Community Up for Retirement Enhancement (SECURE) Act and SECURE 2.0 Act*

The SECURE Act and the SECURE 2.0 Act had various provisions in effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

### *Contributions*

Participants may elect to defer and contribute pre-tax, Roth, and catch-up contributions to the Plan. A participant's combined pre-tax, Roth, and catch-up contributions cannot exceed the limits set forth under the Code. Participants that have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set as 5% of eligible compensation, as defined, and their contributions are invested in a designated fund until changed by the applicable participant.

The Plan provides for discretionary employer matching contributions for eligible participants. For the year ended December 31, 2024, the Company elected to match 100% of participant contributions up to 5% of their eligible compensation, as defined. For the year ended December 31, 2024, discretionary employer matching contributions totaled \$615,575.

All contributions and compensation are subject to Internal Revenue Service (IRS) limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's discretionary employer matching contributions, an allocation of the Plan's earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan, if any. The allocation of earnings or losses is based on a participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Notes Receivable from Participants*

The Plan permits its participants to obtain loans against their account balances. A participant may borrow from his or her vested account balance, as defined, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance within the last 12 months or 50% of his or her vested account balance.

Loan terms are limited to one to five years with the exception of loans used to purchase a primary residence, which must be repaid in a reasonable period beyond five years. Each participant may only have one loan outstanding at any given time. Participants are allowed to refinance loans, but may not request any additional amounts and the replacement loan term cannot exceed the current loan term. Partial repayments and early loan payoff may be made via a method other than payroll deductions. A participant loan will be considered to be in default if any scheduled repayment with respect to such loan is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Notes receivable from participants are secured by balances in participant accounts and bear interest at the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through regular payroll deductions for actively employed participants.

Upon termination of employment, any outstanding notes receivable from participants are due and payable in accordance with the terms of the underlying provisions of each promissory note. As of December 31, 2024, the rates of interest on outstanding notes receivable from participants ranged from 3.25% to 8.50% with various maturities through 2029.

Certain other restrictions apply to notes receivable from participants as defined in the plan document.

### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant vests in discretionary employer matching contributions based on years of continuous service beginning after his or her first year of service and become fully vested after five years of credited service, as defined. Participants will become immediately vested in all contribution sources upon reaching normal retirement age (65) while still employed, disability while still employed, or death while still employed.

### *Forfeitures*

Forfeitures represent the nonvested portion of terminated participant account balances plus related earnings. These amounts can be used reduce discretionary employer matching contributions or pay the Plan's administrative expenses. As of December 31, 2024 and 2023, forfeitures held by the Plan totaled \$13 and \$8,950, respectively. During the year ended December 31, 2024, \$32,991 of forfeitures were used to offset discretionary employer matching contributions. During the year ended December 31, 2024, no forfeitures were used to pay the Plan's administrative expenses.

### *Payment of Benefits*

Withdrawals may be made from a participant's account upon retirement, death, disability, or termination of employment. The participant's vested account shall be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in a single lump-sum payment or partial withdrawals. Distribution shall be made to an eligible participant from his or her vested account as soon as reasonably practicable following the date the participant's application for distribution is received by the Plan Administrator, but in no event later than the participant's attainment of age 73.

### *Payment of Benefits...continued*

Participants who have attained age 59 1/2 may elect to withdraw all or a portion of their vested accounts while still employed. Hardship withdrawals while still employed are permitted from the applicable participant's vested account, as defined.

A participant may elect to withdraw amounts from his or her rollover contributions account at any time. The Plan also allows for qualified reservist distributions and deemed severance distributions. The Plan Administrator can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance in the Plan less than \$5,000.

Certain other restrictions apply to benefit payments as defined in the plan document.

### *Investment Elections*

Each participant shall direct the investment of his or her account and shall select among various mutual funds and a guaranteed interest account held with an insurance company. Each participant has the ability to change his or her investment allocations at any time.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the trustees, Empower Trust Company, LLC (Empower) and Empower Annuity Insurance Company of America (EAICA). Empower and EAICA are collectively referred to as the Trustees. See Note 3 for discussion of fair value measurements.

A fully benefit-responsive investment contract held by a defined contribution plan is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the contract value of the fully benefit-responsive investment contract. See Note 4 for discussion of the fully benefit-responsive investment contract.

Purchases and sales of investments are recorded on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus any accrued, but unpaid interest. Interest is recorded on an accrual basis. As of December 31, 2024 and 2023, accrued but unpaid interest has been deemed insignificant to the Plan. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from participant to be in default, the notes receivable from participants balance is reduced and a benefit payment is recorded within the statement of changes of net assets available for benefits.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means; or

- if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* – Mutual Funds are valued at the daily closing price as reported by each mutual fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission, which are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 4. Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive investment contract insured by EAICA, which is now subject to the terms and conditions of the group annuity contract and the claims-paying ability of EAICA.

The Plan's contract investment balance is credited with earnings based upon contractually determined interest rates and is charged for the Plan's withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan (1.41% for the year ended December 31, 2024). The issuer establishes an effective annual interest rate quarterly. In no event will such effective annual interest rate be less than the minimum interest rate as defined by the contract.

The guaranteed interest account is included in the financial statements at contract value as reported to the Plan by the issuer. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) material misrepresentation, or (4) a material amendment to the agreement without consent to the issuer. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

The crediting interest rate of the contract is based on an agreed-upon formula with the issuer, as defined in the contract agreement, but cannot be less than the minimum annual interest rate in effect during each annual rate period, and the minimum annual interest rate in effect during any annual period will not be less than the agreement minimum interest rate, as defined.

### **5. Information Prepared and Certified by the Plan's Trustees**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **6. Tax Status**

The Plan has adopted a pre-approved plan in which the IRS determined, by an opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

### **8. Party-in-Interest Transactions**

One of the Plan's investments is a guaranteed interest account managed by an affiliate of Empower and therefore, this transaction qualifies as a party-in-interest transaction as that term is defined in Section 3(14) of ERISA. In addition, the Plan issues notes receivable to participants, which are secured by the balances in participant accounts and constitute party-in-interest transactions.

### **9. Risk and Uncertainties**

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **10. Subsequent Events**

The Plan has evaluated subsequent events for potential disclosure or recognition through October 7, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.
