**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of *Agapé Plastics 401(k) Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the *Agapé Plastics 401(k) Plan* ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of *Agapé Plastics, Inc.* ("Company") who are age 18 or older and who have completed one year of service with a minimum of 1,000 hours. The Plan is subject to the provisions of ERISA.

#### *Contributions*

Participants may contribute elective salary reductions up to 75 percent of their compensation as long as the total contribution does not exceed the legal dollar or percentage limits for the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The Company's safe harbor non-elective matching contributions are contributed at one hundred percent of the participant's first three percent plus fifty percent of the participants next two percent of base compensation contributed to the Plan.

The Company has the right to make discretionary profit-sharing contributions to eligible employees each plan year at the direction of the Company's board of directors. The Company made discretionary profit-sharing contributions of \$348,028 and \$355,775 for the years ended December 31, 2024 and 2023, respectively.

#### *Participant Accounts*

Each participant's account is credited with the participant's elective salary reduction contribution, the Company's matching and profit-sharing contributions, and Plan earnings (losses) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that could be provided from the participant's account.

#### *Vesting*

Participants are immediately vested in their elective salary reduction contributions and the Company's safe harbor matching contributions plus actual earnings (losses) allocated thereon. The Company portion of discretionary non-elective contributions plus actual earnings (losses) are vested to participants ratably over a five-year period.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

*Participant Loans*

Participants may borrow from their fund accounts as determined by the Plan administrator. Participants may borrow a minimum of \$1,000 or any amount that does not exceed 50 percent of the participant's vested account balance as of the end of the accounting period preceding the date on which the loan is approved or \$50,000 reduced by the participants highest outstanding loan balance during the previous 12 months, whichever amount is smaller. The loans are secured by assignment of 50 percent of the borrower's interest in their account and each loan will bear interest at a fixed rate for the life of the loan at a rate as determined by the Plan Administrator which has generally been one percent over the bank's prime rate. Loans for general purposes have terms ranging from 12 months to 60 months while loans related to principal residences can extend out to 120 months.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a period of years. For termination of services due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In-service withdrawals are permitted upon attaining age 59½ or in cases of financial hardship. Separated participants with account balances of less than \$5,000 will be paid in a single lump-sum.

*Plan Forfeitures*

The Plan uses forfeited amounts to reduce future Company contributions. Forfeitures were immaterial to the plan as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

*Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefit payments to participants are recorded when paid.

*Plan Expenses*

Certain administrative expenses of the Plan are paid by the Plan in accordance with Plan provisions. All other administrative expenses, including compensation for officers and employees performing administrative functions, are paid by the Company and are excluded from these financial statements.

*Subsequent Events*

Management has evaluated subsequent events through September 18, 2025, the date on which the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

NOTE 5 - TAX STATUS

The Plan is a nonstandardized volume submitter defined contribution plan of Fidelity Management Trust Company who has been informed by the Internal Revenue Service (IRS), by a letter dated March 31, 2014, that its plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and, therefore, the Plan is tax exempt. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

NOTE 5 - TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by Fidelity Management Trust Company, trustee of the Plan, and Fidelity Investments, recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to provisions of ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
