Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sutter Medical Group 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Sutter Medical Group 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General: Sutter Medical Group is a physician-owned and governed medical group (the "Group" or "Sponsor"), that established the Plan effective January 1, 1998. The Plan is a defined contribution 401(k) plan covering all eligible employees of the Sponsor. The Sponsor is responsible for administration and management of the Plan. All investments in the Plan are participant-directed. Fidelity Management Trust Company ("Fidelity") serves as trustee and custodian for the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Each employee who is not otherwise excluded from participation in the Plan is eligible to participate in the Plan after completing the eligibility requirements stated in the Plan document. The Plan excludes the following:

- Employees whose employment is covered by the terms of a collective bargaining agreement.
- Other various exclusions as defined by the Plan.

Contributions: Each year, participants may make salary deferral contributions in any percentage up to 80% of total eligible gross compensation, as defined in the Plan Document subject to certain IRC limitations. Pre-tax contributions, Roth after-tax contributions, or a combination of both are allowed for regular deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Group makes a quarterly matching contribution equal to 100% of the participant's deferral contribution up to a maximum of 10% of the participant's eligible gross compensation. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Group may also make discretionary profit-sharing contributions to the Plan in amounts determined by the Board of Directors. The Group made a discretionary profit-sharing contribution of 6.66% of each participant's eligible gross compensation up to \$345,000 of compensation for the year ended December 31, 2024. Participants must be employed on the last day of the Plan year to be eligible for profit-sharing contributions.

Vesting: Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Participants are also immediately vested in their portion of the Group's matching and discretionary profit-sharing contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Group's matching and profit sharing contributions, (b) Plan earnings, and (c) charged with his or her withdrawals and on allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years, or longer if used to purchase the primary residence of the participant. The loans are secured by the balance in the participant's account and bear interest at prevailing market rates at the time of borrowing. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of Benefits: Upon termination of employment due to death, disability, or retirement, a participant shall receive a distribution equal to the value of the participant's vested interest in his or her account in one of the following forms: (a) normal form consisting of a qualified joint and survivor annuity, (b) lump sum distribution, (c) an installment distribution consisting of approximately equal annual or more frequent installments over a designated term, (d) a cash-out for vested accrued benefits of \$1,000 or less, or (e) optional forms of annuity payments. For termination of service for other reasons, a participant receives the value of the vested interest in his or her account as a lump-sum distribution or rolled over into an eligible retirement plan. As of December 31, 2024 and 2023, there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

Administrative and Investment Management Expenses: Investment management fees are assessed as a percentage of assets invested and are deducted directly from investment returns. Plan administration fees are either deducted from investment returns or paid by the Plan Sponsor. Transaction based fees are charged directly to the participant's account. The Plan participates in Fidelity's Revenue Credit Program in situations where recordkeeping revenue received in connection with Plan services exceeds agreed-upon compensation and Fidelity deposits amounts ("credits") equal to such excess revenue in a suspense account in the plan. Credits under the Revenue Credit Program reduce the recordkeeping fees otherwise paid by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Group has the right to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, the total net assets of the Plan will be distributed to the participants in accordance with the Plan document and ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosure and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest with no allowance for credit losses as repayment of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Notes receivable at December 31, 2024 bear interest rates ranging from 4.25% to 9.50% and mature through November 2034.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, liquidity, credit, and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to change in valuation assumptions, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Group. No such officer or employee receives compensation from the Plan. Plan administration fees are either deducted from investment returns or paid by the Plan Sponsor. Certain Plan investments are shares of registered investment companies (mutual funds) or self-directed brokerage account assets managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, the trustee and custodian of the Plan and, therefore, these transactions and the Plan's payment of trustee fees, record keeping fees and investment management fees to Fidelity, qualify as party-in-interest transactions, as defined. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code and that the Plan continues to be tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
