### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Claremont Graduate University Academic Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Claremont Graduate University Academic Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Claremont Graduate University Academic Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Claremont Graduate University Academic Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Claremont Graduate University Academic Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter***

## Notes to Financial Statements

---

### Note 1 – Description of the Plan

The following brief description of the Claremont Graduate University Academic Retirement Plan (the Plan) is provided for general information purposes only. Participants and other interested parties should refer to the Plan Document for more complete information.

**General** – The Plan is an Internal Revenue Code (the Code) Section 403(b) plan for eligible employees of Claremont Graduate University (the Institution or Employer). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees except for students and post-doctoral fellows are eligible to participate in the Plan.

**Participant contributions** – Each year, participants may contribute between 1–100% of pretax annual compensation, as defined by the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

**Employer contributions** – Participants must be at least 21 years of age and satisfy certain service requirements which may vary depending on pay grade and type of position to become eligible for employer contributions. Participants whose employment is governed by the terms of a collective bargaining agreement, student employees, and Post-Doctoral Fellows are not eligible to receive employer contributions under the Plan. Employer contributions are discretionary. The Institution contributed 6% of discretionary contribution from January 1, 2024, through December 31, 2024. Participants with compensation exceeding Social Security taxable wage based for the year receive an additional 2%.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with contributions and allocations of Plan earnings and charged with withdrawals and an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances.

**Vesting** – Participants are 100% vested in their accounts at all times.

**Investments** – Investments are participant-directed and are reported at fair value and contract value as certified by the Plan's custodians. Investments offered by the Plan comprise various registered investment companies, group annuity contracts, pooled separate account (PSA), and self-directed accounts, which are guaranteed fixed annuity contracts. Certain mutual funds impose a 2% redemption fee to amounts redeemed or exchanged out of the fund during a 60-day holding period after the initial purchase date. See Note 4 for discussion of fair value measurements.

The Plan invests in two types of Teachers Insurance and Annuity Association (TIAA) Traditional Annuity Account contracts, fully benefit responsive and non-fully benefit responsive contracts. Fully benefit responsive group annuity contracts are presented at contract value on the statements of net assets available for benefits because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals. Non-fully benefit responsive group annuity contracts are presented at fair value on the statements of net assets available for benefits.

## Claremont Graduate University Academic Retirement Plan Notes to Financial Statements

---

**Payment of benefits** – On termination of employment, the normal form of distribution is a joint and survivor annuity for a married participant or a life annuity for an unmarried participant. For a married participant, a qualified joint and survivor annuity will provide equal monthly payments to the participant until the participant's death. Upon death of the participant, the surviving spouse will receive 50% of the participant's monthly payment. Alternatively, a participant may elect to receive a lump-sum amount equal to the value of the participant's account or substantially equal installments over a specific period of time.

**Plan loans** – A participant may borrow from TIAA a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of his or her account balance secured by his or her TIAA Traditional Annuity Account balance. The participant is required to maintain a balance equal to at least 110% of his or her outstanding loan in the TIAA Traditional Annuity Account. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. Principal and interest are paid directly by the participant to TIAA and each payment will reduce amounts secured by the participant's TIAA Traditional Annuity Account. Loans bear interest at rates that may be fixed or variable, depending on the annuity contract provisions, but participants' accounts are credited only with the guaranteed rate provided under the TIAA Traditional Annuity Account. Outstanding loans totaled \$0 and \$5,173 as of December 31, 2024 and 2023, respectively. There were no loans in default as of December 31, 2024 and 2023. Effective August 16, 2019, the Plan no longer offers Plan loans.

**Notes receivable from participants (participant loans)** – Effective August 16, 2019, a participant may borrow directly from his or her account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance secured by his or her TIAA Traditional Annuity Account balance under the Retirement Plan Loans (RPL) from mutual funds or annuity contracts. Loans from a TIAA Annuity other than an RPL loan follow a maximum threshold equal to the lesser of \$50,000 or 45% threshold of his or her account balance secured by his or her TIAA Traditional Annuity Account balance. Participants may have a maximum of two loans outstanding at any one time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan Fund. The loans are secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Loans bear interest at a variable rate determined by TIAA. Principal and interest are paid directly by the participant to TIAA. As of December 31, 2024 and 2023, the Plan had \$176,201 and \$168,099 in outstanding participant loans, respectively. At December 31, 2024, interest rates ranged from 4.25%–9.50%, with maturity dates through July 2029.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Payment of benefits** – Benefits are recorded when paid.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate changes, market fluctuations, and credit risks. Due to the risk associated with certain investments, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Administrative expenses** – The Plan's administrative expenses, custodial fees, and investment expenses are charged to participants' accounts (netted against earnings). Certain transaction fees are paid by the participants.

### Note 3 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and College Retirement Equities Fund (CREF), qualified institutions:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest income on notes receivable from participants, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the supplemental schedule of assets (held at end of year).

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies and the pooled separate account are valued at the daily closing price as reported by the fund. Shares are valued at quoted market prices, which represent net asset value of shares held by the Plan at year end.

The Plan also has a self-directed account option that allows participants to invest in all publicly traded stocks and mutual funds, which are valued at quoted market prices at year end.

The Plan has investments in the non-benefit responsive TIAA Traditional Annuity Contracts, which are presented at fair value on the statements of net assets available for benefits. Transactions involving the purchases and sales of individual TIAA Traditional Annuity Contracts are not observable in a public marketplace, but contract value is a good approximation of fair value as supported by the fact that new contributions represent current transactions between willing buyers and sellers as prescribed in the relevant GAAP guidance. As these transactions continue to occur with continued participant contributions at current stated contract values, the market-observable presumption is that the contract value of current funding represents a good approximation of fair value based on the willingness of the participant to continue to contribute. For each contribution, TIAA continues to record a contractual liability for the current contribution and does not consider such liability to have any embedded gain or loss. The Plan holds Retirement Annuity (RA) and Retirement Choice Annuity (RC) contracts, which have liquidity restrictions and are considered non-benefit responsive. RA contracts are no longer offered. Existing RA contracts continue to be held by the Plan; however, any new contributions, rollovers, and external transfers are being directed into the RC annuity contract.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis.

The significant unobservable input used in the fair value measurement of the TIAA Traditional Annuity is the risk-adjusted market discount rate. Significant increases (decreases) in this input in isolation would result in a significantly lower (higher) fair value measurement.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 – Guaranteed Investment Contract with TIAA**

The Plan has investments in fully benefit responsive TIAA Traditional Annuity Contracts, in which contributions are maintained in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses.

The TIAA Traditional Annuity is an unallocated fixed-rate guaranteed annuity offered by TIAA, an insurance company, available as an investment option to plan participants. Contributions to the TIAA Traditional Annuity purchase a contractual or guaranteed amount of future benefits for the participant. The guarantees and returns of the TIAA Traditional Annuity are backed by the claims paying ability of TIAA and are dependent on TIAA's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. The Plan holds Group Supplemental Retirement Annuity (GSRA), Supplemental Retirement Annuity (SRA), and Retirement Choice Plus Annuity (RCP) contracts, which have no liquidity restrictions and are considered fully benefit responsive. GSRA and SRA contracts are no longer offered. Existing GSRA and SRA contracts continue to be held; however, any new contributions, rollovers, and external transfers are being directed into the RCP annuity contract.

RCP TIAA Traditional Annuities provide a guaranteed minimum rate of interest of 1.00% to 3.00% for all premiums plus the potential for additional amounts that may be declared by TIAA on a year-by-year basis and are not guaranteed for future years. GSRA, and SRA TIAA Traditional Annuities provide a guaranteed minimum rate of interest of 3.00%. When declared, additional amounts remain in effect for the 12-month period that begins each March 1. Together the minimum rate of interest and the potential additional amounts make up the crediting rate.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Institution has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed based on individual participant account balances.

### **Note 7 – Tax Status**

The Plan Document is a volume submitter 403(b) plan that received a favorable opinion letter from the Internal Revenue Service dated August 7, 2017, which stated that the Plan, as then designed, was in accordance with applicable sections of the Code. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with guidance on accounting for uncertainty in income taxes, Plan management has evaluated the Plan's tax position and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8 – Party- In- Interest Transactions**

Certain Plan investments are managed by the custodians or their affiliates. Any purchases and sales of these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

**Revenue sharing** – The Plan has an agreement with TIAA in which TIAA will fund a revenue credit account in the Plan based upon revenues generated by the Plan. The revenue credit account funding amounts are based on the reconciliation of the actual revenue for the Plan versus the revenue requirement stated in the agreement on a semi-annual basis. The amount so determined to be in excess of TIAA's revenue requirement is deposited to the revenue credit account in the Plan approximately 60 days after the end of each semi-annual period.

The revenue credit account may only be used to pay direct, reasonable, and necessary expenses of the Plan, if permitted by the Plan, or to provide benefits to participants. Such revenue credits can be paid to participants' accounts on a pro rata basis at the end of the Plan year at the election of the Institution. Payments from a revenue credit account directly to the Institution may be made under certain circumstances. The amounts earned during 2024 and 2023 in the TIAA Traditional Annuity Benefit Responsive Account are immaterial.

### **Note 9 – Subsequent Events**

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 1, 2025, the date on which the financial statements were available to be issued.

#### **Note 10 – Reconciliation of Financial Statement to Form 5500**

The Form 5500 has certain items that differ from amounts shown in the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
