Management, having determined it is permissible in the circumstances, has elected to have the audits of Jolt Credit Union 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Jolt Credit Union 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jolt Credit Union 401(k) and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that,

individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures,

including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the Jolt Credit Union 401(k) and Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan with a 401(k) elective deferral arrangement, which covers substantially all eligible employees of Jolt Credit Union (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees that are age 21 and over are eligible to participate in the Plan upon attaining 90 days of service. Employees are eligible for employer matching and nonelective profit sharing upon obtaining one year of service. Through December 31, 2023, part-time employees working less than 1,000 hours per year, temporary, and seasonal employees were excluded from the Plan; however, starting January 1, 2024, the Plan was amended to allow all employees who meet the age and days of service eligibility requirements to join the Plan.

Contributions

The Plan allows participants to defer up to the maximum contribution allowable by the Internal Revenue Code (IRC), adjusted annually for cost-of-living changes. There is no minimum elective deferral limit for the Plan. Rollover contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants must have achieved one year of service to receive employer contributions. Employer contributions begin the quarter after the service requirement is met. The Company contributes employer flexible discretionary dollar-for-dollar matching contributions (3.00% for 2024 and 2023). In addition, annual profit sharing contributions are at the discretion of the Company (1.00% for 2024 and no contribution for 2023). Participants receive the profit sharing contribution regardless of whether or not they contribute to the Plan; however, the participant must be employed on the last day of the Plan year to receive the profit sharing contribution (unless retired, disabled, or terminated due to death).

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document.

The participant has the responsibility to decide how his or her contributions (including their portion of employer contributions) will be invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, employer flexible discretionary matching contributions, and rollover contributions plus actual earnings thereon. Participants are 100% vested in profit sharing contributions after attaining three or more years of service.

Payment of Benefits

Plan participants are eligible to receive distributions upon reaching retirement age of 65. Participants are eligible to make in-service withdrawals upon reaching age 59 ½. Participants qualify for early retirement at age 55 with at least 5 years of service. Hardship withdrawals are allowed to pay certain qualifying expenses, as defined in the Plan document. In addition, upon separation of employment, because of death, disability, or for other reasons, participants receive their benefits as a lump-sum payment, equal installments, or partial withdrawals of \$1,000 or more. Through December 31, 2023, participants with a distributable event and \$5,000 or less in their account are automatically distributed, and starting January 1, 2024, this Plan provision was amended to increase the threshold to \$7,000 or less.

Forfeited Accounts

Forfeitures of employer contributions shall be used to reduce the employer's contributions to the Plan. There was a balance of \$294 of forfeited nonvested accounts as of December 31, 2024 (no balance as of December 31, 2023). During 2023, employer contributions were reduced by \$468 from forfeited nonvested accounts (no reductions in 2024).

1. Description of Plan (continued)

Administrative Expenses

Certain administrative expenses were paid for by the Company. Additionally, certain administrative expenses were paid by the Plan and are reflected in the accompanying financial statements.

Notes Receivable from Participants

Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Such loans are secured by the balance of the participant's account and shall be charged an annual prevailing rate of interest to be fixed by the Plan administrators. Such loans shall be fully repaid on or before five years (15 years for home loans) from the date of disbursement.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon terms in the Plan's loan policy.

Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy.

The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value, except the Key Guaranteed Portfolio Fund which is stated at contract value. Shares of mutual funds are valued at quoted market prices in an active market, which represents the value of shares held by the Plan at year end. See Note 5 for further information on the Key Guaranteed Portfolio Fund. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statements of changes in net assets available for benefits as net appreciation/(depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

3. Financial Data Certified by the Trustee – Unaudited

The Plan's financial information and data was certified by Empower Annuity Insurance Company of America (Empower) as of and for the years ended December 31, 2024 and 2023, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the participant directed investments, notes receivable from participants, interest and dividends, and net appreciation/depreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by Empower. This certified information has not been audited by independent auditors.

4. Fair Value Measurements

5. Key Guaranteed Portfolio Fund

The Plan invests in the Key Guaranteed Portfolio Fund through a group annuity contract with Empower. The Key Guaranteed Portfolio Fund (“Fund”) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The interest crediting rate is reset quarterly. The average interest earned by the Fund and Plan was 1.41% for the year ended December 31, 2024 and 1.23% for the year ended December 31, 2023. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participant transfers may be restricted for up to 30 days in the event of excessive participant trading. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Plan and Fund can terminate the contract with at least 60 days’ notice.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. At termination, participant accounts would become fully vested.

7. Income Tax Status

The Plan utilizes a volume submitter plan adopted through NFP Retirement, Inc. The volume submitter plan obtained its latest opinion letter as of June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Although the Plan has been restated (effective January 1, 2021) since receiving the opinion letter, the Plan administrators believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax is included in the accompanying financial statements.

7. Income Tax Status (continued)

Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

8. Party-in-Interest Transactions

Certain investments are managed by Empower (the Plan's trustee) or affiliates of Empower, therefore qualifying as a party-in-interest. NFP Retirement Inc. (third-party administrator to the Plan), Hornor, Townsend, & Kent LLC (broker and advisor), Michael T. Stelter & Associates (advisor), and Andrews Hooper Pavlik (auditor) provide services to the Plan; therefore, they qualify as parties-in-interest. Notes receivable from participants are also considered party-in-interest transactions. During 2024, the Plan entered into an agreement to distribute automatic rollovers to Millennium Trust Company (subsequently rebranded as Inspira Financial); therefore, they qualify as a party-in-interest. During 2025, the Plan entered into an agreement with LeafHouse Financial for investment fiduciary services; therefore, they qualify as a party-in-interest.

9. Risk and Uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and long-term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
