NOTE 1 - DESCRIPTION OF PLAN

A. General

The Plan is a defined contribution plan in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all non-excluded full time employees of Inland Tarp & Cover Inc. (Plan Sponsor) and its related entities, who have 3 months of service and are age eighteen or older. Employees are able to participate in the Plan Sponsor's matching contribution after 3 months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). This description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

B. Contributions

The Plan has an automatic enrollment provision (3 percent salary deferral) whereby employees must elect out of the Plan if they do not wish to participate. Each year participants may contribute up to the maximum percentage allowable by the IRC, plus catch-up contributions, if applicable, of pretax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan Sponsor matches 100 percent of the first 3 percent of salary deferrals, plus 50 percent of salary deferrals between 3 to 5 percent of base compensation that a participant contributes in the Plan year.

C. Participant accounts

Each participant's self-directed account is credited with the participant's contribution and allocations of the Plan Sponsor's contribution and Plan earnings, and charged with an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant weighted account balances, as directed in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon as well as the Plan Sponsor's matching contributions.

E. Payment of benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump sum amount equal to the value of the participant's vested interest in their account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The financial statements of the Plan are prepared utilizing the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S.GAAP).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

B. Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

D. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

E. Payment of benefits

Benefits are recorded when paid.

F. Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - INVESTMENTS

During the year ended December 31, 2024, the Plan's investments (including dividends, gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$1,096,687.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments in the pooled separate accounts (PSA) are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian of the Plan's assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The PSA is comprised of shares or units of underlying funds that are valued at the net asset value (NAV) of shares held by the Plan at year end. Underlying assets in these funds primarily include publicly traded equity securities and fixed income securities and are valued at their NAVs calculated by John Hancock Life Insurance Company and have a daily liquidity.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - INCOME TAX STATUS

The Plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the IRC and therefore the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Plan management believes the Plan is no longer subject to income tax examinations for years prior to 2021, which is the standard statute of limitations look back period.
