Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Goldenwest Diamond Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Goldenwest Diamond Corporation 401(k) Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Trust Company, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in Goldenwest Diamond Corporation 401(k) Plan's internal control to be significant deficiencies:

- During the year, the Company remitted employee deferrals for two pay periods outside of the timeframe required by the Department of Labor. We recommend implementing formal procedures to ensure all contributions are deposited as soon as administratively feasible following each payroll cycle, in accordance with DOL guidelines.
- The Plan experienced a lapse in ERISA bond coverage following its transition from the prior recordkeeper, with no bond in place for the start of the 2024 plan year. We recommend that the Company establish a process to monitor ERISA bond compliance on an ongoing basis. A new bond was obtained in April 2025.
- Contributions for a single payroll were deposited three times in error, resulting in excess participant account balances. We recommend implementing a review and reconciliation step prior to submitting contribution files to the recordkeeper to prevent duplicate submissions. The Company is working with the recordkeeper to reverse the duplicate transactions.

Internal financial statements could contain errors which could result in a material misstatement of the financial position of the Plan.
