Years ended December 31, 2024 and 2023

1. Description of Plan

The following description of the People's Trust Insurance Co. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established and made effective January 1, 2009, and restated effective May 1, 2022, for the benefit of the employees of People's Trust Insurance Co. (the Company) and its affiliates Rapid Response Team, LLC and PTI Agency, dba TopLine Agency. The Plan and the Trust of which it is a part of are intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's Sponsor and Administrator. The Plan's Recordkeeper is Empower Retirement (Empower). Its directed Trustee is Great-West Trust Company, LLC (Great-West) and its investment advisor is Pulles & Attento Wealth Management. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Eligibility

The Plan covers all full-time employees of the Company and its affiliates Rapid Response Team, LLC and PTI Agency, dba TopLine Agency, with the exception of interns, leased, union, part-time, and temporary employees with less than 1,000 hours of service. Eligible employees may become a participant and defer a portion of their annual compensation on the first day of the quarter (January 1, April 1, July 1, or October 1) following the attainment of their eighteenth birthday and one month of service.

Notes to Financial Statements

1. Description of Plan (continued)

Contributions

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may contribute a percentage of pre-tax or post-tax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may distribute a discretionary match contribution, which is determined by the Company annually. During 2024, the Company contributed a qualified matching contribution of 25% of each participant’s 2024 contribution to the Plan. Additional profit sharing contributions may be made at the discretion of the Company's Board of Directors and none were made during 2024. Discretionary matching and profit sharing contributions are invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, as well as allocations of the Company’s profit sharing contribution, when applicable, and Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions portion of their accounts and earnings thereon is based on years of continuous service. Participants become 20% vested after one year of service, 20% more each year thereafter, until 100% vested when the participant attains five continuous years of service.

Payment of Benefits

On termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$7,000 may elect to receive a lump-sum cash payment, installment payments, or have assets rolled to another qualified retirement plan. If the participant's vested account balance is between \$1,000 and \$7,000 as of the termination date and instructions to make a distribution are not made, the vested account balance will be rolled over to an Individual Retirement Account (IRA) selected by the Plan Administrator. A single lump-sum distribution will be made to terminated participants whose vested balance as of the termination date is less than \$1,000.

1. Description of Plan (continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. One outstanding loan is allowed at a time. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. The interest rate on any loan to a participant shall be a reasonable interest rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. For the year ended December 31, 2024, the interest rate is set at 1% over the prime interest rate.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$77,649 and \$91,470, respectively. These accounts are used to reduce employer contributions or pay plan expenses. During 2024, \$94,521 of forfeitures were used to reduce employer contributions and \$578 of forfeitures were used to pay plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments, other than the fully benefit-responsive investment contract discussed in Note 3, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodian, and insurance company. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to October 3, 2025, the Plan did not have any material recognizable subsequent events.

3. Guaranteed Investment Contract with Empower

The Plan is invested in a Guaranteed Interest Account (GIA) provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as "book value." The contract meets the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

3. Guaranteed Investment Contract with Empower (continued)

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIA. The GIA is presented on the face of the statements of net assets available for benefits at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract; (2) partial or complete plan termination; (3) plan disqualification; or (4) the issuer provides at least ninety days notice of termination. Consult your Plan's contract for further information. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

6. Tax Status

The Plan has not requested a determination letter from the Internal Revenue Service (IRS) regarding the Plan's exemption from federal income tax under Section 401(a) of the IRC. However, effective May 01, 2022, the Plan adopted a nonstandardized pre-approved profit sharing plan sponsored by Empower Retirement. The Plan has received an opinion letter from the IRS as to the pre-approved profit sharing plan's qualified status. The pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provision of the IRC, and as such, no provision for income tax has been included in the Plan's financial statements.

7. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Information Certified by Empower

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement (the Recordkeeper of the Plan), a qualified institution.

10. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by Empower, the Plan's Recordkeeper. Transactions involving these investments are considered to be party in interest transactions. Administrative expenses totaling \$81,029 were paid by the Plan for the year ended December 31, 2024.
