We have performed audits of the accompanying financial statements of Ozarks Coca-Cola/Dr Pepper Bottling Company Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

Years Ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Ozarks Coca-Cola/Dr Pepper Bottling Company Profit Sharing 401(k) Plan (Plan), sponsored by Ozarks Coca-Cola/Dr Pepper Bottling Company (Company), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of the Company who have 250 hours of service in a three month period and are age 18 or older. The Plan does not cover those employees who are employed under a collective bargaining agreement (union). As of January 1, 2023, the Plan was amended to designate all employer matching contributions as safe harbor contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

Contributions: Each year, participants may contribute up to 100% of their annual wages, subject to certain IRS limitations, as defined in the Plan through pre-tax contributions or as after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Company makes discretionary profit sharing contributions to the Plan which is an amount determined by the Board of Directors equal to a percentage of the participant's eligible wages. The Company profit sharing contribution rate for 2024 and 2023 was 3% and totaled \$991,269 and \$915,177, respectively. The Company makes matching contributions equal to a discretionary percentage of the participant's salary reductions. For 2024 and 2023, the safe harbor matching percentage was 100% of participants' elective salary reductions up to 4% of eligible wages and totaled \$1,082,699 and \$1,093,200, respectively.

Participant accounts: Each participant's account is credited with (a) the participant's contribution, (b) the Company's profit sharing and matching contributions, (c) forfeiture allocations, if any, as an additional Company contribution and (d) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their contributions plus actual earnings thereon. As of January 1, 2023, participants are immediately 100% vested in their safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's matching contribution prior to January 1, 2023 and the profit sharing portions of their accounts are based on years of continuous service. A participant is 100% vested after five years of credited service.

Years Ended December 31, 2024 and 2023

Payment of benefits: A distribution of a participant's vested account balance can be made due to hardship, attainment of age 59 ½, death, disability, retirement, qualified military service, when required by law, or upon termination of service with the Company. A distribution of a participant's rollover balance can be made at any time regardless of the limitations described above.

Participants who terminate service and have account balances of \$1,000 or less will receive an automatic distribution of that balance. Participants with balances greater than \$1,000 but less than \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the Company, unless the participant elects direct distribution or other eligible direct rollover. Participants with account balances that exceed \$5,000 may elect to receive a lump-sum amount equal to the value of the vested interest in their account or installments for a fixed period not to exceed their assumed life expectancy.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Recognition of service: For purposes of satisfying the service requirements for vesting, eligibility, and hours of service, the Plan recognizes service with Coca-Cola Refreshments.

Forfeitures: All forfeited nonvested accounts were used at December 31, 2024 and 2023. Plan expenses of \$17,735 and \$7,960 were paid from forfeited nonvested accounts during 2024 and 2023, respectively. Forfeitures in the amount of \$106,302 and \$113,002 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. Forfeitures can be used to pay plan expenses, reduce future employer contributions or they can be reallocated to participants as an additional contribution.

2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and October 7, 2025, the date the financial statements were available to be issued.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, a qualified institution.

5. Related-Party Transactions & Party In Interest Transactions

The Plan holds investments in funds managed by the Plan's asset custodian, John Hancock Life Insurance Company. Investments in John Hancock Life Insurance Company funds totaled \$42,901,424 and \$36,167,666 at December 31, 2024 and 2023, respectively.

A portion of the administrative costs of the Plan are paid by the Company. Certain employees of the Company serve as the Plan's administrator and trustees. They do not receive any compensation for services rendered to the Plan.

6. Tax Status

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Group annuity pooled separate accounts (PSAs): Valued at the net asset value of the units held by the group annuity contract provider using the quoted net asset value of the shares of the underlying mutual funds adjusted for any dividends or distributions received by John Hancock Life Insurance Company and the daily equivalent of any fee charged pursuant to the contract. Mutual funds are registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

9. Separated Participants

At December 31, 2024, \$138,052 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor with a vested balance of less than \$5,000 and are due a distribution in accordance with the plan document.

10. Transfer from Related Plan

During 2024, account balances totaling \$167,810 were transferred from the Ozarks Coca-Cola/Dr Pepper Bottling Company Union 401(k) Plan for participants who are no longer classified as union employees.
