We have performed an audit of the accompanying financial statements of American Computer Development, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### NOTE A - DESCRIPTION OF PLAN

The following description of American Computer Development, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Readers of these financial statements should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees other than union employees, non-resident aliens, leased employees, temporary/seasonal employees and independent contractors who have completed 90 days of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to defer a portion of pretax and post-tax eligible compensation into the Plan, up to the maximum allowed by the Internal Revenue Code. In addition, the Plan allows for catch up contributions by employees aged 50 years and older before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan's provisions as rollover contributions.

The Company may contribute discretionary matching contributions and discretionary non-elective contributions to eligible participants as a percentage of a participant's elective deferral. The Company shall set such percentage prior to the end of the Plan year. For 2024, the discretionary matching contributions were 50% of salary deferrals up to 6% of participants compensation, up to participant's contribution calculated on a per payroll period basis with a year-end true up. Employer matching contributions are invested in funds, as directed, by participants. The Company contributed \$194,635 and \$162,277 for the years ended December 31, 2024 and 2023, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary contributions, Plan earnings, losses, and Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Two loans can be outstanding at a time. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% and mature through December 2044. Loan terms range from one to five years except for the purchase of a primary residence. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary non-elective contribution portion of their accounts, plus actual earnings thereon, is based on eligible years of service. A participant is 100% vested after three years of credited service. Vesting of credited service is as follows: 25% after one year of service, 50% after two years of service and 100% after three years of service. In addition, participants become 100% vested in the case of death, permanent disability, or upon attaining retirement age.

### NOTE A - DESCRIPTION OF PLAN (continued)

#### ***Forfeited Accounts***

At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0, respectively. The forfeited accounts may be used at the discretion of the Company to reduce Company contributions or to pay administrative fees incurred by the plan. During the years ended December 31, 2024 and 2023, forfeitures in the amount of \$7,827 and \$5,723, respectively, were applied to reduce Company contributions.

#### ***Payment of Benefits***

On termination of service, death or retirement a participant is entitled to receive a distribution of the full amount in that participant's salary reduction and rollover contributions as well as his vested interest in the Plan's contribution. For distributions of \$7,000 or less, the Plan can make an involuntary distribution.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Accounting***

The financial statements of the Plan have been prepared using the accrual basis of accounting where revenues are recognized when earned and expenses are recognized when incurred. The accrual basis of accounting conforms to accounting principles generally accepted in the United States.

#### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

At December 31, 2024, all of the Plan's invested assets are held at John Hancock Life Insurance Company, which invests funds based on the recommendations of each fund's manager. Investments are reported at fair value. Fair value is the sale price that would be received to sell an asset or price paid to transfer a liability in a typical transaction between market participants at the date of measurement. Plan management assesses and establishes the Plan's valuation policies using information provided by the custodians of the investments. See Note H for discussion of fair value measurements. Investment assets, transactions, and income as presented in the financial statements and supplemental schedule were certified by the trustees to be complete and accurate.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held, during the year.

#### ***Participant Loans***

Participant loans in the Plan are recognized when granted to eligible plan participants. The Plan recognizes these loans as assets on its balance sheet. Participant loans are initially measured at the principal amount disbursed to the participant and are subsequently measured based on the amortization of the loan balance. Interest is recognized using the effective interest rate method over the life of the loan.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### **Plan Expenses**

Either the Plan or the Plan sponsor, as provided in the Plan document, pays administrative expenses of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Plan Amendment**

During 2024, the Plan was amended to credit service with a predecessor employer and employees will receive credit for all years of eligibility service with Qinetiq, Inc.

#### **Reclassification**

Certain amounts reported for 2023 have been reclassified to conform to the 2024 presentation. Such reclassifications had no effect on the reported net income.

### NOTE C - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company has certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate. Investments certified by the custodian totaled \$8,184,443 and \$7,001,097 as of December 31, 2024 and 2023, respectively. Investment gain totaled \$681,951 for the year ended 2024.

### NOTE D - RELATED PARTY TRANSACTIONS

John Hancock Life Insurance Company, the custodian as defined by the Plan, and Tiger's Eye Benefits Consulting, was the Third Party Administrator; therefore, transactions with the custodians qualify as party-in-interest transactions. Fees paid by the Plan totaled \$7,927 and \$5,693 for the years ended December 31, 2024 and 2023, respectively.

### NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, the Plan assets shall be distributed in accordance with the terms of the Plan.

### NOTE F - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan adopted the provisions of Statement of Financial Accounting Standard ASC Topic 740, *Income Taxes* (ASC 740). ASC 740 prescribes a comprehensive model for recognizing, measuring, presenting, and disclosing in the financial statements tax positions taken or expected to be taken on a tax return, including positions that the Plan took since issuance of ASC 740. The adoption of ASC 740 resulted in no changes to the Plan's beginning balances and net assets available for benefits.

With few exceptions, the Plan is no longer subject to income tax examination by the U.S. Federal, state, or local tax authorities for the previous three years.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE H - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Pooled Separate Accounts**

Separate accounts are privately managed investment accounts that use pooled money to purchase individual assets. They differ from mutual funds because investors directly own the securities purchased instead of owning a share of the pool in the securities. While the underlying assets values are quoted prices, the net asset value (NAV) of separate accounts are not publicly quoted. NAV per share is allowed to serve as a practical expedient to estimate the fair value.

Total amount of gains and losses (realized and unrealized) included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 are reported in net change in fair value of investments.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers into or out of Levels 1, 2 or 3.

#### NOTE I - INVESTMENT CONTRACT WITH JOHN HANCOCK LIFE INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with John Hancock Life Insurance Company (John Hancock). John Hancock maintains the contributions in a general account, the Reliance Metlife Stable Value Fund. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

### NOTE I - INVESTMENT CONTRACT WITH JOHN HANCOCK LIFE INSURANCE COMPANY

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. This contract is included in the financial statements at contract value, as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management has determined that contract value of \$218,766 and \$192,930 approximates fair value for this contract as of December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

### NOTE J - SUBSEQUENT EVENTS

The Plan adopted Statement of Financial Accounting Standard ASC Topic 855, *Subsequent Events* (ASC 855). ASC 855 establishes general standards of accounting for and disclosure of events that occur after the balance sheet date but before the financial statements are issued or are available to be issued.

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
