**Note 1 - Description of the Plan**

The following brief description of the E Ink Corporation 401(k) Savings Plan is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The E Ink Corporation 401(k) Savings Plan (the Plan) is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan covers all employees of the Plan's sponsor, E Ink Corporation.

The Plan includes an employees' thrift savings plan established under the provisions of Internal Revenue Code Section 401(k). Under the savings plan, a certain percentage of employees' wages, as defined in the Plan, can be deferred as an employee contribution to the Plan.

**Enrollment** - All employees are eligible to participate in the Plan upon commencement of employment with the Company. Employees who first become eligible to participate in the Plan on or after July 15, 2005, who fail to affirmatively make any deferral election (including an election to contribute 0% of eligible compensation) within the time prescribed by the Administrator, shall be deemed to have elected to defer 3% of eligible compensation as a pre-tax contribution. Participants may change such deferral percentage at any time. The plans Qualified Default Investment Alternative fund is the managed account service for participants age 45 or older and the American Funds target date fund, aligned with the participants birthday and projected retirement date, for participants less than 45 years of age. (Reference is made to the Investment Options section.)

**Contributions** - Participants may contribute up to 75 percent of pretax annual compensation, as defined in the Plan. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans. Additional matching and profit sharing amounts may be contributed at the option of the Company's board of directors. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to the first 3 percent of eligible compensation that a participant contributed to the Plan. This matching contribution was fully remitted to the plan in March 2025. Generally, participants must be employed on the last day of the plan year and have a minimum of 1,000 hours of service during the year to be eligible to receive employer matching contributions. Contributions are subject to certain limitations and eligibility requirements apply to such contributions.

**Participants' Accounts** - Each participant account is credited with (a) the participant's contributions, (b) earnings, (c) expenses, and (d) Company discretionary matching contributions and an allocation of profit sharing contributions, if any. Allocations of the Company's profit sharing contributions are based on participant compensation. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the employer discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after four years of credited service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined regularly by the plan administrator. Principal and interest are paid ratably through payroll deductions. Generally, notes must be repaid within five years unless being used to purchase a principal residence. Participants may have one note outstanding at a time.

**Investment Options** - Upon enrollment in the Plan, a participant may direct their contributions in one percent increments to various investment options comprised of various mutual funds with a range of investment objectives, including stock investments, bond investments and blended investments. Additional investment options include an investment contract and a self-directed brokerage account through which participants are able to invest in a variety of publicly traded investments and interest bearing cash accounts. Participants may reallocate their funds or redirect new contributions on a daily basis among any of the offered funds. The plan also offers a managed account service in which participants are able to have an advisory service manage their account balance among available investment fund options within the plan. Participants may opt-out of the managed account service, at any time. Additionally, as participants reach age 45, their funds will automatically be invested under the managed account service, unless the participant chooses to opt-out.

**Payment of Benefits** - On termination of service, a participant may generally elect to receive the value of his or her account in a lump-sum cash payment, a rollover distribution to an eligible retirement account, or if the balance is greater than \$7,000, elect to defer payment of benefits until a minimum distribution is required to be made. Participants may also withdraw from their vested accounts upon the attainment of age 59 ½ or upon certain hardship situations defined in the Plan.

**Plan Termination** - Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent vested in their accounts.

**Forfeited and Unallocated Accounts** - At December 31, 2024 and 2023, unallocated forfeitures amounted to \$35,670 and \$23,928, respectively. Forfeitures may be used to (1) pay administrative expenses or (2) reduce employer contributions. During 2024 forfeitures in the amount of \$23,928 were used to reduce the employer match contribution for 2023. As of December 31, 2024 and 2023, the plan had additional unallocated amounts of \$1,289 and \$1,718, respectively, which represents plan investment income designated to pay plan expenses.

**Administrative Costs** - If the Company does not pay the Plan's administrative costs, costs are permitted to be paid from Plan assets. Such expenses will either be paid from the Plan's forfeitures account or allocated to participant accounts as more fully described in the plan documents. Additionally, certain fees are directly paid by the Plan's participants and include fees for origination of notes receivable from participants, distributions, hardship distributions, the preparation of Qualified Domestic Relations Orders (QDROs) and the preparation of IRS form 1099.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with U.S. generally accepted accounting principles. Benefit payments are accounted for at the time of payment.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in the net assets available for benefits during the reporting period, and the disclosures of contingent assets and liabilities, if applicable, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - All investments are recorded at fair value in these financial statements, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is measured in accordance with U.S. generally accepted accounting principles as more fully described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses include the plan's gains and losses on investments bought and sold as well as held during the year.

In accordance with U.S. generally accepted accounting principles, investment contracts held by a defined contribution plan are required to be reported at contract value if the investment contract is deemed fully benefit responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions in accordance with terms of the plan document.

**Income Tax Status** - Effective January 1, 2022, the E Ink Corporation 401(K) Savings Plan is utilizing an Angell Pension Group 401(k)/Profit Sharing Non-Standardized Plan. The Non-Standardized Plan being utilized obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service state that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan, in effect as of each applicable date, is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions as required by U.S. generally accepted accounting principles. As of December 31, 2024, the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan's informational returns are subject to potential examination by the appropriate regulatory authorities for the prior three years. Currently, there are no audits in progress for any tax periods.

**Subsequent Events** - The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Certain information related to investments and fully benefit-responsive investment contracts disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and investments, at contract value held at December 31, 2024 and 2023, and all investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodian and trustee of the Plan.

**Note 4 - Fair Value Measurements**

Fair value is defined under U.S. generally accepted accounting principles as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan is required to maximize the use of observable inputs, minimize the use of unobservable inputs, and disclose in the form of an outlined hierarchy the details of such fair value measurements. The hierarchy of valuation techniques is based on whether the inputs to fair value measurement are considered to be observable or unobservable in a marketplace. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. The hierarchy requires the use of observable market data and gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). When available, these inputs have created the following fair value hierarchy:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets in active markets or quoted prices for identical assets in inactive markets.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in estimating the value of the assets.

Following is a description of the Plan's valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds*

These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund and calculated at the close of business on the NYSE. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds are classified within Level 1 of the valuation hierarchy.

*Self-Directed Brokerage Accounts*

The plan's self-directed brokerage accounts consist of interest bearing cash and cash equivalents, mutual funds, publicly traded corporate stock investments, and unit investment trusts. Fair value of mutual funds, unit investment trusts and corporate stock within the self-directed brokerage accounts is determined by quoted market prices of the securities in an active market on the last day of the plan year. Interest bearing cash accounts within the self-directed brokerage accounts are considered equivalent to cash. Investments in self-directed brokerage accounts are classified within Level 1 of the valuation hierarchy.

**Note 5 - Investment Contracts with Insurance Company**

The Plan holds a fully benefit-responsive traditional investment contract with Empower Annuity Insurance Company of America that invests contributions in the Empower Investments Fixed Accounts - Series IV. The contract value of the investment contract at December 31, 2024 and 2023 amounted to \$4,365,437 and \$2,106,082, respectively. The Empower Investments Fixed Accounts - Series IV is a general account product guaranteed by the general account assets of Empower Annuity Insurance Company of America. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly and may not be less than 0%. Average yield on the guaranteed investment contract earned by the participants of the Plan was 2.16% for the year ended December 31, 2024.

The contract is included in the financial statements at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, could limit the Plan's ability to transact at contract value with the issuer. Examples of circumstances which would allow the issuer to terminate the contract include the Plan's loss of its qualified tax status or material and adverse changes to the provisions of the Plan. If either of these events were to occur, the issuer could terminate the contract at amounts less than contract value or require a twelve month termination period. The plan administrator believes that the occurrence of such events that would limit the Plan's ability to transact at contract value with plan participants is not probable.

**Note 6 - Related Party Transactions**

Plan investments include the guaranteed investment contract issued and managed by Empower, which is related to the trustee of the Plan. Accordingly, certain transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, fees totaling \$186,481 were charged and allocated to participant accounts on a pro rata basis. These fees were paid to the Plan's record keeper, Empower in an amount of \$72,993 and for investment management in an amount of \$113,488. Additional fees of \$6,235 charged by Empower related to specific distributions, have been directly charged to such participants and included in distribution amounts.

**Note 7 - Notes Receivable from Participants**

As of December 31, 2024 and 2023, notes receivable from participants bear interest at rates ranging from 4.25% to 9.5%, and mature at various dates through January 2037. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
