Independent Auditor's Report

To the Plan Administrators of
the PCCA Enhanced Co-op 401(k) Plan
Lubbock, Texas

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the PCCA Enhanced Co-op 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



Auditor's Responsibilities for the Audit of the Financial Statements (continued)

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule listed in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1: Plan Description

The following description of the PCCA Enhanced Co-op 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the provisions of the Plan.

Basis of Presentation. Plains Cotton Cooperative Association (PCCA, Plan Administrator, or Employer) maintains two 401(k) plans for the benefit of its employees. The PCCA Co-op 401(k) Plan (Standard 401(k) Plan) was designed to supplement the retirement benefits of those employees currently accruing benefits in PCCA's defined benefit plan.

The PCCA Enhanced Co-op 401(k) Plan (Enhanced 401(k) Plan) was established to provide retirement benefits for employees hired after September 30, 2008 and those employees who otherwise are not currently accruing benefits in PCCA's defined benefit plan. These financial statements present only the results of the Enhanced 401(k) Plan.

General. The Plan is a contributory defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Tax Status. The Internal Revenue Service (IRS) has issued an opinion letter determining that the prototype non-standardized plan is acceptable under Section 401(a) of the Internal Revenue Code (the Code). It is not a ruling or determination as to whether the Plan itself is qualified; however, an employer adopting this plan will be considered to be a qualified plan. In addition, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable authorities. There are currently no audits for any tax periods in progress. Generally, the Plan's tax returns are subject to examination for three years after they are filed.

Contributions. All new employees of PCCA are eligible to participate in the Plan upon attainment of age 21 and the completion of one year of service. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. However, no amounts are withheld from the participant's pay until and unless they return an enrollment form to the Employer, electing to contribute to the Plan. Participants may contribute between 1% and 50% of their pretax compensation annually, not to exceed the amount deductible for federal income tax purposes. Participants are allowed to change their contribution percentages at any time, with the changes becoming effective as of the next payroll period.

PCCA makes contributions to the Plan equal to 4% of each participant's compensation (Employer Basic Contributions), regardless of the participant's elected contribution percentage. PCCA also makes matching contributions to the Plan. For 2024 and 2023, the matching contributions equaled 100% of the first 3% of compensation that each participant contributes to the Plan, plus 50% of the next 2% of compensation contributed.

PCCA's contributions to the Plan totaled \$677,687 and \$555,193 in 2024 and 2023, respectively. Although PCCA may make additional discretionary profit-sharing contributions to the Plan, no such contributions were made in 2024 or 2023.

Participant Accounts. Participants direct the investments for their individual accounts. Participants may allocate all of their contributions into any combination of seventeen funds, which include sixteen mutual funds and one money market fund, or one of five model portfolios available under the Plan. If the participant has not made an active investment election, his/her contributions will be invested in the moderate model portfolio. Participants may change their investment options at any time. The earnings of the Plan, including net appreciation (depreciation) in fair value of investments, are allocated based on the returns of the investments selected by the individual participant.

Note 1: Plan Description (continued)

Vesting. Participant and employer matching contributions are fully vested at all times. Employer Basic Contributions and any profit sharing contributions made by PCCA plus earnings and losses thereon vest at the rate of 20% per year following two years of employment, such that the participant is fully vested in those balances following six years of employment.

Notes Receivable from Participants. Participants are allowed to borrow from their individual account limited to the lesser of \$50,000 or 50% of the participant's vested account balance, with a minimum of \$1,000. A participant may not have more than one loan outstanding at any time. Loans are repaid through payroll deductions and are credited to the participant's accounts with interest at a rate of prime plus 1%, as published in the Wall Street Journal on the day the loan is requested.

Participants are also allowed in-service withdrawals in instances of financial hardship, as defined by the plan document, requiring approval by the Plan Administrator.

Payment of Benefits. Upon retirement, death, disability, or termination of employment, the vested benefits, as defined, may be paid to the participant or their beneficiaries, either in a lump sum or other mode of settlement, at their election.

Forfeited Accounts. Forfeitures of terminated participants' non-vested accounts are generally used to reduce the required employer contributions. Forfeitures of approximately \$33,000 and \$35,000 were utilized for such purposes in 2024 and 2023, respectively. There were no unallocated forfeitures at December 31, 2024. Unallocated at December 31, 2023 totaled approximately \$900.

Amendment or Termination. Although it has no intent to do so, PCCA has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would automatically become fully vested in their Employer Basic Contributions and any profit sharing contributions plus earnings and losses thereon.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting. The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates. Financial statements prepared in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Values. At December 31, 2024 and 2023, the assets of the Plan were invested in money market, bond, and equity mutual funds. These investments are stated at fair value, based on quoted net asset values or estimates of the trustee. The net appreciation (depreciation) in fair value of investments includes realized gains and losses on sales of investments during the year and unrealized increases or decreases in the fair value of investments held at year end.

Administrative Costs. Certain administrative expenses of the Plan are paid by the Employer. Employees of PCCA also perform certain administrative functions with no compensation from the Plan. These expenses, which are allowed to be paid by the Plan, are not reflected in the accompanying financial statements.

Notes Receivable from Participants. Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions in accordance with the terms of the plan document.

Payment of Benefits. Benefits are recorded when paid.

Prohibited Transactions. A “party-in-interest” is a fiduciary or employee of the Plan, any person who provides services to the Plan, the Employer or an employee association whose members are covered by the Plan, a person who owns 50 percent or more of the Employer or such employee association or relatives of such person just listed. Under ERISA, a Plan fiduciary is prohibited from causing the Plan to engage in the following transactions with a party-in-interest, with certain conditional exemptions provided by ERISA:

- A sale, exchange, or lease of property;
- A loan or other extension of credit;
- The furnishing of goods, services, or facilities;
- A transfer of plan assets to a party-in-interest for the use or benefit of a party-in-interest; or
- An acquisition of employer securities or real property.

A fiduciary is also generally prohibited from using the Plan’s assets for his or her own interest or account, acting in any Plan transactions on behalf of a party whose interests are adverse to those of the Plan or its participants and receiving consideration for his or her own account from a party dealing with the Plan in connection with a transaction involving the Plan’s assets.

The Plan did not engage in any prohibited transactions for the years ended December 31, 2024 and 2023.

Note 3: Data Prepared and Certified by Trustee

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

The fair values of mutual funds and the money market fund are based on quoted net asset values of the shares held by the Plan at year end.

Note 5: Reconciliation of Financial Statements to Form 5500

The Form 5500 is a joint-agency form, developed by the IRS, the U.S. Department of Labor, and the Pension Benefit Guaranty Corporation, which may be used to satisfy the annual reporting requirements of the Code and Titles I and IV of ERISA. The Plan is required to file a Form 5500 annually, with audited financial statements enclosed. There were no reconciling items between the Form 5500 and the accompanying financial statements for the years ended December 31, 2024 and 2023.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Subsequent Events Evaluation

Effective as of the end of the day on December 31, 2024, the Plan was amended to remove the eligible exclusion for employees who were previously covered by the Employer's Standard 401(k) Plan and defined benefit plan. Thus, substantially all employees of PCCA are eligible to participate in the Enhanced 401(k) Plan beginning January 1, 2025.

Concurrent with the plan amendment, the Standard 401(k) Plan was transferred and merged with and into the Enhanced 401(k) Plan. As a result thereof, net assets available for benefits totaling approximately \$2,747,000 were transferred into the Enhanced 401(k) Plan.

Management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.
