## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants, and Beneficiaries of the  
Havis, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Havis, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

#### **NOTE A - DESCRIPTION OF THE PLAN**

The following is a description of the Havis, Inc. (the "Company") 401(k) Plan (the "Plan"). It is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **[1] General:**

The Plan was established on July 1, 1993. The Plan operates under Section 401(k) of the Internal Revenue Code. The Plan is a defined contribution plan in which every employee of the Company is eligible to enter on the first day of the month coinciding with or next following 60 consecutive days of service and after having attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Newport Trust Company is the trustee, and Newport Group, Inc. is the recordkeeper of the Plan.

Effective December 31, 2024, the assets of Vanner, Inc. 401(k) Plan ("Vanner") were legally merged into the Plan. The participants' accounts from Vanner, amounting to \$5,350,590 at December 31, 2024, were recorded as a receivable and a transfer from related plan in the accompanying financial statements. All amounts were transferred to the trust on January 3, 2025.

##### **[2] Contributions:**

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan, not to exceed certain dollar limits which are set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows Roth deferral contributions. The Company made a Qualified Automatic Contribution Arrangement ("QACA") safe harbor match of 100% of the first 1% of compensation deferred and 50% for the compensation deferrals that exceeded 1% but did not exceed 6%. Employees of the Company who have not met the eligibility requirements may contribute amounts representing distributions from other qualified plans.

The Company also may make a profit-sharing contribution at the discretion of management. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the Plan year. To receive a profit-sharing contribution, an employee must be an eligible participant on the last day of the Plan year or have completed at least 501 hours of service during the current Plan year, unless the employee dies during the Plan year, terminates employment due to becoming disabled, terminates employment after attainment of normal retirement age (65) in the current Plan year or any prior Plan year, or terminates employment after attainment of early retirement age (55) in the current Plan year or any prior Plan year. The Company elected to not make a discretionary contribution for the Plan year ended December 31, 2024.

The Plan includes an auto-enrollment provision which is applied after eligibility requirements are satisfied. Employees that are automatically enrolled will have their contributions defaulted to the age-appropriate target-date fund in the Plan's current lineup. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

Effective January 1, 2025, the Company's QACA safe harbor match is 100% of the first 2% of compensation deferred and 50% for the compensation deferrals that exceed 2% but do not exceed 6%.

**NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)**

**[3] Participant accounts:**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses) and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[4] Vesting:**

Participants are immediately vested in their contributions, rollover contributions and actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts, plus actual earnings on such contributions, is based on years of continuous service. All Company contributions vested for participants who were terminated prior to January 1, 2023 were as follows:

Upon restatement of the Plan, effective January 1, 2023, all participants still employed became fully vested in their QACA contributions and the Company's matching contributions after two years of service.

**[5] Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. A participant may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, as defined. Interest rates on outstanding loan balances range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as benefits paid to participants based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**[6] Forfeitures:**

Forfeitures of terminated participants' nonvested accounts are used to pay Plan expenses or to reduce contributions of the Company. During the year ended December 31, 2024, forfeitures of approximately \$57,800 were used to pay Plan expenses and reduce contributions of the Company. Forfeited nonvested accounts available at December 31, 2024 and 2023 were approximately \$600 and \$20,100, respectively.

##### **[7] Payment of benefits:**

On termination of employment, a participant or beneficiary with a vested account balance exceeding \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly, semi-annual or annual payments over a period not exceeding the life expectancy of the participant or his or her designated beneficiary. A participant with a balance less than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution. Effective January 1, 2024, the threshold increased to \$7,000 from \$5,000.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of accounting:**

The financial statements are prepared on the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **[2] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **[4] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

##### **[5] Payment of benefits:**

Benefits are recorded when paid.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Newport Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

*Registered investment companies (mutual funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*T. Rowe Price Stable Value Fund* - Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan sponsor were to initiate a full redemption of the fund, the fund reserves the right to delay the withdrawal for up to 12 months and requires a notification period of 30 days. There were no unfunded commitments as of December 31, 2024. The fund seeks to maximize current income and maintain principal stability by investing in a diversified portfolio of guaranteed investment contracts, bank investment contracts and synthetic investment contracts.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a benefit-responsive guaranteed investment contract with Reliance Trust offered as a Stable Value Fund MetLife option under the Plan. Reliance Trust maintained the contributions in a general account. The contract was reported at contract value. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Reliance Trust, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not have been less than 1 percent. The crediting rate was reviewed on a quarterly basis for resetting. The contract could not have been terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments.

Certain events might have limited the ability of the Plan to transact at contract value with the contract issuer. These events may have been different under each contract. Examples of such events included the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affected the Plan's normal operations.

In addition, certain events allowed the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may have been different under each contract. Examples of such events included the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

#### **NOTE F - TAX STATUS**

The Plan has adopted a Non-standardized Defined Contribution Pre-approved Plan sponsored by Newport Group, Inc. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the Non-standardized Defined Contribution Pre-approved Plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid expenses related to Plan operations and investment fees to service providers. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan were \$106,710 for the year ended December 31, 2024.

The trustee provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the trustee provides to the funds. This revenue is used to offset certain amounts owed to the trustee for its administrative services to the Plan. If the revenue received by the trustee from such mutual fund service providers exceeds the amounts owed, the trustee remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, no amounts were received from the trustee and reflected in net realized/unrealized appreciation in value of investments in the statement of changes in net assets available for benefits. The account balance as of December 31, 2024 and 2023 was \$-0-.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### **NOTE J - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan entered into a new adoption agreement. The Company's QACA safe harbor match is increased to 100% of the first 2% of compensation deferred and 50% for the compensation deferrals that exceed 2% but do not exceed 6%.

Effective April 25, 2025, the Plan transitioned to Ascensus, LLC. Through an acquisition, Newport Group, Inc. is a part of Ascensus, LLC, and together they will manage the recordkeeping services for the Plan.
